We have performed the audits of the financial statements of Optima Tax Relief, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of the Plan

The following description of Optima Tax Relief, LLC 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan, established effective January 1, 2008, is a defined contribution plan sponsored by Optima Tax Relief, LLC and related affiliates (“the Company”) to provide employees with an opportunity to accumulate funds for their retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and certain provisions of the Internal Revenue Code (“IRC”).

Plan administration

The Company is the administrator of the Plan and is the Plan’s named fiduciary for purposes of Section 402(a) of ERISA. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. The Plan’s custodian, Transamerica Life Insurance Company (“Custodian”), has the authority and responsibility for the management and investment of Plan assets.

Eligibility

To be eligible to participate under the Plan, the participant must be an eligible employee of Optima Tax Relief, LLC, Debtmerica, LLC, Loan Now, LLC and SM Holdings, LLC.

Prior to January 1, 2024, employees who have attained eighteen (18) years of age and completed at least 250 hours of service during the first three (3) months of service are eligible to participate and receive matching contributions from the Company. To become eligible for the Company’s discretionary profit sharing contributions, the employee must have attained eighteen (18) years of age, completed at least 1,000 hours of service, and be employed on the last day of the Plan year. Effective January 1, 2024, employees who have attained eighteen (18) years of age and completed three (3) months of service are eligible to participate and receive matching and discretionary profit sharing contributions from the Company. Participation begins on the first day of the Plan month after the eligibility requirements are satisfied. Any employee who died, became disabled, or terminated employment after attaining Normal Retirement Age during the Plan year is eligible for the discretionary profit sharing contribution.

Contributions

Employees who elect to participate in the Plan may contribute a portion of their salary for that period, or up to the limits imposed by Section 402(g) of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Contributions, cont'd

Participants may elect to make Roth 401(k) contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company, at its sole discretion, makes discretionary matching contributions. For 2024, the matching contribution was 50% of the first 6% that an employee contributes per paycheck, not to exceed \$5,000 for the entire year. Additionally, the Plan allows qualified non-elective contributions at the discretion of the Company.

Participant investment account options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several pooled separate accounts and a guaranteed interest account as investment options for participants.

Allocations

Each participant's account is credited with the participant's contributions, Company contributions, Plan earnings or losses and rollovers from other qualified plans. Plan earnings or losses are allocated based upon each participant's account balance. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The Company's discretionary contributions as well as all earnings on these contributions vest according to the following schedule:

2	40%
3	60%
4	80%
5 or more	100%

Participants are fully vested upon retirement, death, disability or termination of the Plan.

Notes receivable from participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note repayment periods may not exceed five years except for notes used to acquire a principal residence, which have a maximum repayment period of ten years.

Notes receivable from participants, cont'd

Notes receivable from participants are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the note receivable originates. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024. For 2024, there were no excess contributions.

Benefit payments

Benefits to participants or their beneficiaries generally are payable as a lump sum, installments, or partial payments equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. Additionally, participants may request in-service withdrawals upon attainment of age 59½, or upon incurring a financial hardship, as defined in the Plan document, if certain criteria are met. Benefits are recorded when paid.

Distributions under the Plan shall generally be made as soon as possible after the date of retirement, date of death or termination of employment. Mandatory distributions of account balances under \$5,000 will be made as soon as possible. In the event of a mandatory distribution greater than \$1,000 if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an Individual Retirement Account designated by the Plan administrator.

Forfeitures

Unvested amounts forfeited by terminated employees may be used to reduce expenses related to the administration of the Plan or to reduce future employer discretionary contributions. During 2024, forfeited funds of \$3,500 were used to reduce expenses related to the administration of the Plan and none were used to reduce employer discretionary contributions. At December 31, 2024 and 2023, unvested forfeited accounts totaled \$212,400 and \$103,189, respectively.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in the fair value of investments.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, the Plan document provides that participants would become fully vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

3. Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

4. Fair Value Measurement, Cont'd

The three levels of the fair value hierarchy under the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (“NAV”) of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. These accounts are not categorized within the fair value hierarchy. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following tables summarize investments for which fair value is based on NAV per share practical expedient as of December 31, 2024 and 2023:

Notes to Financial Statements

Investment valuation and earnings

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consisted of the realized gains or losses on sales of investments and the unrealized appreciation or depreciation of those investments.

5. Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive investment contract with Transamerica Life Insurance Company (“Transamerica”). Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0.75%. The crediting interest rate is reviewed on a quarterly basis for resetting.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan.), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. As of December 31, 2024, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

6. Tax Status

The Plan Administrator has adopted a Transamerica Retirement Solutions, LLC Volume Submitter 401(k) Profit Sharing Plan (“volume submitter plan”). The IRS has determined that the volume submitter plan is designed in accordance with applicable sections of the IRC and informed the Custodian of such in a letter dated September 22, 2021. Although the Plan has been amended since receiving the IRS opinion letter, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

6. Tax Status, Cont'd

U.S. GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain position that more likely than not would not be sustained upon examination by the IRS. The tax positions taken by the Plan have been analyzed and, as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability, asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-In-Interest Transactions

Certain of the Plan's investments in the fully benefit-responsive investment contract are managed by the Custodian. Certain officers of the Company are current participants in the Plan. The Plan has notes receivable from certain of its participants. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Company pays directly any other fees related to the Plan's operations.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

9. Reconciliation of Financial Statements to Schedule H of Form 5500

Net assets available for benefits and the net increase in net assets available for benefits, as reported in the accompanying financial statements, are consistent with amounts reported in Schedule H of the Form 5500.

10. Subsequent Events

The Plan has evaluated subsequent events through September 4, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
