Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Lift-All Company, Inc. Employee Benefit Plan**, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **Lift-All Company, Inc. Employee Benefit Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at end of year) - modified cash basis and reportable transactions - modified cash basis, as of or for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTE 1 - DESCRIPTION of the PLAN

The following description of the **Lift-All Company, Inc. Employee Benefit Plan** (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan provides health and disability benefits covering all eligible employees of Lift-All Company, Inc. (the Corporation).

Certain Plan assets are held in a Voluntary Employees' Beneficiary Association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Benefits

The Plan provides health benefits (hospital, surgical, major medical, and prescription drug) covering regular full-time employees of the Corporation, their lawful spouses if unemployed or not offered coverage by their employers, and their dependents, after a waiting period of 60 days of continuous active employment. A covered employee can purchase dental and vision coverage for themselves and their dependents at their own cost. The Plan also provides accidental death and disability, life insurance, short- and long-term disability, and transplant benefits to eligible employees only.

Self-Insured Benefits

The health benefits (hospital, surgical, major medical, and prescription drug) and short-term disability are self-insured by the Corporation. The claims for self-insured benefits, other than short-term disability benefits, are processed by the Plan's third-party administrators under administrative services only (ASO) arrangements. The third-party administrators pay claims directly to or on behalf of participants. The payments for these claims are paid by the Plan's VEBA trust which is funded by the general assets of the Corporation. Despite the Plan's utilization of third-party administrators for claims processing, the ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Short-term disability benefits are paid directly by the Corporation.

Insured Benefits

The Plan fully insures the accidental death and disability benefits, life insurance benefits, dental and vision benefits, long-term disability benefits, and transplant benefits. The Corporation purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company from the general assets of the Corporation. Premiums for dental and vision coverage are paid fully by the employee at their own cost and are paid from the assets of the VEBA trust.

Employee Assistance Program (EAP)

The Plan offers an employee assistance program and online worklife counseling and relationship support services through an insurance group. Fees are paid directly by the Corporation.

Stop-Loss Coverage

The Corporation has entered into a stop-loss insurance arrangement related to health and prescription drug claims in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount).

Treatment Cost Containment Program

In prior years, the Plan participated in a Treatment Cost Containment Program administered by a third-party administrator to help reduce the Corporation's claims costs by offering international treatment and medical tourism options to eligible participants. Fees for this program were paid directly by the Corporation. The program was discontinued in 2024. Total fees were \$0 for the years ended December 31, 2024 and 2023.

Prescription Advocacy Program

During 2023, the Plan entered into a Prescription Advocacy Program with a third-party administrator in an effort to reduce Plan claims costs of the Corporation by providing international prescription sourcing options for eligible participants with no copay. Fees are paid directly by the Corporation. Total fees for the years ended December 31, 2024 and 2023 were \$131,603 and \$10,311, respectively, and are included in prescription claims paid in the accompanying statements of changes in net assets available for benefits - modified cash basis.

Contributions

The Corporation makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Corporation on a pay-as-you-go basis.

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of dental and vision insurance programs based on the current group rate premium cost.

The Corporation pays the full cost of accidental death and disability insurance, life insurance, long-term disability insurance, and stop-loss reinsurance.

Consolidated Omnibus Budget Reconciliation Act (COBRA)

Generally effective for Plan years beginning on or after July 1, 1986, the Plan was required to offer continuation of benefits for a specified period of time to qualified employees and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event as required by law. COBRA receipts are deposited directly into the Plan.

NOTE 2 - SUMMARY of SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan follows the practice of presenting its financial statements in accordance with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). Under the modified cash basis of accounting, only revenues collected, costs and expenses paid, and assets and liabilities arising as a result of cash transactions or from the recognition of income due from insurance companies for claims paid or deferred employer contributions, are recognized.

Basis of Accounting (Continued)

Therefore, accrued income and expenses, payables, and deferred expenses, which may be material in amount, are not reflected on the accompanying financial statements.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from estimated amounts.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Dividend income is recorded when received by the Plan. Net appreciation (depreciation), if any, includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Claims payments are recorded when paid by the third-party administrators.

Payments for Specific Stop-Loss Reinsurance

Reinsurance premiums and insurance premiums paid by either the Corporation or the VEBA trust, are recorded as payments in the accompanying statements of changes in net assets available for benefits - modified cash basis.

Stop-Loss

Premiums for stop-loss insurance are recorded in the accompanying statements of changes in net assets available for benefits - modified cash basis. Reimbursements from specific stop-loss reinsurance total \$211,642 and \$108,821 for the years ended December 31, 2024 and 2023, respectively. When applicable, they are netted with claims paid in the accompanying statements of changes in net assets available for benefits - modified cash basis. Stop-loss recoverables were \$-0- and \$108,821 at December 31, 2024 and 2023, respectively. When applicable, they are netted with employer contributions in the accompanying statements of changes in net assets available for benefits - modified cash basis.

The Corporation manages the risk of loss related to the Plan's medical and prescription claims through participation in a captive insurance program for specific stop-loss reinsurance. Under this program, the Corporation pays annual premiums to cover expected losses. In the event of adverse loss experience, an adjustment would be assessed to the Corporation in a future period. The program also provides for risk-sharing among program participants. The Corporation received a refund from the captive insurance program for claims experience adjustments plus federal excise taxes in the amount of \$106,638 and \$119,164 for the years ended December 31, 2024 and 2023, respectively. These amounts were shown as assessments on the statements of changes in net assets available for benefits - modified cash basis, during the period they were actually paid.

There are no assessments expected subsequent to the Plan year ended December 31, 2024, as the Corporation received a refund from the captive insurance program for claims experience adjustments plus federal excise taxes in the amount of \$54,732 in April 2025.

Refunds

Refunds from the Plan's pharmacy benefit manager are recorded when received. Pharmacy refunds totaling \$67,754 and \$68,840 have been netted with prescription claims paid in the accompanying statements of changes in net assets available for benefits - modified cash basis for the years ended December 31, 2024 and 2023, respectively.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party administrators. These expenses are reported on the statements of changes in net assets available for benefits - modified cash basis as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Corporation on behalf of the Plan.

Benefit Obligations

Plan obligations at December 31, 2024 and 2023, for health claims incurred by participants are estimated by analyzing actual subsequently paid claims that have dates of service during the reporting period which is determined by the third-party administrator.

Concentration of Credit Risk

Financial instruments which potentially subject the Plan to credit risk consist primarily of temporary cash deposits with financial institutions. The Plan maintains its cash deposits with a financial institution where the account balance may at times exceed FDIC insured limits.

NOTE 3 - TAX STATUS

The VEBA trust funding certain benefits of the Plan received a determination letter from the IRS dated October 21, 1983, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded for the years ended December 31, 2024 and 2023, for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The trust has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and therefore, believes that the related trust is tax-exempt.

Under the modified cash basis of accounting, the Corporation is required to evaluate tax positions taken by the Plan and disclose a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require disclosure of a liability (or asset) in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - TERMINATION of the PLAN

Although it has not expressed any intention to do so, the Corporation has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Corporation must pay the claims incurred and expenses of the Plan due up to the date of termination plus extended benefits, if any, provided under the Plan. Also, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Corporation or be used for purposes other than that for the exclusive benefit to the Plan's participants.

NOTE 5 - CERTIFICATION by CUSTODIAN and INVESTMENTS

At December 31, 2024 and 2023, the Plan's investments were held by the custodian, Fulton Bank, N.A. The following information at December 31, 2024 and 2023, and for the years then ended, was certified as complete and accurate by the custodian under 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974:

NOTE 6 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset and liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 6 - FAIR VALUE MEASUREMENTS (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund: Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. The fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
