Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1: Plan Description**

The following description of the Wylie Manufacturing PS & 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General.** The Plan is a contributory, defined contribution plan covering substantially all employees of Wylie & Son, Inc. (the Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility.** Employees are eligible to participate in the Plan after completing one year of employment, provided they are at least 21 years of age. Plan entry dates are on the first day of the calendar quarter coinciding with or next following satisfaction of the eligibility requirements.

**Contributions.** Under the Plan, both participants and the Sponsor are allowed to make contributions. Participant contributions may consist of pre-tax 401(k) deferrals, Roth 401(k) deferrals, or rollover contributions. Participant contributions are subject to certain annual limitations under provisions of the Internal Revenue Code (the Code). Participants can change their contribution percentages at least once annually, with the changes becoming effective as soon as administratively feasible, and they can elect to stop making contributions to the Plan at any time.

The Sponsor may make discretionary matching contributions to the Plan, as determined annually, equal to a uniform percentage of each participant's salary deferrals. For the years ended December 31, 2024 and 2023, the Sponsor made matching contributions to the Plan equal to 50% of each participant's salary deferrals, per pay period, up to a maximum of 4% of the participant's compensation.

**Participant Accounts.** Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contributions, as well as the investment earnings or losses thereon, and allocations of administrative expenses.

**Vesting.** Participants are always fully vested in their contributions and any earnings thereon. Participants vest in the Sponsor matching contributions portions of their accounts (if any, including the related earnings) at a rate of 25% per year following one year of employment, such that the participant is fully vested in such contributions following four years of employment.

**Notes Receivable from Participants.** Participants may borrow from their account a minimum of \$1,000 up to 50% of their vested account balance or \$50,000, whichever is less. Loans are secured by the balance in the participant's account and bear interest at a reasonable rate, as determined by the plan administrator, based on the interest rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits.** On termination of service due to death, disability, retirement, or for other reasons, the participant or their beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. The Plan also permits in-service and hardship withdrawals under certain conditions.

**Forfeitures.** Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. As permitted by the Plan, forfeitures are utilized to reduce employer contributions or to pay administrative expenses of the Plan. Unallocated forfeitures totaled \$4,697 and \$12,958 at December 31, 2024 and 2023, respectively.

**Amendment or Termination.** Although they have no intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would automatically become fully vested.

**Note 2: Summary of Significant Accounting Policies**

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), including specialized industry practices as specified in the American Institute of Certified Public Accountants audit and accounting guide titled *Audits of Employee Benefit Plans*.

**Use of Estimates.** Financial statements prepared in conformity with GAAP require management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Values.** Investments are stated at fair value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants.** Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits.** Benefits are recorded when paid.

**Administrative Expenses.** Certain administrative expenses of the Plan are paid by the Sponsor. Employees of the Sponsor also perform certain administrative functions with no compensation from the Plan. These expenses are not reflected in the accompanying financial statements. Administrative expenses include fees related to the administration of notes receivable from participants, which are charged directly to the participant's account, along with investment-related expenses and other expenses of maintaining the Plan.

**Prohibited Transactions.** A "party-in-interest" is a fiduciary or employee of the Plan, any person who provides services to the Plan, the Sponsor or an employee association whose members are covered by the Plan, a person who owns 50 percent or more of the Sponsor or such employee association or relatives of such person just listed. Under ERISA, a Plan fiduciary is prohibited from causing the Plan to engage in the following transactions with a party-in-interest, with certain conditional exemptions provided by ERISA:

- A sale, exchange, or lease of property;
- A loan or other extension of credit;
- The furnishing of goods, services, or facilities;
- A transfer of plan assets to a party-in-interest for the use or benefit of a party-in-interest; or
- An acquisition of employer securities or real property.

A fiduciary is also generally prohibited from using the Plan's assets for his or her own interest or account, acting in any Plan transactions on behalf of a party whose interests are adverse to those of the Plan or its participants and receiving consideration for his or her own account from a party dealing with the Plan in connection with a transaction involving the Plan's assets.

The Plan did not engage in any prohibited transactions for the years ended December 31, 2024 and 2023.

**Tax Status.** The Internal Revenue Service (IRS) has issued an opinion letter determining that the prototype non-standardized plan is acceptable under Section 401(a) of the Code. It is not a ruling or determination as to whether the Plan itself is qualified; however, an employer adopting this plan will be considered to have a qualified plan.

**Note 2: Summary of Significant Accounting Policies (continued)**

**Tax Status (continued).** Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Although the Plan has been amended since receiving the opinion, the plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. There are currently no audits for any tax periods in progress. Generally, the Plan's tax returns are subject to examination for three years after they are filed.

**Note 3: Data Prepared and Certified by Custodian**

The following information included in the accompanying financial statements was obtained from data that has been prepared and certified to as complete and accurate by Matrix Trust Company (Matrix), the custodian of the Plan:

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

**Note 5: Reconciliation of Financial Statements to Form 5500**

The Form 5500 is a joint-agency form, developed by the IRS, the U.S. Department of Labor, and the Pension Benefit Guaranty Corporation, which may be used to satisfy the annual reporting requirements of the Code and Titles I and IV of ERISA. The Plan is required to file a Form 5500 annually, with audited financial statements enclosed. There were no reconciling items between the Form 5500 and the accompanying financial statements as of and for the years ended December 31, 2024 and 2023.

**Note 6: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of such investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7: Subsequent Events Evaluation**

Management has evaluated subsequent events through September 24, 2025, the date which the financial statements were available to be issued. No material subsequent events have occurred during this time which would require recognition in the financial statements or footnotes as of and for the year ended December 31, 2024.
