We have performed an audit of the financial statements of First National Bank of Pulaski Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

The First National Bank of Pulaski Profit Sharing Plan (the Plan) was established on January 1, 1970. Three officers of the employer are the Plan Trustees for all plan assets. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of First National Bank of Pulaski (the Employer), who are 21 years of age and have completed one year of service and credited with 1,000 hours of service by the end of the first twelve months of employment. Participants enter the Plan on the first entry date (January 1 or July 1) after the date on which eligibility requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The employer's profit sharing contribution is discretionary and not limited to current or accumulated net profits. Profit sharing plans permit the employer to contribute and deduct up to 25% of eligible participant compensation, subject to annual limits as defined by law. For the years ended December 31, 2024 and 2023 the employer contribution was 14.33% and 14.29% of eligible compensation, as defined in the Plan, respectively. Allocations of employer contributions and forfeited benefits are based on eligible compensation and years of service while earnings are allocated based on account balance.

Participant Accounts

Each participant's account is credited with allocated employer contributions (including any contributions of the employer's parent company stock and related forfeitures), account earnings and other forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants who are not actively employed at the end of the plan year do not share in allocations of employer contributions and forfeitures. However, if employment is terminated as a result of death, total and permanent disability, or retirement, participants do share in allocations of employer contributions and forfeitures. In addition, partial withdrawals are limited to a minimum of \$1,000 and such partial withdrawals may occur no more than every 90 days.

Each participant may direct the investment of his or her account, which is not invested in employer stock, in any percentage of the fund options. Transfers among funds can be made daily by participants.

Note 1. **Description of the Plan**

Administration

The Plan is administered by the Profit Sharing Retirement Committee consisting of eight employees and two directors of the Bank. All funds in the Plan are held by the Plan Trustees. A portion of the Plan's assets are invested in the stock of First Pulaski National Corporation. Other assets are invested at the discretion of the participants.

Payment of Benefits

Generally, plan benefits begin as soon as practicable after the later of the normal retirement date or the date of termination. Disability benefits to eligible participants are made as if the participant had retired. Death benefits begin after the final allocation of employer contributions with respect to the deceased participant has been made. Benefits under the Plan may be paid in a single lump sum or partial payments. Automatic cash-out of vested balances of \$1,000 or less is required by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$23,906 and \$22,279, respectively. Totals include cash and shares of employer stock. Forfeitures will be reallocated to participants in the same manner as employer contributions.

Note 2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation (depreciation) in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net change of fair value of investments.

Reclassifications

Certain prior year amounts have been reclassified to conform to current year presentation.

Note 3. Certification

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan. The Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this information:

- Investments at fair value, participant-directed
- Uninvested cash
- Net change in fair value of investments, participant-directed

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The prior year period presentation was revised to move the classification of separate accounts within the fair value hierarchy table to better reflect the underlining funds as well as to reflect measurement at NAV practical expedient. There was no difference in fair value in making the revision. Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: valued at the net asset value (NAV) of units of the accounts, as provided by the custodian, which is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The pooled separate accounts invest in conservative, income, growth and income, growth, aggressive growth, target risk asset allocations, and target date asset allocation investment categories.

Note 4. Fair Value Measurements

Common Stock: The fair value of the common stock of the employer's parent company is based on an appraisal that considered the financial condition of the issuer, past and expected future results of operations, dividend history, and information related to known transactions, market growth potential and an assessment of management.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Parties and Party-in-Interest

Certain Plan investments are managed by John Hancock Trust Company LLC. John Hancock Trust Company LLC is the custodian as defined by the Plan and, therefore these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan under the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and related earnings thereon.

Note 7. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan sponsored by Acuff & Associates, Inc. The sponsor has received an opinion letter from the Internal Revenue Service (IRS) as to the non-standardized pre-approved profit sharing/money purchase/CODA plan's qualified status. The non-standardized pre-approved profit sharing/money purchase/CODA plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to IRS examination for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
