### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of ERI 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ERI 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ERI 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 – Description of Plan

The following description of ERI 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a salary deferral plan covering substantially all employees of Electronic Recyclers International, Inc. and subsidiaries (the Company), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Electronic Recyclers International, Inc. is the Plan's sponsor and serves as Plan administrator.

**Eligibility** – Employees of the Company are eligible to participate in the Plan and receive Safe Harbor matching contributions upon reaching age 18 and after completing one month of service. The Plan also provides for an employer discretionary matching contribution. The eligibility for the employer discretionary matching contribution is age 18 and 1,000 hours of service. The entry date is the first of the month following satisfaction of the eligibility requirements. In order to share in the allocation of the discretionary matching contribution, the participant must complete one year of service with at least 1,000 hours or more during the Plan year and must be employed on the last day of the Plan year.

### Contributions

*Participant contributions:* Each year, participants may contribute between 1% to 100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

*Employer contributions:* The Company provided a Safe Harbor employer matching contribution, which matches participant's contributions up to 4% of eligible compensation. The Company may also make discretionary contributions which are determined annually. There was no employer discretionary matching contribution in 2024.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contribution, any Company matching contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

## ERI 401(k) Plan Notes to the Financial Statements

---

**Vesting** – Participants are vested 100% immediately in their elective deferral contributions, rollover contributions and Safe Harbor employer matching contributions, plus actual earnings thereon. Participants vest 100% in the employer discretionary matching contributions upon death, normal retirement age, or based on the following schedule:

**Payment of benefits** – Upon termination of service, death, disability, or retirement, a participant will receive a lump sum amount equal to the value of the participant’s vested interest in his or her account. Participants whose vested account balance exceeds \$5,000 and who are subject to lifetime required minimum distributions may receive installments payable in monthly, quarterly, or annual installments equal to or exceeding the annual required minimum distribution amount. In addition, a participant may elect to receive a hardship or an in-service distribution when certain criteria are met, as outlined in the Plan’s agreement.

**Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeited nonvested accounts may be applied to payment of the plan administration expenses or to reduce any Company matching contribution. As of December 31, 2024 and 2023, the balance of forfeited nonvested accounts was \$3,958 and \$2,067, respectively.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed 30 years. Plan loans will bear a reasonable rate of interest determined by the plan administrator, currently 2% above the USA Today prime rate. Principal and interest are paid ratably through semi-monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.25% to 10.50%, with various maturities through December 2029.

**Administrative costs** – The Plan is administered by the Company, and administrative expenses of the Plan are paid principally by the Company. Investment management fees related to the administration of the Plan are paid directly by the Plan. Participants are responsible for any distribution and loan expenses.

### Note 2 – Summary of Significant Accounting Policies

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan's custodian, John Hancock Life Insurance Company (U.S.A.) (John Hancock), certifies the fair market value of all investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan's agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payable to participant** – Payable to participant represents an amount related to a distribution requested by a participant that was not paid until after year end.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments and loans are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses that are paid directly by the Plan are separately disclosed in the financial statements. Investment funds are also subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance; thus, they are not separately disclosed in the accompanying financial statements.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available to be issued.

### Note 3 – Investments

The Plan holds sub-accounts within a pooled separate account under a group annuity contract with John Hancock. The sub-accounts are invested in shares of a corresponding fund issued by John Hancock, or in shares of funds issued by other management investment companies or collective investment trusts. Following is a description of the valuation techniques used for assets measured at fair value.

*Pooled separate account:* Units held in pooled separate account sub-accounts are valued using the net asset value practical expedient (NAV practical expedient) of the sub-account as reported by the custodian. The NAV practical expedient is based on the fair value of the underlying assets owned by the sub-account, minus its liabilities, and then divided by the number of units outstanding.

The Plan currently invests in the following significant sub-accounts under the John Hancock Separate Account B. (Other sub-accounts are available and insignificant sub-accounts are not disclosed here.) All of the sub-accounts calculate NAV practical expedient per share. There are no unfunded commitments, redemption frequency restrictions, redemption notice periods, or any redemption restrictions, except restrictions may be imposed to minimize short-term trading activity.

*JH Multimanager Lifetime Target Date Thru “Year” Funds:* These are a series of target date asset allocation portfolios, each identified by a future year. The funds seek high total returns until their respective target retirement dates, using an asset allocation strategy designed for investors expected to retire in the designated retirement year.

*John Hancock Lifestyle Aggressive Active Strategies:* The fund seeks to achieve long-term growth of capital by investing 100% of the portfolio assets in underlying portfolios that invest primarily in equity securities.

*John Hancock Lifestyle Growth Active Strategies:* The fund seeks long-term growth of capital by investing approximately 80% of the portfolio’s assets in underlying portfolios that invest primarily in equity securities and approximately 20% of its assets in portfolios that invest primarily in fixed-income securities. Current income is also a consideration.

*John Hancock Lifestyle Balanced Active Strategies:* The fund seeks to achieve a balance between a high level of current income and growth of capital, with a greater emphasis on growth of capital, by investing approximately 40% of the portfolio’s assets in underlying portfolios that invest primarily in fixed-income securities and approximately 60% of its assets in underlying portfolios that invest primarily in equity securities.

*John Hancock Lifestyle Moderate Active Strategies:* Seeks to achieve a balance between a high level of current income and growth of capital, with a greater emphasis on income by investing approximately 60% of the portfolio’s assets in underlying portfolios that invest primarily in fixed-income securities and 40% of its assets in portfolios that invest primarily in equity securities.

*500 Index Fund:* The fund seeks to achieve the approximate aggregate total return of a broad U.S. domestic equity market index. The managers try to match the performance of the S&P 500 Index by holding all, or a representative sample of, the securities that comprise the Index.

*Mid Cap Index Fund:* This fund seeks to achieve the approximate aggregate total return of a mid-cap U.S. domestic equity market index.

*Vanguard Small Cap Grow Index:* The fund aims to track the performance of a small-cap U.S. growth index and invests all or substantially all of its assets in the stocks that make up the index.

*The Growth Fund of America:* The fund seeks growth of capital by investing in common stocks and seeks to invest in companies that appear to offer superior opportunities for growth of capital. The fund invests primarily in common stocks of large and mid-capitalization issuers.

*Investment Company of America:* The fund seeks long-term growth of capital and income by investing in common stocks that offer growth and dividend potential. The fund is designed for investors seeking both capital appreciation and income.

*Parnassus Core Equity Fund:* The fund is a diversified, fundamental, U.S., large-cap, core equity strategy that invests principally in undervalued equity securities trading at a discount to their intrinsic value. At least 75% of the fund's total assets will normally be invested in equity securities that pay dividends.

*Capital Appreciation Fund:* The fund seeks long-term capital appreciation that invests at least 65% of its total assets in equity and equity-related securities of companies that exceed \$1 billion in market capitalization and believes that have above-average growth prospects. It may invest up to 20% of its total assets in foreign equity securities. The fund may invest in U.S. government securities issued or guaranteed by the U.S. government or by an agency or instrumentality of the U.S. government.

*John Hancock Stable Value:* The fund seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. The fund is a stable value product that guarantees principal and accumulated interest.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 4 – Tax Status**

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

#### **Note 6 – Certified Investment Information**

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

#### **Note 7 – Party-in-Interest Transactions**

The Plan holds sub-accounts within a pooled separate account under a group annuity contract with John Hancock. Some of the sub-accounts are managed by John Hancock Asset Management, an affiliate of John Hancock. Therefore, transactions with these entities qualify as exempt party-in-interest transactions.

In 2024, the Plan paid \$22,126 of administrative expenses related to services provided by parties-in-interest.

#### **Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. In the event of plan termination, amounts allocated to a participant's account become fully vested.


