**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Rotating Machinery Services, Inc. 401(k) P/S Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all employees of Rotating Machinery Services, Inc. (the "Employer" or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

***Eligibility***

An employee becomes eligible to participate in the Plan upon attainment of age 21 and must not be covered under a collective bargaining agreement, unless the agreement requires the employees to be included in the Plan. An employee may begin to participate the first day of the month following the date on which such requirements are satisfied.

***Contributions***

A participant may voluntarily contribute to the Plan a portion of his or her compensation as defined by the Plan document, up to 100% through systematic payroll deductions subject to the maximum allowable contribution under the Internal Revenue Code (the "Code"). All participant contributions shall be allocated among the available investment options in accordance with participant elections.

The Plan provides a safe harbor matching contribution in an amount equal to 100% of the first 4% of eligible compensation contributed by the participant to the Plan.

A 4% automatic enrollment will be made for newly eligible employees 35 days from mailing of auto-enrollment notice and for active participants beginning after February 5, 2020 who have not made a deferral election. Employees who are rehired will be automatically enrolled at 4% 35 days from the date of rehire notice.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and matching contributions, and an allocation of Plan earnings (losses) and administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. Participant accounts are also charged applicable administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

All contributions made by participants and all safe harbor matching contributions are immediately vested.

***Participant Loans***

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms are generally limited to five years unless the loan is for the purchase of a participant's primary residence. The loans are secured by the balance in the participant's account, must bear interest at a reasonable rate of interest and bear interest at a fixed rate, as determined by the Plan Administrator. Interest rates on loans outstanding ranged from 4.25% to 9.50% at December 31, 2024 and December 31, 2023, respectively.

***Payment of Benefits***

A participant or his or her beneficiary may receive a lump sum payment or periodic payments of his or her vested account balance upon retirement, disability, termination, or death prior to retirement. Participants may also withdraw amounts from their accounts under certain defined conditions.

***Hardship Withdrawal of Funds***

A participant may withdraw an amount from his or her elective deferral account to pay for medical care, make a down payment on a principal residence, to pay post-secondary education expenses for a member of the participant's household, make payments to prevent eviction of the participant from or a foreclosure on the mortgage on the participants primary residence, payments for funeral or burial expenses, expense for the repair of damage to the participants principal residence that would qualify for a casualty loss under Code Section 165, or to pay other expenses that are determined to be an immediate and heavy need.

***Plan Termination***

Although it has not expressed an intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates that affect the amounts reported in the accompanying financial statements and notes. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Loans***

Participant loans are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as benefits paid based upon terms in the Plan document. Principal and interest is paid ratably through payroll deductions. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

***Payment of Benefits***

Benefit payments are recorded when paid.

***Administrative Expenses***

Administrative expenses of the Plan are paid by the Plan and, if not, the Company as provided in the Plan document.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 - Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable, or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.
- Level 3 - Inputs to the valuation methodology are unobservable and are supported by little or no market activity and, that are significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued based on quoted prices of the fund in active markets.

*Collective Trust Funds:* The Plan holds an investment in the Putnam Stable Value Fund (“Stable Value Fund”), a fully benefit-responsive collective trust. The fair value of the Stable Value Fund is based on the net unit value (“NUV”) of the fund provided by the Trustee and is used as a practical expedient to estimate fair value for the fund. This NUV represents the fund’s fair value since this is the amount at which the Plan transacts with the fund. The Stable Value Fund attempts to maintain a stable price per unit of \$1. The Stable Value Fund primarily invests in traditional guaranteed investment contracts (“GICs”), insurance separate accounts, and money market instruments. The Stable Value Fund’s value represents invested principal plus accrued interest earned thereon.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEE**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule that was certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

- Investments at fair value and participant loans;
- Investment income (loss) and interest income on participant loans; and
- Information included on Schedule H, line 4i - schedule of assets (held at end of year).

The Plan's independent accountants did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service ("IRS") has issued an opinion letter dated June 30, 2020, stating that the volume submitter profit sharing plan with a cash or deferred arrangement used by the Plan was designed in accordance with applicable sections of the Code. The Plan has been amended since the opinion letter was issued. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

Certain Plan investments are managed by Fidelity Investments. Fidelity Investments is an affiliated company of the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

**NOTE 7 - RISKS AND UNCERTAINTIES**

Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
