Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tosca, Ltd. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Tosca, Ltd. Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Tosca, Ltd. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all nonunion employees of Tosca Services, LLC (the "Company"), who are not resident aliens and meet certain eligibility requirements. Employees are eligible to participate in the Plan upon completion of three months of service. Effective January 1, 2024, upon satisfying eligibility requirements, an employee is eligible to participate on the first day of the following calendar month. Prior to January 1, 2024, upon satisfying eligibility requirements, an employee was eligible to participate on the first day of the following calendar quarter.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Officers of the Company are responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Each year, participants may contribute to the Plan up to 100% of eligible compensation, as defined in the plan document, on a pre-tax or Roth basis, not to exceed the maximum allowable limits by the Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover contributions"). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2024, the Plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company contributes a safe harbor matching contribution equal to 100% of the first 6% that a participant contributes to the Plan. Rollover contributions are not matched. In addition, the Company may make additional discretionary matching and profit sharing contributions to the Plan. Participants must be employed on the last day of the plan year and have completed 1,000 hours of service during the plan year to be eligible to receive the Company's discretionary matching and profit sharing contributions. The Company did not make any discretionary matching or profit sharing contributions for 2024.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's voluntary contributions, Company safe harbor and discretionary matching contributions, and allocations of (a) Company discretionary profit sharing contributions, (b) plan earnings or losses, and (c) forfeitures of terminated participant's nonvested accounts. Participant accounts are reduced by withdrawals and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions, plus actual earnings thereon, is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service, upon attainment of normal retirement age (age 62), or upon death or permanent disability.

Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service during a Plan year.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at any given time. Note terms may not exceed five years, unless the note is for the purchase of a primary residence, in which case a longer term is allowed. The notes are secured by the balance in the participant's account and bear interest at rates from 3.25% to 8.50% at December 31, 2024, which were equal to the prime rate as of the date of issuance of the note. Principal and interest are repaid ratably through payroll deductions.

Payment of Benefits

Plan benefits are available at normal retirement (age 62), disability retirement, death, or termination of employment. Participants may elect to receive benefit payments in the form of a lump-sum distribution or ad-hoc distribution. Installment payments are also allowed for lifetime minimum required distributions. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 70 1/2 or upon deemed severance of employment for active military personnel. In-service distributions can only be made from accounts that are 100% vested.

Note 1: Description of Plan (Continued)

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary matching and profit sharing contributions. The Plan had forfeited nonvested accounts of \$0 at December 31, 2024, and \$1,626 at December 31, 2023. The Company may decide at its discretion how to use forfeitures under the plan document. During 2024, forfeited accounts of \$1,759 were used to pay plan expenses.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the Plan's trustee. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Charges for the issuance of notes receivable from participants serve as a reduction to the note proceeds received by the participant and, as a result, are not included in administrative expenses. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Management Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment advisory fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income.

Fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. All other expenses paid by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through August 28, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds and common/collective trust fund: Valued at the net asset value (NAV) of shares held by the Plan at year-end. The funds held by the Plan are registered with the U.S. Securities and Exchange Commission and are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded on an open market.

Putnam Stable Value Fund 25bps: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or significant restrictions on redemption at December 31, 2024 or 2023.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, and non-interest-bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, except for interest income on notes receivable from participants, for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company, the Custodian of the Plan.

Note 5: Party-in-Interest Transactions

Pension, Inc. serves as the third-party administrator for the Plan, and Morgan Stanley serves as the investment advisor for the Plan. Transactions with these parties qualify as party-in-interest transactions. For 2024, fees paid to Pension, Inc. for administrative services were \$54,713, and fees paid to Morgan Stanley for investment advisory services were \$36,932. Certain fees for investment management services during the plan year ended December 31, 2024, are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary matching and discretionary profit sharing contributions.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
