Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Interstate Truck Center, LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule of Schedule H, Line 4(i) – Schedule of Assets Held for Investment Purposes at End of Year are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the

audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 DESCRIPTION OF PLAN

The following description of the Interstate Truck Center, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. A more complete description of the Plan's provisions can be found in the plan agreement.

General – The Plan was adopted on November 1, 1976 by Interstate International, Inc. (a wholly-owned subsidiary), and on January 1, 1988 by Big D International Trucks, Inc. dba Silver State International, Inc. (acquired by Interstate International, Inc.). Effective November 1, 2004, these corporations contributed substantially all of their assets to two limited liability companies, Interstate Truck Center, LLC in California, and JBP, LLC dba Silver State International Trucks in Nevada (collectively the "Company").

Effective January 1, 2008, JBP, LLC dba Silver State International Trucks withdrew from the multi-employer plan and participant accounts related to that entity were transferred to a separate plan.

The Plan is a defined contribution plan covering all eligible employees of the Company who have 1,000 hours and one year of service, except collective bargaining employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Company's annual contributions to the Plan will equal the total amount of employee deferral contributions, employer matching contributions, and employer profit-sharing contributions. Employee deferral contributions under Internal Revenue Code Section 401(k) are amounts which the Company must contribute pursuant to a salary reduction agreement. The Company must contribute the amount by which participants have reduced their compensation for the plan year, subject to a statutory dollar limitation of \$23,000 for 2024 and \$22,500 for 2025. An additional salary deferral may be made for the calendar year by any participant that is age 50 or over during the calendar year. The Company will make employer-matching contributions up to 4% of an eligible participant's gross wages for the plan year. For the plan years ended December 31, 2024 and 2023, the employer matching contributions were \$416,278 and \$400,942, respectively.

Subject to Internal Revenue Service and ERISA limitations, employer profit-sharing contributions are at the discretion of the Company's Managing Members and the Company must have current and accumulated net profits exceeding \$1,000. For the years December 31, 2024 and 2023, the employer profit-sharing contributions were zero and zero, respectively.

Funding – Employee salary deferrals are funded by the Company concurrently with the processing of payroll each period. The annual Employer matching contribution is funded on or before the due date, including extensions, of the plan Sponsor's income tax return.

Participant Accounts – Each participant's account is credited with an allocation of the employer's profit-sharing contribution, plan earnings and forfeitures of terminated participants' non-vested accounts and with actual employee deferral contributions and employer matching contributions. Contributions and forfeitures are allocated based on the ratio of each participant's compensation for the Plan year to the compensation of all participants for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting – Participants are 100% vested in their employee deferral contributions. With respect to employer matching contributions, participants are 100% vested. With respect to employer profit-sharing contributions, participants are 20% vested after two years of service with an additional 20% increase in vesting for each additional year of service.

Investing Options – Upon enrollment in the Plan, a participant may direct employee contributions and employer matching contributions in any of the investment funds John Hancock Life Insurance Company USA offers. Participants may change their investment options daily through a toll-free number with John Hancock or via the internet on the John Hancock website.

Participant Notes Receivable – Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their non-forfeitable account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from 1-5 years or up to 25 years for the purchase of a primary residence. The loans are secured by the non-forfeitable balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the advisory committee. The interest rates on the current loans outstanding range from 4.25% to 9.50%. Principal and interest is paid ratably through bi-weekly payroll deductions.

If a participant should fail to make a payment on their loan, the loan is considered to be delinquent. The participant is given 90 days from the loan becoming delinquent to bring the loan back to a current status. If the loan is not brought current, the unpaid loan balance is considered to be a deemed distribution. As of December 31, 2024, there were no delinquent loans outstanding.

Payment of Benefits – Upon termination of service including death, disability or retirement, a participant will be paid no earlier than 90 days following the participant's separation from service. Normal retirement age is defined as 65. The benefit obligations payable to participants were \$911,146 and \$2,131,776 for December 31, 2024 and 2023, respectively.

Forfeitures – Monies forfeited by the participants in the Plan upon termination of employment with the Company, prior to attaining 100% vesting in the employer profit-sharing contributions may be used as part of the matching contributions, employer profit-sharing contributions, or to reduce administrative expenses. Total forfeitures allocated for 2024 and 2023 were \$0 and \$0, respectively.

Plan Amendments – Effective January 1, 2005, the Plan's name changed from the Interstate International, Inc. 401(k) Profit Sharing Plan to the current name. The Plan's federal identification number was also changed.

Effective February 1, 2005, the in-service distribution rules changed as follows: an in-service distribution from a participant's salary deferred account may be requested upon reaching age 59 ½; an in-service distribution from profit-sharing and/or matching contributions may be requested once a participant is 100% vested in his account; and, participants may request an in-service distribution threshold for involuntary cash-outs decreased from \$5,000 to \$1,000 for non-responsive separated participants. Effective August 15, 2005, the Plan loan policy was updated to provide for more detailed documentation to support loan requests.

The Plan was amended effective for plan years beginning after December 31, 2005 to comply with Internal Revenue Service regulations regarding hardship distributions. Hardship distributions must satisfy the deemed immediate and heavy financial need standards.

Effective January 1, 2008, JBP, LLC and Big D National Truck, Inc. dba: Silver State International, Inc. became unrelated employers and were removed as Participating Employers in the Interstate Truck Center, LLC 401(k) Profit Sharing Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Interstate Truck Center, LLC 401(k) Profit Sharing Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements is as follows:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized when received. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Notes receivable from participants are considered to be delinquent after one payment is late. The participant is notified by letter that the note receivable is held in default if the note is not brought current after three missed payments. The default is a deemed distribution.

Allowance for Doubtful Accounts

Allowance for doubtful accounts is assumed to be zero based on historical collections.

Investment Valuation and Income Recognition

Mutual funds are stated at their quoted market price on a daily basis.

Participant notes receivable are valued at cost plus accrued interest, which approximates fair value. The net aggregate change in net assets available for plan benefits are presented as net appreciation or depreciation in the fair value of investments.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Substantially all of the administrative expenses, including recordkeeping, trustee and other fees, incurred in connection with the Plan are paid by the Plan through an allocation to participant accounts.

NOTE 3 FAIR VALUE MEASUREMENTS

Generally accepted accounting principles provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common stocks, corporate bonds and U.S. government securities: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the net asset value (NAV) of shares held by the plan at the year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest include fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization or relatives of such persons. As of December 31 2024 and 2023, Plan investments included units held in an annuity contract with Standard Insurance Company. In addition, the Plan holds notes receivable from participants and paid certain expenses related to plan operations and investment activities to various service providers. Transactions with these entities qualify as exempt party-in-interest transactions.

NOTE 5 INVESTMENT CONTRACT WITH INSURANCE COMPANY

On July 18, 1996, the Plan entered into an allocated retirement account group annuity contract with The Manufacturers Life Insurance Company (John Hancock). John Hancock maintains the contributions from the employees and employer match in the investment options directed by each participant. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by Manulife. The contract is included in the financial statements at fair value as reported to the Plan by John Hancock. Fair value represents contributions made under the contract, plus earnings, less plan withdrawals and administrative expenses.

NOTE 6 TAX STATUS

The IRS has determined and informed the plan sponsor by a letter dated August 30, 2001, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The tax years 2021 to current remain subject to examination by taxing authorities.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. After payment of expenses properly chargeable against the Plan, the trustee shall distribute all Plan assets to the participants in the proportions determined by their respective accounts.

NOTE 8 RISKS AND UNCERTAINTIES

Plan participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. The maximum amount of loss due to credit risk in the event of a complete institutional failure at December 31, 2024 is \$18,179,380.

NOTE 9 SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 9, 2025, the date through which the financial statements were available to be issued.
