**Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of the WeStreet Federal Credit Union 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed, as described in the Auditor's Responsibilities for the Audit of the Financial Statements Section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements Section of our report. We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## **Responsibilities of Management for the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements are presented fairly, in all material respects, in accordance with GAAP.

**NOTE 1    DESCRIPTION OF THE PLAN**

---

The following description of the WeStreet Federal Credit Union 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established by WeStreet Federal Credit Union (the Credit Union) (formerly known as Tulsa Federal Credit Union), effective January 1, 1971. The Plan was set up for the purpose of allowing employees of the Credit Union to defer a portion of their annual base compensation for federal income tax purposes in accordance with Section 401(k) of the Internal Revenue Code. The Plan is a defined contribution plan covering all eligible employees of the Credit Union. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administrator and Trustees**

The Credit Union is the Plan Sponsor and named Plan Administrator. The Plan's Trustees are officers of the Credit Union. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator has formed a committee made up of Credit Union officers and members of the human resources department. The committee determines the appropriateness of the Plan's investment offerings and monitors investment performance and fees. The Plan's Investment Custodians are Empower Trust Company, LLC and Empower Annuity Insurance Company of America. The Investment Custodians hold all the Plan's assets and execute all of the Plan's transactions. Empower Trust Company LLC and Empower Annuity Insurance Company of America also perform participant recordkeeping services.

**Eligibility**

The Plan covers all employees employed by the Credit Union, except for nonresident aliens, who have attained age 18 and have been credited with one month of service.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and applicable employer contributions. Funds contributed by participants are invested at percentages as directed by participants in any one or more of several investment alternatives. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The investment fund income and gains or losses are allocated daily to the applicable participants' accounts in the respective funds based on the previously reported account balances, adjusted for current period contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Contributions to the Plan**

Each year, participants may elect to contribute up to 100% of their eligible compensation after completing one month of service, as defined in the plan document. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan on the first of the month after eligibility is met at a set percentage, unless they affirmatively elect otherwise. Automatically enrolled participants have their deferral rates set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make 'catch-up' contributions. Participants may also contribute amounts representing distributions from other defined benefit or defined contribution plans (rollovers). Participants may designate all or a portion of their elective deferrals as Roth (after tax) elective deferrals.

**Contributions to the Plan (Cont'd)**

The Plan also provides for employer safe harbor matching contributions of 100% of the first 3%, and 50% of the next 2% of eligible employee compensation for participants eligible for elective deferrals that have completed one year of eligibility service. The Credit Union may also make discretionary profit-sharing contributions; none were made in 2024 or 2023.

The total employer contributions, net of forfeitures, amounted to \$402,159 for the year ended December 31, 2024.

Participants direct the investment of both their individual contributions, plus their share of employer matching contributions, into the various investment options offered by the Plan. The Credit Union's contributions are allocated in the same manner as that of the participants elective contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Payment of Benefits and Distributions**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments through the Empower Guaranteed Income Fund. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Notes Receivable from Participants**

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Loan transactions are treated as participant-directed investments. Loan terms range from one to five years. Loan terms may exceed five years only in the event the loan proceeds are used to purchase or construct a participant's principal residence. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing prime rates. Principal and interest are paid ratably through payroll deductions.

**Vesting**

Participants are immediately vested in their deferral contributions and employer safe harbor matching contributions, plus actual earnings thereon. Employer matching is vested at 100% from the eligibility date, and the discretionary profit-sharing contributions are subject to a six-year graded vesting schedule based on years of service. Participants are 100% vested in employer contributions after the completion of six years of service or upon death or total and permanent disability.

**Forfeited Accounts**

Forfeitures will be used to reduce future employer contributions or to pay plan administrative expenses. At December 31, 2024 and 2023, forfeiture account balances totaled approximately \$7,964 and \$6,220, respectively. Forfeitures of approximately \$1,434 were used to reduce employer contributions during the year.

**Investment Options**

Upon enrollment in the Plan, participants may direct their participant accounts to be invested in various mutual funds, general insurance accounts, or a fixed deferred group annuity. These funds include a variety of investment options with various objectives and degrees of financial risk.

**NOTE 2    SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

**Basis of Accounting**

The accounting records and the accompanying financial statements are maintained on the accrual basis of accounting. Employee contributions are recorded when withheld from pay. Employer contributions and income from investments are recorded when they are earned. Expenses are recorded in the accounting period in which they are incurred.

**Use of Estimates**

The preparation of the financial statements, in accordance with accounting principles generally accepted in the United States of America (GAAP), requires the Plan management to make estimates and assumptions that affect the reported amounts of the Plan assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Investment Custodians and investment advisors. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of investments valued at contract value.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation or depreciation in fair value investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)**

---

**Notes Receivable from Participants**

Notes receivable from participants are valued at their unpaid principal balances, plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits payments to participants are recorded when paid.

**Fees and Expenses**

Certain of the Plan's administrative expenses, including salaries, accounting, and legal, are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of loans and benefit payments are charged directly to the participants accounts and are included in administration expenses. Direct fees for custodian and recordkeeping services are paid by the Plan and are also included in administration expenses. Investment-related expenses are included in the net appreciation or depreciation in fair value of investments.

**Reclassification**

Certain prior year amounts have been reclassified to conform to the current year's presentation.

**Subsequent Events**

The Plan has evaluated subsequent events through the date of this report, which is the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE MEASUREMENTS**

---

Fair value as defined under U.S. GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U.S. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. The three levels of the fair value hierarchy under *FASB ASC 820 – Fair Value Measurement*, are described as follows.

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value.

The financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments consist solely of mutual funds (registered investment companies) that are measured on a recurring basis using Level 1 inputs. There have been no changes in the methodologies used at December 31, 2024, and 2023. Mutual funds are valued at daily closing prices, as reported by the fund, and are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset values and to transact at those prices. Mutual Funds held by the Plan are deemed to be actively traded.

**NOTE 4 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

---

The Plan has entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America with regard to the EI Fixed Account - Series Class I, totaling \$272,404 and \$689,441 as of December 31, 2024, and 2023, respectively. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administration expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan and declared for any quarter at the discretion of Empower Annuity Insurance Company of America. As of December 31, 2024, the crediting rate for the EI Fixed Account - Series Class I is 1.41%.

The contract meets the fully benefit-responsive investment contract criteria, and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America and represents contributions made under the contract, plus earnings, less participant withdrawals, and administration expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. No events are probable of occurring that might limit the ability of the Plan and participants to transact at contract value with the issuer.

**NOTE 5 – UNAUDITED INVESTMENT INFORMATION CERTIFIED BY THE CUSTODIANS**

---

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Empower Trust Company LLC and Empower Annuity Insurance Company of America as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

- All investment balances reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- All investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024; and
- Notes receivable from participants as of December 31, 2024 and 2023 and the related income on notes receivable from participants for the year ended December 31, 2024

**NOTE 6 RELATED PARTY and PARTY-IN-INTEREST TRANSACTIONS**

---

Certain plan investments are managed by Empower Trust Company LLC and Empower Annuity Insurance Company of America, who are the Custodians as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. For the year ended December 31, 2024, the Plan paid fees to the Custodian in the amount of \$31,947. Certain investment-related expenses are included in the net appreciation or depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Certain accounting and administrative functions are performed by officers or employees of the Credit Union. No such officer or employee received compensation from the Plan.

**NOTE 7 RECONCILIATION TO FORM 5500**

---

Net assets available for benefits from the Form 5500, "Annual Return/Report of Employee Benefit Plan" (Form 5500), agrees with the Plan's financial statements.

---

**NOTE 8 TAX STATUS OF THE PLAN**

---

The Plan has adopted a prototype plan document sponsored by Empower Trust Company LLC and Empower Annuity Insurance Company of America. That document has received an advisory letter dated November 14, 2022, from the IRS as to the prototype plan's qualified status. The prototype plan advisory letter has been relied upon by the Plan.

The Plan was most recently restated on January 1, 2022. However, there were no significant changes from the prior Plan document other than as described in Note 1.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is currently not being examined. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2020.

**NOTE 9    RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10    PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Credit Union may, at its discretion, elect to discontinue its contributions at any time, or terminate or amend the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Credit Union may determine.
