#### **NOTE A - PLAN DESCRIPTION**

The following description of the SandRidge Energy, Inc. 401(k) Plan (the "Plan") provides only general information. For a more complete description of the Plan's provisions, participants in the Plan should refer to the Plan document.

##### ***General***

The Plan is a defined contribution plan covering all eligible employees of SandRidge Energy, Inc. and its subsidiaries (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan is administered by the Sandridge Energy, Inc. Benefits Committee (the "Committee"). T. Rowe Price Trust Company ("T. Rowe Price") serves as both the trustee and the custodian (the "Trustee").

##### ***Eligibility***

Employees become eligible on the first day of employment and upon reaching age 21.

##### ***Contributions***

Upon enrollment into the Plan, participants may elect to make pre-tax and Roth salary deferral contributions up to 75% of their eligible annual compensation subject to Internal Revenue Code ("IRC") limitations. Participants may direct contributions into one or more of the available investment options. Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans.

Eligible employees, who do not affirmatively make a salary deferral election, will be automatically enrolled in the Plan at 3% of their eligible compensation until either the participant elects to discontinue or change his or her election. Salary deferrals for participants who are automatically enrolled will escalate 1% annually up to a maximum of 6%.

The Company may make discretionary matching contributions, which are determined annually by management. For the year ended December 31, 2024, the Company made discretionary matching contributions of 100% on up to 10% of participants' eligible compensation.

##### ***Participant Accounts***

A separate account is established for each participant. The account is credited or charged, as applicable, with the participant's salary deferral contributions, an allocation of the Company's discretionary matching contributions, the participant's share of investment earnings and losses, the participant's distributions, and certain administrative charges. Allocations are based on participant earnings or account balances, as defined. Participants direct the investment of their account into the various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in the participant contributions of their accounts plus actual earnings thereon. The Company's discretionary matching contributions plus earnings thereon vest based on years of service, as shown in the following table:

Upon termination of service due to a participant's death, disability or retirement, the participant has a non-forfeitable right to 100% of his or her account balance.

***Forfeitures***

Unvested Company matching contributions, if any, are forfeited and remain in the Plan following separation of employment due to reasons other than a participant's death, disability or retirement. Unvested forfeited amounts may be used to pay Plan expenses that otherwise would be payable by Plan assets or reduce Company matching contributions in accordance with the Plan document. During the year ended December 31, 2024, there were no forfeitures used to reduce employer contributions. Forfeited non-vested accounts as of December 31, 2024 and 2023, were \$226,984 and \$211,365, respectively.

***Payment of Benefits***

The Plan provides for payments of benefits to participants or their beneficiaries (i) in the event of a participant's death, (ii) in the event a participant becomes permanently disabled or (iii) in the event a participant age 59½ or older elects to receive in-service distributions. Benefit distributions can be made as lump-sum payments, substantially equal installments or partial withdrawals. Participants may also make withdrawals from their pre-tax elective deferral account in the event of certain financial hardships.

***Notes Receivable From Participants***

Participants may borrow from their eligible vested accounts, a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the borrower's vested account balance or \$50,000 less the amount of the highest outstanding loan balance in the prior 12-month period. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% in effect at the time of the application of the loan and will be fixed for the entire term of the loan. The maximum term of a general loan is five years. However, if the loan is for the purchase of a principal residence, the Plan Administrator may permit a longer repayment term. Interest rates on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024 and 2023.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation, in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. The Company provides administrative and managerial services to the Plan at no charge. Investment related expenses are included in net appreciation in fair value of investments.

The recordkeeper of the Plan charges a quarterly administrative fee that is charged directly to the participant accounts.

#### ***Other Income***

T. Rowe Price Retirement Plan Services, Inc. receives pricing credits associated with certain investments in the Plan and allocates those pricing credits to participants in proportion to their account balances invested in those options.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

**NOTE C - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds* - Valued at the NAV of the units held by the Plan at year-end, as determined by fair value of the underlying assets. Underlying assets include commingled pools of exchange traded equity and fixed income securities.

*Stable value fund* - A stable value fund valued at the NAV of units of the collective trust. The NAV is calculated by the fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund and is used as a practical expedient to estimate fair value.

Investments without a readily determinable fair value have been valued at NAV as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with industry practices, the use of different methodologies or assumptions

**NOTE D - STABLE VALUE FUNDS**

The Plan invests in collective trust funds that are considered to be stable value funds with underlying investments in fully benefit-responsive investment contracts. Fair value of the stable value funds are the NAV of the funds. The NAV is based on net assets, which includes the fully benefit-responsive investment contracts at contract value. The funds are the Plan's guaranteed investment fund option. The funds' investment objective is to maximize current income consistent with the maintenance of principal and to provide for withdrawals for certain participant-initiated transactions under a retirement plan without penalty or adjustment. To achieve their investment objective, the funds invest in short-term money market instruments and are fully benefit-responsive synthetic guaranteed investment contracts and other similar contracts with various insurance companies, banks, and financial institutions. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events can limit the ability of the Plan to transact at contract value with the funds, and the funds themselves may be subject to circumstances that affect their ability to transact at contract value. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

**NOTE E - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator determined that the certifications received from the Trustee meet the requirements of ERISA Section 103(a)(3)(C). The Trustee certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income, other income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE F - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain plan investments are held and managed by the Trustee. The Trustee also performs administrative and recordkeeping services for the Plan. The Plan permits notes receivable from participants. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

**NOTE G - PLAN TERMINATION**

Although it has not expressed an intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and terms of the Plan. In the event of termination or partial termination of the Plan, applicable participants' accounts shall be fully vested as of the date of such termination. The Company determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

**NOTE H - TAX STATUS**

The Plan utilizes a pre-approved plan document sponsored by T. Rowe Price Trust Company. The Internal Revenue Service ("IRS") provided an opinion letter dated August 19, 2020, which states the pre-approved document satisfies the provisions of Section 401 of the IRC. The Plan Administrator believes the Plan, including any subsequent amendments, is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE I - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is a least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
