***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Lance, Soll & Lunghard, LLP 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Lance, Soll & Lunghard, LLP 401(k) Profit Sharing Plan (the "Plan"), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### 1. General

The Plan was established effective January 1, 1993 for eligible employees of Lance, Soll & Lunghard, LLP (the "Employer" or the "Firm") and is a defined contributory profit sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### 2. Eligibility

An employee, as defined in the plan agreement, is eligible to make contributions to the Plan and to receive Employer matching contributions upon reaching the age of 18 and completion of six months of service. Employees are eligible to receive Employer profit-sharing contributions upon reaching the age of 18 and completion of one year of service, as also defined in the plan agreement. Employees who have satisfied eligibility requirements are eligible to begin participating in the Plan on January 1 or July 1. Self-employed owners of the Firm are considered employees for plan purposes and are eligible to participate in the Plan upon meeting the eligibility requirements. However, any employee who has a written compensation agreement with the Employer that provides, in part, that they shall not receive any matching contributions under the Plan shall be excluded from such Employer contributions. Employees covered under a collective bargaining agreement, non-resident aliens, and leased employees are not eligible to participate in the Plan.

##### 3. Contributions

Participants may elect to contribute, on a tax-deferred basis and/or make Roth contributions, up to the maximum deferral limit per Section 402(g)(1) of the IRC. Additional "catch-up" contributions may be made beginning in the plan year in which a participant will be at least age 50 by the end of the plan year.

The Plan allows for the Employer to make a discretionary matching contribution. During 2024, the Employer matched 50% of employee deferrals up to the first 4% of compensation contributed by the employee, resulting in a maximum employer matching contribution of 2%. The match is made on a per payroll basis. For the year ended December 31, 2024, the Employer made discretionary matching contributions totaling \$231,539 (net of applied forfeitures of \$19,980).

The Plan also allows for the Employer to make a discretionary profit-sharing contribution to participants employed on the last day of the plan year, who have also completed 1,000 hours of service during the plan year. The Employer made \$60,000 discretionary profit-sharing contributions for the year ended December 31, 2024.

**4. Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer matching contributions, and allocations of the Employer profit-sharing contributions, and plan earnings. Employer profit-sharing contributions are allocated based on a percentage of compensation or a dollar amount per participant based on each participant's classification group. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**5. Investment Options**

Participants may direct employee and Employer contributions, as desired, in any of a variety of investment options offered by Transamerica Trust Company ("Transamerica"), as selected by the Employer. Participants may change their investment options daily.

**6. Forfeitures**

Forfeitures of terminated participants' non-vested accounts may be used to offset administrative expenses of the Plan or reduce future Employer contributions. As of December 31, 2024 and 2023, outstanding forfeitures available totaled \$22,052 and \$6,047, respectively, and are included in net assets available for benefits.

**7. Benefit Payments**

Upon termination of service, participants are entitled to a distribution of their vested account balance. Upon termination of employment due to normal retirement or death, the participant or the participant's beneficiary is entitled to 100% of the participant's account balance. Distributions are made in lump-sum payments, in partial, or non-periodic distributions. Additionally, participants may receive distributions upon attaining age 59 ½ or for financial hardship, if certain criteria are met.

**8. Vesting**

Participant contributions, rollovers and actual earnings thereon are fully vested at all times. Vesting of the Employer matching and profit-sharing contributions is based upon the participant's years of service with the Employer as follows:

**9. Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 up to lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in the previous twelve months. The loans are secured by the balance in the participant's account. Loans must be repaid within five years of the date of issuance and shall bear interest at the prime rate plus 2%. Participants may not have more than two loans outstanding at one time.

**10. Plan Termination**

Although it has not expressed such intent, the Employer reserves the right, at any time, to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants would become fully vested in their employer contributions. The assets of the Plan would be distributed to the participants based on each individual participant's interest in the Plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**2. Plan Administration**

The Employer is the plan sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

**3. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### 4. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

##### 5. Payment of Benefits

Benefits are recorded when paid.

##### 6. Administrative Expenses

Administrative expenses incurred by the custodians and other service providers in performance of their duties are paid from the assets of the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

The plan administrator authorized the Plan's recordkeeper, to establish an expense budget account (EBA). The EBA is funded by the recordkeeper's shared revenues from certain investments. At the direction of the Employer, these funds may be used to pay reasonable plan related expenses or can be allocated to plan participants at the end of the year. For the year ended December 31, 2024, shared revenues totaled \$35,950 and expenses paid from the EBA totaled \$35,535, which are netted and reflected in administrative expenses in the accompanying Statement of Changes Net Assets Available for Benefits.

##### 7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### 8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### NOTE C - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the following custodians of the Plan: Reliance Trust Company (as of December 31, 2023 and for the period January 1, 2024 to June 30, 2024), Transamerica Trust Company (as of and for the six months ended December 31, 2024), and Transamerica Life Insurance Company Inc. (as of December 31, 2024 and 2023 and for the year ended December 31, 2024).

#### NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds*: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

*Interest-bearing cash (Diversified Cash Reserve account)*: Interest-bearing cash account, valued at cost plus accrued interest.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

**NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds an investment that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus credited interest, less participant withdrawals, and administrative expenses.

The following represents the traditional investment contract held by the Plan:

The traditional investment contract is a stable value fund. The stable value fund is backed by the general account of Transamerica. On a semi-annual basis Transamerica declares a guaranteed crediting rate that shall apply for a six-month period and this rate will not change during this six-month period. There is no minimum guaranteed interest rate. Plan participants may transfer assets from the stable value fund to non-competing funds without restrictions, but must remain in the non-competing fund for 90 days before transferring to a competing fund. Transamerica may impose a hold period, up to 12 months, at the contract level in the event of a full contract discontinuance or partial contract discontinuance initiated by the Plan. Transamerica may effect a total discontinuance of the contract under certain circumstances including if: the Plan is terminated, the contract can no longer be treated as a pension plan contract, or if the account value at any time equals or is less than \$20,000.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

**NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Reliance Trust Company (through June 30, 2024), Transamerica Trust Company (effective July 1, 2024) and Transamerica Life Insurance Company Inc. are custodians of the Plan. Transamerica Retirement Services is the recordkeeper for the Plan. Transactions with these entities qualify as party-in-interest transactions. Notes receivable from plan participants and the related interest income are also considered party-in-interest transactions.

#### **NOTE G - TAX STATUS**

The Employer adopted a new non-standardized pre-approved profit sharing plan (“pre-approved plan”) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated December 17, 2021 which stated that the applicable pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

#### **NOTE I - SUBSEQUENT EVENTS**

Effective January 1, 2025, the plan sponsor’s name changed from Lance, Soll & Lunghard, LLP to LSL, LLP and the Plan’s name changed from Lance, Soll & Lunghard, LLP 401(k) Profit Sharing Plan to LSL, LLP 401(k) Profit Sharing Plan. In addition, eligibility for elective deferrals was reduced from 6 months to 60 days, with entry dates on the first day of each month. The Employer matching contribution limitation also increased from 4% of compensation to 6%.

Plan management has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.



