In planning and performing our audit of the financial statements of the Lensing Wholesale, Inc. 401(k) Profit Sharing Plan and Trust (Plan) as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing our auditing procedures, but not for the purpose of expressing our opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and would not necessarily identify all deficiencies in internal control that might be significant deficiencies or material weaknesses and; therefore, there can be no assurance that all deficiencies, significant deficiencies, or material weaknesses have been identified.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the financial statements will not be prevented or detected and corrected on a timely basis.

A significant deficiency is a deficiency, or combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

Following are descriptions of identified control deficiencies that we determined did not constitute significant deficiencies or material weaknesses:

#### **TIMELY REMITTANCE OF CONTRIBUTIONS**

During our audit, we noted there was insufficient controls in place to ensure the employer segregates all employee contributions from its general assets as soon as administratively feasible, as required by the Department of Labor (DOL). We noted employee contributions for certain paycheck dates between January and April during the audit year took longer to remit to the Plan compared to remaining paycheck dates during the audit year. We discussed with Plan management and noted new procedures were implemented in April to ensure employee contributions are remitted timely.



### **MISSING EMPLOYEE DEFERRALS**

During our audit, we noted participants whose employee contribution amount per payroll was greater than the amount deposited in his or her participant account. It was noted these employees received off-cycle payroll checks and 401(k) deductions were not remitted to the Plan.

We recommend that the Plan Sponsor put controls in place to ensure 401(k) deductions in off-cycle payrolls are remitted to the Plan in a timely manner. In addition, we recommend the Plan Sponsor consult with ERISA counsel to determine options for correction.

### **INCONSISTENT DEMOGRAPHIC DATA ACROSS PROVIDERS**

During our audit, we noted there are insufficient controls in place to ensure that employee data matches between the recordkeeping system and the payroll system. We noted certain employee data did not match between service providers, specifically date of rehire. It is important that employee data in the recordkeeping system be accurate since this is the data used for Plan operations and to ensure the Plan's compliance with laws and regulations.

We recommend Plan management put policies and procedures in place to ensure employee data captured in the recordkeeping system is reviewed for accuracy and relevance for proper Plan operations.

### **MANDATORY DISTRIBUTIONS**

During our audit, we found that there is no procedural control in place to ensure that mandatory distributions are processed following severance of employment for participants with an account balance of \$7,000 or less, pursuant to Plan provisions. We noted participant accounts exist at audit year-end that belong to terminated employees and do not exceed \$7,000.

We recommend Plan management consult with its service provider to develop a procedural control to periodically (at least annually) review the accounts of terminated employees and process mandatory distributions pursuant to Plan provisions. If mandatory distributions cannot be made due to missing participants, Plan fiduciary must be able to demonstrate compliance with DOL's missing participants guidance (<https://www.dol.gov/agencies/ebsa/employers-and-advisers/plan-administration-and-compliance/retirement/missing-participants-guidance>) regarding efforts made in locating missing participants or the selection of a distribution option for the benefit of missing participants.



### **AUTO ENROLLMENT NOT DONE TIMELY**

During our audit, we noted Plan management did not have proper controls in place to ensure all newly eligible employees were auto enrolled into the Plan in a timely manner, unless the employee specifically opted out. Written documentation of opt out from auto enrollment is important if there were ever any disagreement or allegations by employees that he or she was not auto enrolled in the Plan upon meeting eligibility requirements, a violation of Plan provisions and ERISA.

We recommend that Plan management put policies and procedures in place to maintain adequate documentation that supports all newly eligible employees are either timely auto enrolled into the Plan or the employee has specifically opted out of participation. We also recommend that the Plan Sponsor consult with ERISA counsel to determine correction options for affected participants.

### **ELIGIBLE COMPENSATION**

During our audit, we noted that the compensation used for calculating employee deferrals is not consistent with the definition of eligible compensation stated in the Plan Document. Cleaning Dollars wages were excluded from compensation for the November 22, 2024 and December 6, 2024 pay periods for one participant. In addition, one participant did not have deferrals on the final paycheck upon termination.

We recommend reviewing the contribution calculations to determine if the compensation used is being applied consistently, and as intended. We recommend reviewing the Plan Document to determine if the definition of eligible compensation is in agreement with the current application and intent. Additionally, we recommend that you consult with the third-party administrator and ERISA counsel to determine what corrective action and/or amendments are necessary.

### **NONDISCRIMINATION TESTING**

The Plan is subject to certain annual nondiscrimination tests. The results of such tests have a direct effect on whether the Plan remains qualified. The Plan did not initially meet the requirements of the nondiscrimination tests for the Plan year ended December 31, 2024. In order to meet the requirements, the Plan had to refund a portion of the contributions made by highly compensated participants. We recommend that the Company ask the third-party administrator to perform preliminary ADP and/or ACP and Section 415 tests during the Plan year. The need to plan is especially important to the highly compensated participants because excess contribution refunds can cause them a delay in filing their individual income tax returns or require them to file amended income tax returns. Noncompliance may also affect the calculation of Sponsor-matching contributions.

We recommend that the Company revise the procedures to monitor compliance with the nondiscrimination tests, and to ensure that the matching contribution is correctly calculated.



## TRUST STATEMENT RECONCILIATION

During our audit inquiries of Plan management, Plan management noted they review Plan level trust statements but there is no reconciliation of Plan activity throughout the year. Periodic review and reconciliation of Plan level trust statements and activity throughout the year allows Plan management and/or Plan fiduciaries to identify and correct errors in a timely manner, as well as document oversight of the Plan and assist in mitigating fiduciary risk.

We recommend Plan management establish procedural controls to ensure that Plan level trust statements are periodically (quarterly or bi-annually) reviewed and reconciled with Plan Sponsor payroll and other relevant records. The review and reconciliation process should be documented and consider items such as: total employee contributions withheld per payroll agrees to contributions deposited to the Plan by source, spot checking some individuals, total employer contributions agree to contributions deposited to the Plan by source, spot checking some individuals, and reviewing distributions, fees, and other activity for any unusual or unexpected transactions.

This communication is intended solely for the information and use of the Plan administrator, Investment Committee, and management involved within the Plan, and is not intended to be and should not be used by anyone other than these specified parties.

### ***Note 1 - Plan Description***

The following description of the Lensing Wholesale, Inc. (Company) 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of the Company who have two months of service and are age 18 or older. The Plan is subject to the provisions of ERISA. The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

#### *Contributions*

Each year, participants may contribute up to 50 percent of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation and their contributions invested in a designated target date retirement fund correlated with their normal retirement age until changed by the participant. The Company shall increase the deferral rate for employees automatically enrolled by one percent annually up to five percent, unless the employee elects against the increase. The Company contributes a non-discretionary matching contribution equal to 33 percent up to three percent of the participant's eligible compensation for employees who have obtained one year of service by July 1st of the Plan year, who have completed 1,000 hours of service during the Plan year, and are employed as of the last day of the Plan year with exceptions for death, disability, or retirement. The Company may also contribute a discretionary profit sharing contribution as determined by the Company's Board of Directors. During the year ended December 31, 2024, the Company made a \$158,093 profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Note 1 - Plan Description (Continued)***

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other eligible events defined by the Plan, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants who have attained age 59 ½ may elect to receive either a partial withdrawal or lump-sum amount equal to the value of the participant's vested interest in his or her account.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,008 and \$5,365, respectively. These accounts will be used to pay administrative expenses or reduce future employer contributions. Also in 2024, administrative expenses were reduced by \$12,896 from forfeited nonvested accounts.

### ***Note 2 - Significant Accounting Policies***

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping, investment advisory, and Plan audit fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### ***Note 4 - Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end money market fund that is registered with the Securities and Exchange Commission. This fund is required to publish their daily NAV and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

### *Note 5 - Related Party Transactions and Party-in-Interest Transactions*

Certain Plan investments are shares of mutual funds and a money market fund managed by Fidelity Investments Institutional. Fidelity Management Trust Company, a related entity, is the Trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator, investment consultant, and other service providers in the total amount of \$54,684, which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

### *Note 6 - Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### ***Note 7 - Tax Status***

The Plan adopted a nonstandardized pre-approved profit sharing plan with Cash or Deferred Arrangement sponsored by FMR, LLC, a related party of Fidelity Management Trust Company. The plan has received an opinion letter from the IRS as to the plan's qualified status. The Plan Sponsor can rely on the qualified status to the extent the Plan Document does not deviate from the IRS pre-approved provisions. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

### ***Note 8 - Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Note 10 - Subsequent Events***

The Plan has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was restated and amended the Company's non-discretionary matching contribution provisions to change the eligibility requirements for employees to obtain two months of service by December 1st of the Plan year, eliminated the requirement to have completed 1,000 hours of service in the Plan year, and increased the match limit up to six percent of the participant's eligible compensation. Additionally, the restatement included amendments to allow for monthly enrollment in all contribution types allowed by the Plan, to allow participants to change deferrals elections as of the beginning of each payroll period, and to change vesting in the Company's contributions to a five-year vesting schedule.

Effective January 1, 2025, the Plan was amended to modify its automatic deferral provisions whereby participants who are automatically enrolled will have their deferral rate set at six percent of eligible compensation and the deferral rate will increase one percent annually up to 12 percent. Additionally, the Plan implemented a one-time resolicitation as of January 1, 2025 whereby all eligible employees with a deferral rate of zero percent were automatically enrolled at six percent and participants with a deferral rate greater than zero had a one-time increase to their deferral rate up to six percent.
