Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements December 31, 2024

1. Description of Plan

The following brief description of the Stach & Liu, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, as amended, is a defined contribution and profit sharing plan covering all employees of the Company, with a minimum age of 18 and a minimum service requirement of three months (through August 1, 2024). Participation in the Plan is voluntary. The Plan went into effect January 1, 2006, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and is designed to qualify under Section 401(k) of the Internal Revenue Code (the “Code”).

Effective October 1, 2024, the Plan was amended. A significant revision to the Plan included removing the minimum service requirement of three months.

Plan Administration

Stach & Liu, LLC (dba Bishop Fox, LLC) (the “Company”) is the sponsor of the Plan. The Company’s Director of Human Resources is the Plan Administrator.

The Company has contracted with Ascensus, LLC, and its subsidiary, Ascensus Trust Company, to act as the record-keeper, asset custodian and trustee (collectively, “Ascensus”). Ascensus holds and distributes the funds of the Plan in accordance with the Plan’s provisions and instructions of the participants and the Plan Administrator.

Participant Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to limits established by the Code (\$23,000 in 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also make contributions to the Plan on an after-tax basis by designating deferrals as Roth deferrals. The Plan includes an automatic enrollment provision whereby, eligible employees automatically have 2% of their compensation withheld as an employee contribution unless they complete a salary reduction agreement and elect a different percentage or elect not to participate at all.

Notes to Financial Statements (continued) December 31, 2024

1. Description of Plan (continued)

Employer Contributions

The Plan is currently designed as a safe harbor 401(k) plan. Each semi-monthly period, the Company matches 100% of the first three percent of compensation and 50% of the fourth and fifth percent of compensation deferred by eligible participants and such amounts are immediately fully vested. The Company may also make discretionary profit sharing contributions to the Plan that are subject to time-based vesting. During 2024, there were no such profit sharing contributions made to the Plan. Contributions are subject to certain limitations established by the Code.

Participant Accounts

A separate account is maintained for each participant and is credited with the participant's contributions, the Company's contributions, and investment earnings and losses, net of certain investment management fees. Participants may direct the investment of their account in any combination of investment funds offered by the Plan. The Company's matching contribution is allocated among the funds within each participant account in the same manner as the participant's contributions. Investment income is allocated daily among eligible participants in the ratio which the dollar value of the respective participant's interest in the specific investment bears to the dollar value of all participants' interests in that investment. A participant is entitled to the vested benefit provided from their account.

Investment Options

Investments of the Plan consist primarily of interests in mutual funds (Note 4). Upon enrollment in the Plan, participants may direct employer and participant contributions in increments of 1% in any of the investment options offered under the Plan. Participants may change their investment options at any time.

Vesting

Participants are immediately vested 100% in their contributions, plus actual earnings thereon. The employer safe harbor matching contributions are also immediately vested 100%. The discretionary profit sharing contribution, if any, vests at a rate of 20% beginning the second year of participation and a participant is 100% vested after six years of credited service.

1. Description of Plan (continued)

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loans must generally be repaid within five years, unless the loan is used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate at the prime rate of interest plus 1% per year (8.50% as of December 31, 2024). Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of Benefits

Upon termination of employment, retirement, death or disability, a participant may elect to receive a lump-sum payment, make partial withdrawals, or rollover the balance in their account to an eligible retirement plan, equal to the participant's vested interest in his or her account. Distributions may be made as soon as administratively feasible following termination of employment.

Hardship Withdrawals

Participants may receive hardship withdrawals against the employee deferral and vested employer portion of their account (excluding any earnings allocated thereto) for specified financial needs, such as unreimbursed medical expenses, the purchase of a primary residence, to prevent potential eviction or foreclosure on their personal residence, or to pay for post-secondary education expenses.

Forfeited Accounts

Forfeited, non-vested amounts are to be applied to reduce employer contributions. As of December 31, 2024 and 2023, there were no forfeited, non-vested amounts.

Termination of the Plan

The Company may terminate, amend, modify, or suspend the Plan, in whole or in part, at any time. However, in any such event, the participants' rights to their accrued benefits become 100% vested.

Income Tax Status

The Plan adopted an Ascensus Non-Standardized Pre-Approved Profit Sharing Plan With Cash or Deferred Arrangement, which received a favorable opinion letter from the Internal Revenue Service (the “IRS”) dated June 30, 2020. The Plan also adopted an Ascensus Qualified Retirement Plan Non-Standardized Adoption Agreement effective October 1, 2024. Although the Plan has been amended subsequent to receiving the IRS opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and is therefore exempt from income taxes. Accordingly, no provision for income taxes has been included in the Plan’s financial statements. The Plan has not received a determination letter specific to the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value (Note 4) in the accompanying Statements of Net Assets Available for Benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net change in the fair value of its investments, which consists of net realized and unrealized gains and losses.

2. Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal amount plus any accrued but unpaid interest. Interest income is recognized on the accrual basis and no allowances for expected credit losses were required as of December 31, 2024 and 2023. When applicable, delinquent participant loans are reclassified as distributions (referred to as deemed distributions) pursuant to the provisions of the Plan document. During the year ended December 31, 2024, there were no delinquent participant loans that were reclassified as deemed distributions.

Contributions

Participant contributions are recorded by the Plan in the year withheld from participant earnings. Contributions to the Plan by the Company are recorded in the year which they become obligations of the Company.

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recognized as a liability with a corresponding reduction to contributions. The Plan distributes excess contributions to applicable participants no later than March 15 of the following year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan may be paid from Plan assets; however, the Company pays for expenses such as administration and periodic financial reporting fees. Such expenses are reflected as Administrative Expenses in the Statement of Changes in Net Assets Available for Benefits (Note 5).

Income Taxes

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

3. Summary of Investment Data Certified by the Plan Trustee

The Plan's investments were held by Ascensus at December 31, 2024 and 2023, and the following investment information was certified to be complete and accurate within the meaning of 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Interest and dividend income from investments, net realized gains and losses, and net unrealized appreciation in the fair value of investments reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Interest income on notes receivable from participants reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investments at fair value and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.

4. Investments and Fair Value

Plan investments should generally be presented at fair value at the reporting date. GAAP establishes a framework for measuring fair value and defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. GAAP also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of inputs that may be used to measure fair value are:

Level 1: Quoted prices for identical assets or liabilities in active markets.

Level 2: Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

Notes to Financial Statements (continued) December 31, 2024

4. Investments and Fair Value (continued)

The following is a description of the valuation methodologies used for assets measured at fair value:

Money market fund: The money market fund is valued based on the Net Asset Value (“NAV”) of underlying securities that have observable inputs, including quoted prices for similar assets in active or inactive markets. The Plan uses a practical expedient permitting a reporting entity to measure the fair value of certain investments using the net asset value per share (or its equivalent) of the investment.

Mutual funds: Such investments are valued at the daily closing price as reported by the respective fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Therefore, they are deemed to be Level 1 investments.

The methodologies described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan provides for various investment options in any combination of fixed income securities, mutual funds, including target-date funds, and other investment securities. These investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the accompanying financial statements.

5. Party-in-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The following transactions qualify as party-in-interest transactions for which a statutory exemption exists:

- The Plan issues notes receivable to participants, which are secured by the balances in the participants’ accounts.
- The Company paid certain administrative expenses of the Plan.
- Certain employees of the Company provide administrative services to the Plan.
