We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of schedule H—part IV, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Description of Plan

The following description of the Care Initiatives 403(b) Group Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General and eligibility:** The Plan is a defined contribution plan covering all employees of Care Initiatives (Care), the Plan Sponsor. Employees are eligible to make elective deferral contributions to the Plan on the first day of employment. Upon entry into the Plan, employees are eligible to receive an employer discretionary matching contribution which occurs upon commencement of employment or, if later, on January 1 or July 1 of each calendar year. The Committee for Administration of 403(b) Group Retirement Plan (the Committee) is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute a stated percentage of their compensation, as defined by the Plan, not to exceed the maximum allowed by federal regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan also permits Roth elective deferrals, Roth rollovers and in-plan Roth conversion contributions. Care may make a discretionary matching contribution equal to a percentage of up to 6% of participating employee's compensation. Discretionary matching contributions of 25% of the first 6% of eligible compensation were made beginning June 2024 through the year ended December 31, 2024. Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

**Investment options:** Participants may direct their contributions and employer discretionary matching contributions into various mutual funds. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's contribution, Care's discretionary matching contribution, and an allocation of Plan earnings and expenses that are paid by the Plan. Allocations of Care's contributions are based upon the participant's compensation and allocations of Plan earnings and expenses are based upon the participant's account balance.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Effective April 1, 2022, vesting of employer matching and discretionary contributions is 0% until three or more periods of service, which are measured as 12-month periods starting with date of hire, is obtained by the participant. Once obtained the participant will become fully vested in these contributions plus actual earnings thereon. Prior to the amendment, participants were immediately vested in the employer matching and discretionary contributions.

**Payment of benefits:** Upon termination of service or reaching age 59½, participants may elect to receive a lump-sum amount equal to the value of their account or may choose from installment payments available under the Plan. Participants with an account balance less than \$1,000 may roll over the amount into another qualified plan or receive a mandatory lump-sum distribution upon termination of service.

**Forfeited accounts:** Forfeitures are used for plan expenses or to reduce employer contributions. During the year ended December 31, 2024, forfeitures were used to reduce plan expenses. The balance of forfeited nonvested accounts totaled \$3,034 and \$528 as of December 31, 2024 and 2023, respectively.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Contributions:** Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Use of estimates:** The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 9 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit payments:** Benefit payments are recorded when paid.

**Subsequent events:** Management has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued.

#### Note 3. Administrative Expenses

Certain administrative functions are performed by employees of Care. No such employee receives compensation from the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation of fair value of investments.

#### Note 4. Information Certified by State Street Bank and Trust Company (the Custodian)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and the ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate, by the Custodian, a qualified institution:

The Custodian also certified to the completeness and accuracy of \$750,843 of interest and dividends, and \$3,476,580 of net appreciation in fair value of investments (including investments bought, sold and held during the year) related to the aforementioned investments for the year ended December 31, 2024.

#### **Note 5. Plan Termination**

Although it has not expressed any intent to do so, Care has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

#### **Note 6. Related-Party Transactions**

The Plan holds investments with State Street Bank and Trust Company. State Street Bank and Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in interest transactions. Fees paid by the Plan to the custodian totaled \$70,832 for the year ended December 31, 2024. The Company also pays certain administrative expenses on behalf of the Plan.

#### **Note 7. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document. However, the Plan Administrator believes the Plan is designed, and is being operated, in conformity with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

#### **Note 9. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Mutual funds:** Mutual funds are reported at fair value based on the quoted market price of the fund, which represents the net asset value of shares held by the Plan at year-end. The fair value of mutual funds is classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
