**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of The Heritage Foundation Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Heritage Foundation Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**Note 1: The Plan and its significant accounting policies:**

The following description of The Heritage Foundation (the Foundation) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established January 1, 1989 by the Foundation to provide benefits to eligible employees. Prior to January 1, 2022, the Plan covered all employees of the Foundation who had reached age 21 and completed 1,000 hours of service in a twelve-month period. Eligible participants entered the Plan the day all eligibility requirements were satisfied. Effective January 1, 2022, the Plan adopted a restated Plan document and adoption agreement. Per this restated Plan document and adoption agreement, the Plan now covers all employees of the Foundation, except for temporary employees and interns, who have reached age 21 and completed 500 hours of service in a six-month period. Eligible participants now enter the Plan the first of the month following when eligibility requirements are met. For purposes of allocating employer contributions, Plan participants were divided into 7 demographic groups in 2024 and 2023. During 2010, the Plan was amended to allow employees of Heritage Action for America to participate in the Plan. During 2024, the Plan was amended to allow employees of The Daily Signal Institute to participate in the Plan. The Plan is subject to the provisions of ERISA.

**Basis of accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Administration** - Under the terms of the Plan, a group of designated officers of the Foundation act as trustees. A third-party administrator processes and maintains the records of participant data. The Foundation has contracted with Charles Schwab Trust Bank (Charles Schwab) to act as custodian. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Foundation. Expenses that are paid by the Foundation are excluded from these financial statements. Fees related to administrative services, investment management services, as well as fees related to the administration of distributions, which are charged directly to the participants' accounts, are included in administrative expenses.

**Investment valuation and income recognition** - Investments of the Plan are held by Charles Schwab and are invested solely based upon instructions received from participants. Plan assets are stated at fair value as of the last day of the Plan year, as reported by Charles Schwab. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

**Investment valuation and income recognition** (continued) - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits** - Benefits are recorded when paid.

**Income taxes** - The Plan is a volume submitter plan sponsored by MAP Retirement (formerly Gorrellick, Tievy & Associates, Inc.). The Plan obtained its most recent determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since then; however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties** - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Plan assets may have decreased in value since December 31, 2024 due to normal market fluctuations.

**Adoption of new accounting policy** - On January 1, 2024, the Plan adopted ASU 2016-13 *Financial Instruments – Credit Losses (topic 326): Measurement of Credit Losses on Financial Instruments*, as amended, which replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The measurement of expected credit losses under CECL methodology is applicable to financial assets measured at amortized costs, including contribution receivables and held-to-maturity debt securities. The Plan adopted ASC 326 using the modified method for all financial assets measured at amortized costs. The Plan has analyzed its financial assets and deemed that no adjustment is necessary. Therefore, net assets available for benefits and changes in net assets available for benefits are unchanged due to the adoption of this new standard. The Plan will continue to analyze its financial assets for expected credit loss under this new standard.

**Note 2: Participation and benefits:**

**Participant contributions** - Employee deferrals are not permitted by the Plan. Prior to January 1, 2022, participants were allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions were deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions. Effective January 1, 2022, rollovers were no longer permitted by the Plan.

**Employer contributions** - The Plan is a profit sharing plan; however, there is no requirement that the Foundation have profits in order to make a contribution to the Plan. Contributions are discretionary and are made in the amount approved by the Board of Trustees of the Foundation. The amount contributed by the Foundation for any Plan year cannot exceed 25% of all of the eligible employees' compensation paid during the Plan year. The contribution is allocated on an integrated basis to those participants who have at least 1 hour of service during the Plan year. An additional allocation is determined separately for each group each year based on a cross-tested allocation formula. Additional contributions were allocated to 2 of the designated 7 groups in 2024 and 3 of the designated 7 groups in 2023.

**Participant accounts** - Each participant's account is credited with the Plan earnings or losses, administrative expenses, and the allocation of the Foundation's contribution. Allocation of the Foundation's discretionary profit sharing contribution is based on participants' compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Prior to January 1, 2022, participants were immediately vested in their rollover contributions and related earnings. Participants vest ratably and are fully vested in the employer's contributions and related earnings allocated to their account after five years of credited service.

**Forfeited accounts** - The Foundation's actual contribution may be reduced by certain available forfeitures, if any, during the Plan year. Forfeited nonvested accounts used to reduce the employer contribution for Plan years ended December 31, 2024 and 2023 were \$113,054 and \$36,060, respectively. There were no forfeitures available to offset future employer contributions at December 31, 2024 and 2023.

**Payment of benefits** - Upon termination of service due to death, disability, retirement, or other reasons, the participant or beneficiary can elect to immediately receive the benefits in a lump sum amount equal to the value of the participant's vested interest in his or her account or defer the benefits until reaching normal retirement age. The Plan allows for an automatic lump sum distribution to an individual retirement account established by the trustee in the name of the participant for participant vested account balances which do not exceed \$5,000.

**Note 3: Certified information:**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the years ended December 31, 2024 and 2023, was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab, the custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. In addition, the information in the Form 5500 Supplemental Attachment to Schedule H has been certified by Charles Schwab as of December 31, 2024.

**Note 4: Fair value measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Mutual funds* - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Foundation intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate and/or modify the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
