Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Portledge School Retirement Plan RA (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

1. Description of Plan

The following description of the Portledge School Retirement Plan RA (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

General

The Portledge School Retirement Plan RA was initially effective January 1, 1968. The Plan covers substantially all eligible employees of the Portledge School (the "School" or "Employer"). Excluded employees include non-resident aliens, student employees, employees who are eligible to participate in another plan of the Employer which is a 401(k) plan or 403(b) plan and collective bargaining employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2024, the Portledge School TDA Plan merged into the Portledge School Retirement Plan RA .

Contributions

Participants may voluntarily contribute up to the Internal Revenue Service ("IRS") maximum allowable amount of their pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants who have completed 15 years of service with the School are eligible to defer additional participant contributions.

For purposes of Employer matching contributions, a participant with less than or equal to 20 years of service will receive a matching contribution equal to 100% of a participant's elective deferral, provided the participant's elective deferrals are less than or equal to 5% of eligible compensation. Participants with more than 20 years of service will receive a matching contribution of 7.5% of eligible compensation, provided the participant's elective deferrals equal or exceed 2.5% of the participant's eligible compensation. Participants with more than 25 years of service will receive a matching contribution of 10% of eligible compensation.

Vesting

A participant is 100% vested in their accounts including allocated earnings thereon at all times.

Participant Accounts

Each participant's account is credited with the participant's contribution, the School's contribution, and Plan earnings (losses), and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. All investments of the Plan are participant directed.

Payment of Benefits

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Participants may take a loan subject to the Internal Revenue Code ("IRC") limits on the total amount that can be borrowed. The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The TIAA Traditional Annuity Account is an unallocated contract. The fully benefit responsive contracts are carried at contract value and the non benefit responsive contracts are carried at fair value, which approximates their contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). The fair value is derived from a discounted cash flow analysis and other factors. Investments in registered investment companies are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. The pooled separate account is valued at the NAV of units held by the Plan. The NAV, as provided by Teachers Insurance and Annuity Association of America and College Retirement Equities Fund ("TIAA and CREF"), is used as a practical expedient to estimate fair value. The NAV based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Investment Valuation and Income Recognition (continued)

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and a distributable event occurs (retirement, termination, death), the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 25, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, qualified institutions.

TIAA has been authorized by TIAA Trust, N.A., to certify the investments and investment information for which TIAA Trust, N.A. is the directed trustee and custodian.

TIAA Traditional Annuity Account

The TIAA Traditional Annuity is comprised of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity (“GSRA”), the Supplemental Retirement Annuity (“SRA”), and the Retirement Choice Plus (“RCP”) contracts. The non benefit responsive contracts are: the Group Retirement Annuity (“GRA”), Retirement Annuity (“RA”) and Retirement Choice (“RC”) contracts. The Plan utilizes the GRA, RA and RC contracts, which are reported at fair value and the GSRA, SRA and RCP contracts which are reported at contract value. Unobservable inputs include the risk-adjusted discount rate applied and the range of significant input values are as follows at December 31, 2024: GSRA – 4.50%-4.75%; SRA – 4.50%-4.75%; RCP – 4.75%-5.00%; GRA – 5.25%-5.50%; RA – 5.25%-5.50%; and RC – 5.50%-5.75% and at December 31, 2023: RCP – 3.50%-6.25%; GRA – 4.00%-6.75%; RA – 4.00%-6.75%; and RC – 4.25%-7.00%.

Under GSRA and SRA contracts, lump sum withdrawals and transfers can be done at any time without any restrictions or charges. Under RCP contracts, lump sum withdrawals and transfers are allowed at any time without any surrender charges. Certain RCP contracts impose a 90-day equity wash rule. Under GRA contracts, lump sum withdrawals are available only within 120 days after termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers must be paid in ten annual installments. Under RA contracts, lump sum withdrawals are not permitted and all withdrawals and transfers must be paid in ten annual installments. Under RC contracts, lump sum withdrawals are only available within 120 days after termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers must be paid in 84 monthly installments (7 years).

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in-rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

The TIAA Traditional Annuity represents approximately 24% and 26% of the Plan’s net assets available for benefits as of December 31, 2024 and 2023, and represents an obligation from TIAA to repay as amounts come due.

TIAA Real Estate

The TIAA Real Estate Account generally invests in real estate properties and real estate-related investments. The TIAA Real Estate Account’s value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional’s opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. While redemptions from the TIAA Real Estate Account may occur daily, transfers out are limited to one per calendar quarter. As of December 31, 2024 and 2023, there are no unfunded commitments.

5. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

6. Tax Status

The School has adopted a restated prototype plan document effective January 1, 2024 which is intended to satisfy the Internal Revenue Service's final 403(b) regulations. The prototype plan document preparer received an opinion letter dated August 7, 2017 from the Internal Revenue Service. Although the Plan has been amended, the School believes that the Plan is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

The plan administrator has identified Plan document errors that required the submission of the Voluntary Compliance Program ("VCP") application to the IRS under the Employee Plans Compliance Resolution System ("EPCRS"). The Plan has completed the VCP application which was submitted in February of 2022. The proposed correction methodology will not impact any participant's benefit in the Plan.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

Certain investments of the Plan are managed by TIAA, the record-keeper and a custodian, and CREF, a custodian. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

The Plan and TIAA and CREF entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Plan created the Revenue Credit Account under the Plan. The Revenue Credit Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$12,835 and \$1,571 at December 31, 2024 and 2023. During 2024, no amounts were used to pay Plan expenses and no amounts were allocated to participants from the Revenue Credit Account.

8. Prohibited Transactions

During 2024 and prior, the School failed to remit to the Plan certain participants' contributions totaling \$30,704 and \$287,744 within the period prescribed by the Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight and the School has calculated and remitted lost earnings to the affected participants in 2025.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
