## INDEPENDENT AUDITORS' REPORT

The Plan Administrator

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Miller & Martin Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

*Other Matter - Supplemental Schedule Required by ERISA*

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### (1) Description of plan

The following description of the Miller & Martin Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan which was adopted on February 1, 1974, to provide retirement benefits for employees of Miller & Martin PLLC (the "Plan Sponsor"). The Plan covers substantially all non-excluded employees who have completed six months of service (participants). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### (b) Contributions

Participants may contribute the maximum allowable amount under Section 401(k) of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In order to participate in the employee deferral contributions and the Plan Sponsor matching contributions, employees must make a minimum contribution of 1% of compensation. Participant contributions are permitted up to 80% of compensation.

The Plan Sponsor matched an amount equal to 100% of each participant's contributions up to 2% of each participant's compensation in 2024 and 2023. The Plan excludes a certain group of participants from the matching and discretionary nonelective contribution portions. In addition, the Plan Sponsor will provide notice to participants annually with respect to its intention to make a safe harbor contribution of 3% of each eligible participant's compensation. No eligible participants are excluded from the safe harbor contribution. Safe harbor contributions were made for 2024 and 2023.

The Plan also provides that the Plan Sponsor may make a discretionary nonelective contribution each year of an amount authorized by the Plan Sponsor for eligible participants with two or more years of service who were employed on the last day of the plan year; however, an annual discretionary nonelective contribution by the Plan Sponsor is not required. For the years ended December 31, 2024 and 2023, the Plan Sponsor made a discretionary nonelective contribution of 2.5% of each eligible participant's compensation.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions and allocations of Plan Sponsor contributions, investment earnings, and administrative expenses allocable to such participants. Allocations are based on participant compensation or account balances as defined in the plan agreement.

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers a money market fund, various mutual funds, self-directed brokerage accounts, and a common collective trust fund as investment options for participants.

(d) Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Participants are also immediately vested in the Plan Sponsor's safe harbor, matching, and discretionary nonelective contributions.

(e) Notes receivable from participants

Each participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her account balance. A participant may have no more than two notes outstanding at a time. The notes are secured by the balances in the respective participants' accounts and bear interest at a fixed rate of Prime plus 1%, which is commensurate with local prevailing rates as determined by the plan administrator. Interest rates on outstanding notes at December 31, 2024, range from 4.25% to 9.50%. Principal and interest are generally collected through payroll deductions.

(f) Payment of benefits

On termination of service, a participant may elect to receive a cash lump-sum payment, installments over a specified period equal to his or her entire account, or partial withdrawals.

For all active or terminated employees age 55 and older, with 10 or more years of service, in-service withdrawals (\$1,000 minimum) may be taken from the Plan.

**(g) Revenue sharing**

Fidelity Management Trust Company ("Fidelity") provides certain administrative services to the Plan pursuant to a service agreement between Fidelity and the Plan Sponsor. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such mutual fund service providers exceeds the amounts owed under the service agreement, Fidelity remits the excess to the Plan on a quarterly basis. Such amounts are allocated to the accounts of eligible Plan participants. Revenue sharing is included as other income in the statements of changes in net assets available for benefits.

**(h) Administrative expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Recordkeeping and other investment advisory fees are charged directly to the participants' accounts and are included in administrative expenses. Investment management fees are included in net appreciation in fair value of investments as they are paid through revenue sharing, rather than a direct payment from the Plan.

**(i) Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**(2) Summary of significant accounting policies**

**(a) Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**(b) Investment valuation and income recognition**

The investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of investment valuation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Reclassifications

Certain items in the 2023 financial statements have been reclassified to conform to the presentation of the 2024 financial statements. These reclassifications had no effect on net assets available for benefits as previously reported.

(g) Events occurring after reporting date

The Plan's management has evaluated events and transactions that occurred between December 31, 2024, and September 16, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to non interest-bearing cash, investments, and notes receivable from participants presented and disclosed in the accompanying financial statements and supplemental schedule, including the fair value of investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity.

### (4) Fair value measurements

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for asset measurement at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- (i) *Money market fund and mutual funds*: Valued at the net asset value (NAV) of shares held by the Plan at year-end in an active market.
- (ii) *Self-directed brokerage accounts*: Comprised of certificates of deposit, common stock, mutual funds, corporate bonds and other publicly traded investments. Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (5) Income tax status

The Plan Sponsor adopted a pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the pre-approved volume submitter plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan as amended, is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (6) Related party and party-in interest transactions

Certain plan investments are managed by Fidelity Investments, an affiliate of Fidelity, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and holds notes receivable from participants which also qualify as party-in-interest transactions.

As described in Note 1, the Plan includes a revenue-sharing arrangement under which Fidelity returns a portion of the fees it receives from certain investment funds. These amounts are then allocated to participants' accounts in proportion to their individual investments in the respective revenue-generating funds. The revenue sharing transactions are considered exempt party-in-interest transactions.
