### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Farmers & Merchants Bank 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Farmers & Merchants Bank 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

## **Basis for Opinion**

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**


Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Note 1 – Description of Plan**

---

The following brief description of The Farmers & Merchants Bank 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete description of the Plan’s provisions.

*General*

The Plan is a profit-sharing plan with 401(k) provisions established for the benefit of employees of Farmers & Merchants Bank, Inc. (the “Bank”) who have attained age 21 and have at least six months of service as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Participants may contribute a portion of their eligible compensation as pre-tax or Roth deferrals, as defined by the Plan document, subject to *Internal Revenue Code (IRC)* limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Newly hired participants are subject to automatic enrollment into the Plan at a 4% pre-tax enrollment rate, unless the participant affirmatively elects otherwise. The Plan includes a provision wherein participants’ deferrals are automatically increased by 1% each year up to a maximum of 10% of compensation.

The Bank matches 100% of the first 4% of compensation a participant contributes to the Plan. Additional nonelective amounts may be contributed at the discretion of the Bank’s board of directors. There were no discretionary nonelective contributions for the year ended December 31, 2024. Participants direct the investment of their contributions, matching, and any discretionary contributions into various investment options offered by the Plan. Contributions are subject to various limitations.

*Participant Accounts*

Each participant’s account is credited with the participant’s contributions and the Bank’s contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in the Bank’s safe harbor matching and discretionary nonelective contributions portion of their account plus actual earnings thereon based on years of service. A participant is 100% vested in the Bank’s contributions after six years of credited service, as defined. The Bank’s matching contributions that were merged into this Plan from the Carroll Community Bank 401(k) Profit Sharing Plan on January 1, 2022, plus actual earnings thereon are based on years of service, where a participant is 100% vested in these contribution after three years of credited service, as defined.

#### *Notes from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms range up to five years. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. These rates ranged from 3.25% to 8.50% on loans outstanding at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

#### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution of their vested interest in his or her account, as defined. The Plan allows in-service withdrawals at age 59½. Mandatory distributions are required for vested balances of \$5,000 or less when a participant separates from service.

Effective January 1, 2024, the Plan adopted the SECURE Act 2.0 provision to raise the threshold for mandatory distributions, where vested balances of \$7,000 or less are subject to automatic rollover out of the Plan.

#### *Forfeitures*

Forfeitures may be used to pay Plan expenses or reduce the Bank's contributions. Forfeited nonvested accounts totaled \$128 and \$2 at December 31, 2024 and 2023, respectively. During 2024, forfeitures of \$64 were used to reduce the Bank's contributions. No forfeitures were used to pay Plan expenses.

## **Note 2 – Summary of Significant Accounting Policies**

---

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### *Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) require the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### *Valuation of Investments and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could

materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

*Benefit Payments*

Benefit payments are recorded when paid.

*Administrative Expenses*

Administrative expenses incurred by the Plan are paid by the Plan. Plan fees related to investment transactions are paid by the Plan and netted with investment income.

*Subsequent Events*

Subsequent events have been evaluated through August 25, 2025, the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used only when Level 1 inputs were not available.

#### *Level 1 Fair Value Measurements*

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

#### *Level 2 Fair Value Measurements*

The fair values of the fixed account are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. The fixed account invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While underlying asset values are quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are included in the computation of the NAV and are realized by the participant upon withdrawal.

At December 31, 2024 and 2023, the Plan had investments in the Empower Investments Fixed Account. Included in this fund are certain guaranteed investment contracts. These contracts are considered to be benefit-responsive and are required to be stated at fair value. The average yields for the fixed account for 2024 and 2023 were approximately 1.70% and 1.55%, respectively. The yields earned by the fund with an adjustment to reflect the actual interest rate credited to participants at December 31, 2024 and 2023 were 1.68% and 1.58%, respectively. The percentage of contributions allocated to this fund is determined by the participants.

**Note 5 – Related Party Transactions**

---

Certain administrative functions are performed by officers or employees of the Bank. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds held by Empower Trust Company (“Empower”). Empower provides certain administrative services to the Plan subject to a Recordkeeping Service Agreement between the Bank and Empower. Investments in funds issued and managed by Empower are considered related party transactions. Fees paid to Empower for the 2024 Plan year were \$26,550.

---

**Note 6 – Plan Termination**

---

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

---

**Note 7 – Tax Status**

---

The Plan was restated to a non-standardized pre-approved profit-sharing/money purchase/CODA document sponsored by Great-West Trust Company, LLC effective January 1, 2022. The Plan has received an opinion letter from the Internal Revenue Service dated November 14, 2022, stating that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
