of Forward Solutions 401(k) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed the audit of the financial statements of Forward Solutions 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). ## Notes to Financial Statements

December 31, 2024 and 2023

### (1) **Description of Plan**

The following description of Forward Solutions 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

#### (a) **General**

The Plan is a defined contribution plan sponsored by I&I Sales Group LLC dba Forward Solutions (the “Company”) for the benefit of its employees who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Empower Trust Company, LLC and Empower Retirement, LLC serve as trustee and recordkeeper for the Plan, respectively.

#### (b) **Contributions**

Each year, participants may contribute up to the maximum amount of annual compensation allowable by law as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Company contributes a safe harbor matching contribution equal to 100% of the first 4% of eligible compensation that a participant contributes to the Plan. Additional matching contributions not to exceed 6% of participants’ eligible compensation may be contributed at the option of the Company. The Company elected not to make additional matching contributions for the year ended December 31, 2024. Also, at the option of the Company, additional nonelective amounts may be contributed to participants employed with the Company on the last day of the plan year. The Company elected not to make a nonelective contribution for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

#### (c) **Participant Investment Account Options**

The Plan currently offers various mutual funds, common collective trusts and self-directed brokerage accounts as investment options for participants. Each investment options has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

### Notes to Financial Statements – Continued

#### (1) Description of Plan - Continued

##### (d) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company safe harbor matching as well as additional matching contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### (e) Vesting

Participants are immediately vested in their contributions and the Company's safe harbor and additional matching contributions plus actual earnings thereon. Certain prior employer matching and nonelective contributions are subject to a six-year graded vesting schedule.

##### (f) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

##### (g) Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Installment payments are only permitted for participants or beneficiaries who must receive required minimum distributions. Terminated participants with balances below certain thresholds as defined in the Plan are subject to mandatory distributions. The Plan provides for in-service distributions for participants age 59 ½ or older and for hardship withdrawals in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

##### (h) Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,997 and \$22,132, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. During the year ended December 31, 2024, no forfeited nonvested accounts were used.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

#### (2) **Summary of Significant Accounting Policies - Continued**

##### (b) **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### (c) **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### (d) **Contributions**

Contributions from Plan participants and the safe harbor and additional matching contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

##### (e) **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### (f) **Payment of Benefits**

Benefits are recorded when paid.

##### (g) **Administrative Expenses**

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### (3) Information Prepared and Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments, at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### (4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### (4) Fair Value Measurements - Continued

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Valued based on the underlying investments held in the self-directed brokerage accounts. As of December 31, 2024, substantially all of the underlying investments held in self-directed brokerage accounts were mutual funds.

*Common collective trusts:* Valued at the NAV of units of each bank collective trust. The NAVs, as provided by the trustee, are used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### (5) **Party-In-Interest Transactions**

Certain plan investments are self-directed brokerage accounts managed by Empower. Notes receivable from participants are also managed by Empower. Empower is the trustee and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

The Plan made direct payments to the recordkeeper of \$49,438 for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions. The Company pays directly any other fees related to the Plan's operations.

#### (6) **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### (7) **Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (8) **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### (9) **Subsequent Events**

Effective January 1, 2025, the Plan was amended to update the name of the plan sponsor to Forward Solutions, LLC, to exclude post-severance compensation and equity bonuses from eligible compensation, and to change the determination period for safe harbor matching contributions from each payroll period to each plan year.

The Plan has evaluated subsequent events through September 24, 2025, which is the date the financial statements were available to be issued.
