## Report of Independent Auditors

To the Participants and Plan Administrator of

**1. Description of Plan**

The Outrigger Hotels Hawaii Profit Sharing and Retirement Savings Plan (the “Plan”) was initially adopted on January 1, 1967. Participants should refer to the plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Principal provisions of the Plan, as amended, are as follows:

**Plan Administration:**

T. Rowe Price Trust Company (“T. Rowe Price”) is the trustee of the Plan and manages a trust fund for the Plan on behalf of the plan sponsor. T. Rowe Price holds the Plan’s assets, executes investment transactions, and provides administrative services to the Plan. Charles Schwab Trust Company (“Charles Schwab”) is the custodian of the Plan’s Self-Directed Brokerage Account (“SDBA”). Charles Schwab holds the Plan’s assets in the SDBA and executes investment transactions within the SDBA.

**Participation:**

Employees become eligible to make voluntary pre-tax salary reduction contributions on their date of hire and receive employer matching contributions after completing one hour of service.

Employees become eligible to participate in the annual fixed contribution and profit sharing portions of the Plan upon the completion of one year of service, which is a consecutive twelve-month period of employment commencing on the employee’s first day of employment, or any full plan year thereof during which the employee has at least 1,000 hours of service. Employees become eligible to participate upon the completion of the year of service requirement and must be employed as of the last day of the plan year.

**Vesting:**

Employer contributions vest 20% annually with full vesting after five years of service.

Full vesting is provided in the event of a participant’s death or disability.

**Contributions – Employer:**

Profit sharing contributions are discretionary and determined by the Employer’s Retirement Committee, but are limited to the maximum amount deductible for Federal income tax purposes.

The Employer makes annual fixed contributions of 2% of each eligible participant’s pay, subject to a minimum contribution of \$200 and a maximum of \$1,000.

The Employer makes matching contributions of \$0.50 per \$1.00 of participant contributions up to the first 2% of compensation. The maximum matching contribution is generally limited to \$500 per participant per year, with participants employed at certain properties being eligible to receive matching contributions in excess of this amount.

**Contributions – Participants:**

A participant may elect to make salary reduction contributions up to the lower of 100% of eligible compensation, as defined, or the maximum allowed by law. Salary reduction contributions may be withdrawn due to financial hardship or upon attainment of age 59½ with written notice. Participants shall at all times have a 100% non-forfeitable interest in the values of salary reduction and savings accounts.

The Plan maintains an automatic contribution arrangement, whereby eligible or rehired participants are automatically enrolled in the Plan at a contribution percentage of 5% of their eligible pay. Participants may opt out of the automatic contribution arrangement.

**Allocation of Employer Profit Sharing Contributions:**

Employer profit sharing contributions are allocated to participants based upon the relationship of each participant’s number of units (determined from the participant’s compensation and years of service) to the total number of units assigned to all participants.

**Investment of Participants’ Accounts:**

Participants have the exclusive authority to direct investment of their accounts among the Plan’s investments.

**Treatment of Forfeitures:**

There were approximately \$147,000 and \$149,000 in forfeited nonvested accounts as of December 31, 2024 and 2023, respectively. Forfeitures may be used to pay for Plan expenses and reduce the employer contributions.

In 2024 and 2023, \$100,000 of forfeited nonvested accounts were used to reduce employer contributions.

<b>Notes Receivable from Participants:</b>	<p>Subject to the approval of a member of the Employer's Retirement Committee, a participant may borrow from the Plan for financial hardship reasons or if he/she has a specified financial need. The loan amount is limited to the lesser of \$50,000, subject to certain limitations predicated by previous loans to the participant, or 50% of the participant's vested accrued benefits under the Plan. In general, all plan loans must be secured by the vested balance of the participant's account. All plan loans will bear a reasonable rate of interest and be payable evenly not less frequently than quarterly. Participant loans shall generally have a definite maturity date not in excess of five years, unless the loan is used for the purchase of a primary residence, in which case, the loan shall generally have a maturity date not in excess of fifteen years.</p> <p>Participant loans shall generally be deemed to be in default if a scheduled payment is missed and is not received by the end of the calendar quarter subsequent to the calendar quarter in which the missed payment occurred.</p>
<b>Benefit Payments:</b>	<p>Participants may receive their benefit payments in lump sum distributions or partial distributions, as defined by the Plan.</p>
<b>Administrative Expenses:</b>	<p>Administrative expenses not paid by the Employer are paid from the funds of the Plan.</p>
<b>Termination:</b>	<p>Should the Plan terminate, the rights of all participants to benefits accrued to the date of such termination shall become fully vested.</p>

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statements of changes in net assets available for benefits.

#### **Fair Value Measurements**

For financial and nonfinancial assets and liabilities reported at fair value, the Plan defines fair value as the price that would be received to sell an asset or paid to transfer a liability in the principal or most advantageous market for an asset or liability in an orderly transaction between market participants at the measurement date. The Plan measures fair value using observable and unobservable inputs based on the following hierarchy:

- **Level 1** – Quoted prices (unadjusted) in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.
- **Level 2** – Inputs other than quoted market prices included within Level 1 that are observable for an asset or liability, either directly or indirectly.
- **Level 3** – Unobservable inputs for an asset or liability reflecting the reporting entity’s own assumptions. Level 3 inputs should be used to measure fair value to the extent that observable Level 1 or Level 2 inputs are not available.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### **Fair Value of Financial Instruments and Investments**

The following methods and assumptions were used by the Plan in estimating the fair value of its investments and other financial instruments:

- **Mutual funds** – The fair value of mutual funds is based on quoted market prices which represent the net asset values of shares held by the Plan at the plan year-end and is generally categorized as Level 1 in the fair value hierarchy.
- **Self-directed brokerage account** – The self-directed brokerage account consists of interest bearing cash, common stock, and exchange traded funds that are stated at fair value based on quoted market prices. The self-directed brokerage account is generally categorized in Level 1 of the fair value hierarchy.
- **Loans to participants** – The fair value of loans receivable from participants was estimated using a discounted cash flow analysis utilizing interest rates currently offered for new participant loans and approximated its carrying value.

The underlying investments of the Plan’s stable value common trust fund maintained with T. Rowe Price include guaranteed investment contracts issued by insurance companies, investment contracts issued by banks, synthetic investment contracts (“SICs”) issued by banks, insurance companies, and other issuers (collectively, investment contracts) and securities supporting such SICs, and other similar instruments which are intended to maintain a constant net asset value while permitting participant-initiated benefit-responsive withdrawals for certain events. The Plan’s underlying investment in the stable value common trust fund qualifies as a fully benefit-responsive investment contract.

The underlying investments of the Plan’s common trust funds are primarily comprised of equity securities. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the

collective trust, the issuer reserves the right to require 30 days notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The net asset value is used as a practical expedient to estimate fair value of the Plan's stable value common trust fund maintained with T. Rowe Price and the common trust funds maintained with Northern Trust and T. Rowe Price. This practical expedient would not be used if it is determined to be probable that the funds would sell the investments for an amount different from the reported net asset value.

In accordance with the policy of stating investments at fair value, the Plan presents in the statements of changes in net assets available for benefits, the net appreciation in the fair value of its investments that consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of Benefits**

Benefits are recorded when paid. There were approximately \$150,000 in benefits paid in 2025 to participants who elected to withdraw funds in 2024. There were no benefits paid in 2024 to participants who elected to withdraw funds in 2023.

**Subsequent Events**

The Plan has reviewed all events that have occurred from January 1, 2025 through September 19, 2025, the date that the financial statements were available for issuance, for proper accounting and disclosure in the financial statements.

**3. Investments**

The Plan Administrator continued to elect the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained a certification from T. Rowe Price, the trustee of the Plan, and Charles Schwab, the custodian of the Plan's Self-Directed Brokerage Account, that all of the following information provided by the trustee and custodian are complete and accurate as of December 31, 2024 and 2023 and for the years then ended:

- All information related to investment balances and notes receivable from participants presented in the statements of net assets available for benefits.
- Investment income, including net appreciation in value of investments and dividend and interest income, and interest income on notes receivable from participants presented in the statements of changes in net assets available for benefits.
- All information presented in the supplemental schedule.

**5. Notes Receivable from Participants**

Notes receivable from participants as of December 31, 2024 and 2023 of approximately \$2,959,000 and \$2,575,000, respectively, were comprised of amounts due in monthly installments at interest rates ranging from 4.25% to 9.50%, due at various dates through April 2038. Principal and interest are paid ratably through payroll deductions.

**6. Tax Status**

The Plan obtained its latest determination letter on October 19, 2016, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**7. Related-Party Transactions**

Certain plan investments represent shares of investment funds managed by T. Rowe Price and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to T. Rowe Price for administrative services approximated \$206,000 and \$166,000 in 2024 and 2023, respectively. There were no amounts owed to T. Rowe Price as of December 31, 2024 and 2023.
