1. Description of Plan

The following description of The Sterno Group Companies, LLC 401 (k) Profit Sharing and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1997, as a defined contribution plan covering all employees of The Sterno Group Companies, LLC (the "Company" or "Sponsor") who are age 18 or older, excluding collectively bargained employees, non-resident aliens and residents of Puerto Rico. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Company is the Plan Sponsor and Plan Administrator. The Company is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Eligibility

Any employee who is eighteen (18) years of age is eligible to become a participant in the Plan on the first day of the Plan year coinciding with or the next following date he or she completes 1,000 hours of service. Eligibility conditions for nonelective contributions includes one (1) year of service and 1,000 hours.

Employee Salary Reduction Election

A participant may elect to defer up to ninety-two percent (92%) of his or her compensation each year instead of receiving that amount in cash. However, total deferred compensation may not exceed the limits set by Internal Revenue Code ("IRC") Sections 401(k), 404, and 415. In addition, participants who are age fifty (50) or over before the close of the plan year are eligible to make catch-up contributions subject to the limitation imposed by the IRC.

Contributions

Automatic Deferrals

The Plan contains an automatic deferral provision. Newly eligible employees are automatically enrolled at an initial deferral rate of 2% of compensation. For participants with a deferral rate greater than zero, the automatic deferral percentage will increase by 1% per year up to a maximum of 5% of compensation. The employee may choose to opt out, select a different deferral rate or select different investment options at any time.

Contributions (continued)

Elective Contributions

The Company must contribute the amount of the total employee salary reduction elections of all participants made during the plan year. The Company must pay elective contributions to the Plan's trustee as soon as they can be segregated from its general assets, but no later than the fifteenth (15th) business day after the month of receipt of the voluntary contribution. There are two types of elective deferrals for the Plan: pre-tax deferrals and Roth deferrals.

Employer Safe Harbor Matching Contributions

The Company makes a safe harbor matching contribution equal to 100% of your salary deferrals that do not exceed 3% of your compensation plus 50% of your salary deferrals between 3% and 5% of your compensation. This safe harbor matching contribution is 100% vested.

Employer Nonelective Contributions

The Company may make a discretionary matching contribution in an amount to be determined by the Company. The Employer may determine a separate discretionary matching contribution for participants working in different business units or locations. The employer nonelective contributions are not immediately fully vested and are subjected to a 6-year graded vesting schedule described below under Vesting section.

Rollover Contributions

The Plan may accept a rollover contribution on behalf of all participants as well as any employee, regardless whether such employee has met the age and service requirements of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions (continued)

Vesting

Participants are immediately fully vested in their elective contributions plus actual earnings thereon. Vesting in the employer nonelective contributions portion of their accounts plus earnings thereon is based on years of continuous services. The vesting for the Company account is as follows:

Forfeited Accounts

At December 31, 2024 and 2023, there were \$1,446 and \$1,425 available, respectively. During 2024, no forfeitures were used to offset employer contributions or reduce Plan expenses.

Distribution of Benefits

Upon Retirement

Distributions may be made to a participant who has not separated from service when he or she attains age fifty-nine and one-half (59 ½). Payment may be in the form of a lump-sum distribution or partial withdraw.

Upon Termination of Employment

A participant may elect to have his or her account balance distributed as soon as administratively feasible following termination of employment. If the value of the vested account balance does not exceed \$1,000, then a distribution will be made in cash. However, if the value of the vested account balance is more than \$1,000 but less than \$5,000, he or she may elect to receive distribution in cash or to roll over to an IRA or a qualified plan of his or her new employer.

Hardship Distributions

A participant may withdraw pre-tax deferrals, including any earnings, in the event of a financial hardship, provided certain conditions are met. The minimum withdrawal amount is \$500 minimum. Hardship distributions can only be made from the vested portion of the elective deferral, Roth contribution, matching contribution and profit-sharing contribution accounts.

Upon Disability

A participant's account is distributable upon a participant's disability. Payment may be in the form of a lump-sum distribution or partial withdrawal.

Distribution of Benefits (continued)

Upon Death

Upon the death of a participant, a distribution of the vested account balance be made to his or her designated beneficiary in a single lump-sum payment.

Administrative Fees

Distribution and loan fees are charged directly to the requesting participant's account. The Company absorbs the majority of all other administrative fees of the Plan. If expenses paid by the Plan are allocated to participants, expenses are either proportionately based on the value of the account balances or as an equal dollar amount based on the number of the participants in the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct all of his or her accounts to a variety of investments. Participant's accounts are segregated for purpose of determining the earnings or losses on their investment options.

Notes Receivable from Participants

Participants may borrow from his or her account with a maximum loan amount not to exceed the lesser of (a) \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one-year period or (b) one-half ($\frac{1}{2}$) of a participant's vested account balance. A participant may only have one (1) loan outstanding at any time. Principal and interest are repaid by payroll deductions from each regular paycheck. Loans are secured by the balance in the participant's account and bear an interest rate currently being charged on similar commercial loans by persons in the business of lending money.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

2. Summary of Significant Accounting Policies

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds

Share Prices/Net Asset Values (NAVs) reported on the financial statements for NAV mutual funds are generally obtained from a file feed from the National Securities Clearing Corporation, and/or directly from the fund house, or a secondary pricing source, such as Interactive Data Corporation (IDC).

Fixed Annuities

The reported values for fixed annuity options are reported daily. Based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

4. Information Prepared and Certified by Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America (“Empower”), a qualified institution, has certified the following investments and notes receivable information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants information included in the accompanying Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Related-Party Transactions and Party in Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$26,594 of recordkeeping fees to Empower, and \$41,110 of advisory fees (net with appreciation in fair value of investments) to Creative Planning, LLC during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Tax Status

The IRS has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Company and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
