**1. Summary of Significant Accounting Policies**

Basis of Accounting – The financial statements of The Lead Group of Companies 401(k) Plan (the Plan) are prepared under the accrual method of accounting.

Investments – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Contributions – Contributions from plan participants and the matching contribution from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses – Administrative expenses in the amount of \$78,301 are shown on the Statement of Changes in Net Assets Available for Benefits. This amount represents administrative costs paid to third-party service providers for administration, recordkeeping, and financial advisory services. The employer absorbs substantially all other costs of the Plan.

Risk and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least probable that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statement of net assets available for benefits.

Subsequent Events – The Plan has evaluated events and transactions that occurred through September 4, 2025, which is the date the financial statements were available for issue.

**2. Plan Description**

The following description of The Lead Group of Companies 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**2. Plan Description (Continued)**

General – Effective July 1, 1984, The Lead Group of Companies, Inc., adopted the defined contribution plan covering substantially all employees. The following employers are included in The Lead Group of Companies 401(k) Plan: Resource Technology Corporation d/b/a The Lead Group of Companies, Inc., Consolidated Chemical Corporation d/b/a Tri-Chem, Alkuhme Corporation (previously named Superior Manufacturing Corporation), MEC Personnel Consultants, Inc., and Rooted People Solutions LLC (collectively the Company or employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Employees of the Company who have attained 18 years of age are eligible to participate in the Plan.

Contributions – Contributions to participants' accounts may be made through voluntary reductions in their compensation, rollover contributions from other qualified plans, as well as discretionary matching contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in designated funds until changed by the participant. Employees participating in the Plan may contribute up to 100% of their before-tax compensation up to the limit in effect for the year (\$23,000 in 2024). Participants aged fifty or older may make an additional "catch-up" contribution (\$7,500 for 2024).

For the year 2024, the employer contributed an amount equal to 100% of the participant's contribution up to 1% of compensation with an annual cap of \$104 per participant. A discretionary amount, as determined by the Companies each year, may be contributed at the option of the Board of Directors. No additional discretionary contribution was made for the year ended December 31, 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the (a) employer's contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions are invested based on participant-directed investment programs.

Investment Options – Participants' accounts are self-directed within a limited number of investment options. Participants may change their investment elections at their discretion.

Vesting – Participants are 100% vested in their accounts at all times.

Payment of Benefits – Participants or their beneficiaries may receive distributions of their account balances in a lump sum upon the earlier of reaching age 59-1/2, disability, death, or termination of service, as defined in the Plan. Installment distributions are available to those employees who reach Normal Retirement Age, as defined in the Plan. Further, the trustee may permit a participant who experiences a qualified financial hardship, as defined by the Plan, to receive a distribution of all or a portion of the participant's elective account balance.

**2. Plan Description (Continued)**

Notes Receivable from Participants – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**3. Related Party and Party-In-Interest Transactions**

Certain Plan investments are managed by Ascensus Trust Company, the trustee, and therefore, these transactions are considered to be party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Certain administrative costs incurred by the Plan are paid by the plan sponsor. The Plan uses the staff, resources, and facilities of the plan sponsor to perform certain administrative activities related to the Plan. These transactions qualify as party-in-interest transactions. Participant notes receivable are classified as both related party and party-in-interest transactions.

**4. Tax Status**

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**5. Termination of the Plan**

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**6. Certification of Financial Information**

The following information included in the accompanying financial statements and supplementary schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan: investments at fair value, notes receivable from participants, interest and dividends, and net appreciation in fair value of investments.

**7. Nonparticipating Participant Account Balances**

Included in the net assets available for benefits at December 31, 2024 and 2023 are balances due to participants who had terminated employment with the employer, as such they are no longer participating. These accounts are payable on request.

**8. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Cash and cash equivalents:* Valued at cost, which is fair market value for cash.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are op-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
