**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

**NOTE A - PLAN DESCRIPTION**

The following description of the BSA Family of Companies (the "Company" or "Plan Sponsor") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan was established on January 15, 2018, with New Energy Transport, Inc. was added as a participating employer. The Company also merged the Midwest Specialized Transportation, Inc. Salary Savings Plan and the Warren Transport, Inc. Retirement Plan into the Plan on March 30, 2018 and April 30, 2018, respectively. However, Midwest Specialized Transportation, Inc. Salary Savings Plan has ceased their participation in the Plan as of September 11, 2024. The investment committee determines the appropriateness of the Plan's investment offers and monitors investment performance. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and is designed to provide employees with additional security for their retirement.

***Eligibility***

All employees who attained age 18 and are not covered by a collective bargaining agreement, nonresident aliens or independent contractors are eligible to participate in the Plan 60 days following an employee's commencement of employment. Plan entry dates are the first day of the month after satisfying the employment eligibility requirement.

***Funding Policy***

Participants may make elective deferral contributions to the Plan in whole increments up to 70% of the participant's eligible compensation, subject to limits in the Plan and established by law. Participants at age 50 are permitted to make catch-up contributions. Participants may also make rollover contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation until changed by the participant. The Plan also implemented an automatic annual 1% increase up to 6%, unless the participant makes a contrary election.

Each year, the Company matches a discretionary amount of each participating employee's contribution up to a certain maximum. The matching contribution was 100% of the first 7.5% of each participating employee's eligible wages with no maximum for the years ended December 31, 2024 and 2023. Participants are eligible for the discretionary match if they are employed on the last day of the Plan year and have 1,000 hours of service during the Plan year.

***Vesting***

Participants have a fully vested interest in their participant elective deferral, catch-up and rollover contributions, plus actual earnings and losses thereon. Employer matching contributions begin vesting at the completion of two years of service and continue to vest on a graduated scale to 100% after four years of service. The Plan also provides 100% vesting upon death, disability and at retirement.

***Participants' Accounts***

Participant accounts are credited with the participant contributions (elective deferral, catch-up, Roth, and rollover) and allocations of the Company's contribution and plan earnings or losses. Allocations are based on the earnings and losses of the participant's investments or participant account balances, as defined. Income and losses is allocated daily based on the number of shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Investment Options***

All investments in the Plan are participant directed and the Plan allows participants to make transfers between fund investments daily.

***Notes Receivable from Participants***

Participants may borrow from their vested fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. No loans in an amount less than \$1,000 will be granted to any participant. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus 2%, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions for active participants. A participant can have a maximum of one loan outstanding at one time from the Plan. The maximum term of a loan is five years, or 15 years if used to purchase a principal residence.

***Benefits Paid to Participants***

On termination of service, due to death, total and permanent disability, termination of employment or retirement, the distribution method depends on the vested account balance. If the vested account balance does not exceed \$1,000, a lump-sum distribution, net of tax will be made. If the vested account balance exceeds \$1,000 but is not more than \$5,000, the balance will be automatically rolled into an IRA if no distribution option is provided by the participant within 90 days of notification of mandatory distribution. If the vested account balance exceeds \$5,000, the participant may elect to keep the vested account balance in the Plan, receive a lump-sum distribution, net of tax, rollover the entire vested portion to a qualified plan, or receive installment payments. Participants are permitted withdrawals from the Plan accounts for financial hardships.

***Forfeitures***

Participating employees not 100% vested in the employer matching contribution will forfeit the non-vested amount upon termination of employment. The Plan Sponsor may use these funds to offset administrative expenses, reduce employer contributions, and for other uses as defined in the Plan agreement. For the years ended December 31, 2024 and 2023, there were no forfeitures utilized in regards to paying administrative expenses, respectively. For the years ended December 31, 2024 and 2023, there were no forfeitures utilized in regards to paying employer match. For the years ended December 31, 2024 and 2023, outstanding forfeiture balances total \$10,700 and \$27,301 respectively.

***Administrative Expenses***

Investment transaction fees and administrative expenses of the trustee are paid for by the Plan. Administrative expenses not covered by the Plan are paid for by the Company.

#### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

##### ***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

##### ***Investment Valuation and Income Recognition***

The Plan's mutual fund investments are carried at fair value based on the net asset value ("NAV") of shares held by the Plan at year end. Collective trusts are valued at the NAV of the shares held at year end as a practical expedient at fair value. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### ***Net Appreciation in Value of Investments***

Net appreciation in the fair value of investments represents the net realized gains and net unrealized appreciation of investments. Realized gains are the difference between the proceeds received and either the cost of the investments sold, determined on an average-cost basis, or the fair value at the end of the previous year, whichever is applicable. Net unrealized appreciation is the change in the difference between fair value and the cost of investments or fair value at the end of the previous year, whichever is applicable.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

##### ***Benefits Paid to Participants***

Benefits are recorded when paid.

##### ***Excess Contributions Payable***

Excess contributions are recorded for refunds payable to participants due to contributions in excess of Internal Revenue Service ("IRS") limitations. Amounts payable to participants for excess contributions are recorded as a liability with a corresponding increase in benefits paid to participants.

#### ***Risk and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **NOTE C - FAIR VALUE MEASUREMENTS**

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued using the NAV as a practical expedient to estimate the fair value the underlying investments held by the Plan at year end. These funds have no significant redemption or unfunded capital restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - TRUSTEE CERTIFICATIONS**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Noninterest-bearing cash, investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE E - INCOME TAX STATUS**

The Plan adopted the Milliman, Inc. Defined Contribution Prototype Plan and Trust ("Prototype Plan"). The Prototype Plan obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service ("IRS") stated that the underlying Prototype Plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been restated since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be

sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F - RELATED PARTIES**

The Company has been designated the Plan Administrator. These services are provided at no expense to the Plan.

Certain assets are invested in funds managed by Matrix Trust Company. Additionally, the Plan issues loans to participants, which are secured by the participant's account balance. These transactions qualify as party-in-interest transactions. Notes receivables from participants also qualify as party-in-interest transactions.

**NOTE G - SUBSEQUENT EVENTS**

The Plan evaluated its financial statements for subsequent events through September 25, 2025, the date the financial statements were available to be issued.

The Plan is not aware of any other subsequent events that would require recognition or disclosure in the financial statements.
