**Scope and Nature of the *ERISA Section 103(a)(3)(C)* Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of the Tom Wood Group 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974 ("ERISA")*, as permitted by *ERISA Section 103(a)(3)(C)*. ### NOTES TO FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF THE PLAN

The following brief description of the Tom Wood Group 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General* – The Plan is a defined contribution profit sharing and salary deferral plan established for the benefit of the employees of Tom Wood, Inc. (the "Plan Sponsor") and related entities who have elected to be a participating employer in the Plan (collectively, the "Company"). Employees become eligible to participate in the Plan on the first day of the month after completion of three months of eligible service and the attainment of age 20 ½. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 ("ERISA")*.

*Administration* – The Plan Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Contributions* – Each year, participants may elect to defer up to 85% of their eligible compensation as a contribution to the Plan. Participants age 50 and older are eligible to make additional catch-up contributions. The Plan also includes an automatic enrollment provision for all eligible employees whereby a pre-tax deferral in the amount of 3% of eligible compensation will be contributed to the Plan unless the employee elects a different percentage or elects to not contribute to the Plan. This percentage will be increased by 1% on the first day of each subsequent Plan year until a maximum of 6% is reached. Participants may also contribute amounts from other qualified plans. Contributions are subject to certain limitations, as established by the Internal Revenue Code ("IRC").

The Company makes a non-elective contribution equal to \$50 per week to the accounts of certain participants employed by participating employers, Richfield Bloomington Honda and Mitsubishi, as defined in the Plan document. These contributions totaled \$190,500 and \$185,400 for the years ended December 31, 2024 and 2023, respectively.

The Company may also make discretionary contributions to the Plan. For the 2024 and 2023 Plan years, the Company made a matching contribution equal to 25% of the first 6% of eligible compensation each participant contributed to the Plan.

*Participant Accounts* – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, Company matching contributions, as well as allocations of the Company's non-elective contributions and Plan earnings, as applicable. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, specific participant transaction costs or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**TOM WOOD GROUP 401(k) PROFIT SHARING PLAN****NOTES TO FINANCIAL STATEMENTS****1. DESCRIPTION OF THE PLAN (continued)**

*Investment Options* – Upon enrollment in the Plan, participants may direct the investment of their accounts into various investment options offered by the Plan. They may change their investment options among those investments provided at any time during the Plan year.

*Notes Receivable from Participants* – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance for hardship purposes as defined by the IRC. Generally, the term of the loan may not exceed five years. However, if the loan is for the purchase of a participant's principal residence, the Plan administrator may permit a longer term. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is repaid ratably through payroll deductions. A participant may only have one outstanding loan at any time.

*Payment of Benefits* – Upon termination of service or attaining normal retirement age, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest or receive a series of installments. In-service and hardship withdrawals are also allowed as defined in the Plan document.

*Vesting* – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant becomes 100% vested after six years of credited service.

*Forfeited Accounts* – The non-vested portion of former participants' accounts may be used to pay administrative expenses of the Plan or reduce the amount of Company contributions. Forfeited accounts totaled \$114,614 and \$83,817 at December 31, 2024 and 2023, respectively. During the Plan years ended December 31, 2024 and 2023, forfeitures totaling \$73,523 and \$67,459 were used to pay administrative expenses of the Plan and \$84,255 and \$39,349 were used to reduce the amount of Company contributions, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Presentation* – The financial statements of the Plan are prepared on the accrual basis of accounting which is in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments are reported at fair value. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

*Investment Management Fees and Operating Expenses* – Investment management fees and operating expenses charged to the Plan for certain investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

*Payment of Benefits* – Benefits are recorded when paid. There were no benefit payments requested and not yet disbursed at December 31, 2024 and 2023.

*Administrative Expenses* – Administrative expenses of the Plan are paid by the Company or the Plan participants, as defined in the Plan document.

**3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION (UNAUDITED)**

The Plan administrator has elected the method of annual reporting compliance permitted by *ERISA Section 103(a)(3)(C)* pursuant to *29 CFR 2520.103-8 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA*. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule.

- Investments at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule of assets, held at end of year as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for investments measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest Bearing Cash, and Cash Equivalents* – Valued at cost which approximates fair value.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price.

*Common Stock* – Valued on the basis of readily determinable market prices in active markets.

*Common/Collective Trust Fund* – Valued at the NAV of units held by the Plan at year end provided by the issuer of the fund. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets owned by the fund, minus its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are currently no other redemption restrictions or unfunded commitments on this investment. Investments valued using NAV as a practical expedient are not reflected in the valuation hierarchy.

**4. FAIR VALUE MEASUREMENTS (CONTINUED)**

The preceding methods described may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative services are provided by the Company at no costs to the Plan and certain administrative costs incurred by the Plan are paid by the Company. The Plan has entered into various service agreements with parties-in-interest.

The Plan pays fees to and invests in cash reserves and mutual funds managed by an affiliate of the trustee. These qualify as party-in-interest transactions. These transactions as well as notes receivable from participants and related activity also qualify as party-in-interest.

#### 6. INCOME TAX STATUS

The Internal Revenue Service (“IRS”) ruled on June 30, 2020, that the pre-approved profit-sharing plan of FMR LLC upon the Plan is based, is designed in accordance with applicable sections of the IRC. The Plan has been amended since receipt of the determination letter. However, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 7. PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of *ERISA*. In the event of Plan termination, participants will become 100% vested in their accounts.

#### 8. RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment securities. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall volatility risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the financial statements.

#### 9. SUBSEQUENT EVENTS

The Plan has evaluated all subsequent events through September 17, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.
