INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Ladder Life 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

1. Description of the Plan

Ladder Financial Inc. (the Company) established the Ladder Life 401(k) Plan (the Plan), effective January 1, 2023, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. A 401(k) committee, comprised of Company employees, is responsible for overseeing the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. Ascensus Trust Company (Ascensus) is the Plan's trustee. Ascensus holds, invests, and reinvests Plan assets in the interest and direction of the participants and their beneficiaries. The Vanguard Group, Inc. (Vanguard) is the record keeper and has outsourced recordkeeping services to Ascensus, LLC. The Company has engaged Sequoia as an investment advisor. Sequoia assists the Plan committee in selecting investment options offered under the Plan and monitoring investment performance.

Eligible Participants:

Eligible employees, as defined by the Plan agreement, may participate in the Plan immediately upon hire.

Contributions:

Participants are permitted to make voluntary pre-tax salary deferrals and Roth post-tax contributions up to 50% of their annual compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), excluding rollovers of after-tax contributions, subject to Code regulations.

The Plan provides for automatic enrollment on the date participants become eligible for the Plan. The automatic pre-tax salary deferral contribution is 4% of eligible compensation, as defined by the Plan agreement, unless participants request a different amount to be contributed or formally decline participation. Participants may adjust the deferral rate or discontinue contributions at any time.

1. Description of the Plan (continued)

Contributions: (continued)

The Company may make discretionary profit sharing and matching contributions in an amount determined by the Company's Board of Directors. Matching contributions are made based on a participant's annual eligible compensation and annual salary deferral contributions. In 2024, the Company made matching contributions of \$732,241 to the Plan, of which \$27,558 was a receivable as of December 31, 2024. These contributions represent 100% of a participant's deferral contributions, up to a maximum of 4% of eligible gross annual compensation.

For matching contributions made, the Plan requires an annual true-up so the aggregate matching contributions made during any given Plan year to reflect an amount equal to the matching contributions had they been computed based on participant year-to-date eligible compensation contributed to the Plan. As of December 31, 2024, true-up matching contributions of \$13,137 were due to participants, which were funded with forfeitures in 2025.

The Company has not made profit sharing contributions through December 31, 2024.

Contributions are subject to certain limitations under the Code.

In-Plan Roth Conversions:

The Plan allows participants who are active employees of the Company to convert any portion of their accounts to Roth balances. There were no conversions to Roth balances in 2024.

Participant Accounts:

Participant accounts are credited with participant contributions, discretionary Company contributions, rollovers and an allocation of Plan net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

1. Description of the Plan (continued)

Vesting:

Participants are fully vested (100%) in their contributions plus actual earnings (less any losses) thereon. Vesting in Company contributions, plus allocated earnings (less any losses) thereon, is based on years of continuous service. Participants become 25% vested in Company contributions after one year of service and are fully vested after four years, or upon retirement, disability, Plan termination, or death.

Forfeitures:

Forfeitures of non-vested Company contributions may be used to reduce future Company contributions or to pay Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$82,757 and \$62,549, respectively. During 2024, forfeitures of \$38,956 were used to reduce employer contributions.

Notes Receivable from Participants:

Participants may borrow up to one-half of their account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to 30 years are permitted. Participant notes are evidenced by a written note, secured by the balance in the participant's account, and bear interest at the prime rate published in The Wall Street Journal, plus 1%. The interest rates on the notes outstanding as of December 31, 2024 ranged from 5.75% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Payment of Benefits:

On termination of service for any reason, benefits are paid to participants in a lump-sum cash distribution equal to the value of the participant accounts, or in partial withdrawals, or regular cash installment payments of their choice. Terminated participant accounts between \$1,000 and \$7,000 may be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Terminated participant accounts below \$1,000 may be distributed directly to participants without participant approval. The Plan agreement also allows for in-service and hardship withdrawals of benefits to current employees. Benefits are recorded when paid.

1. Description of the Plan (continued)

Administrative Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain administrative expenses are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investments:

Investments consist of mutual funds and a money market fund. These funds are reported at fair value, which is the net asset value of shares held by the Plan at year end, as quoted in active markets.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's investments are classified as Level I within the fair value hierarchy as of December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold or held during the year.

3. Information Prepared and Certified by Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, the qualified institution of the Plan, have certified to the completeness and accuracy of the:

- investments, notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Partial Termination

As a result of a reduction in the Company's workforce in 2023, the Plan experienced a partial plan termination, as defined by ERISA. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated because of an action taken by the Company. If a partial plan termination occurs, full vesting in the Company portion of the account balance of the affected participants is required, but the remaining participants' vesting continues to be determined under the Plan agreement.

All affected employees who were participants in the Plan became fully vested in their account balances at the date of the partial plan termination. As a result of the partial plan termination, in 2024, the Plan sponsor reinstated \$164,267 of forfeited non-vested account balances to affected participants.

5. Party-In-Interest Transactions

Certain Plan investments are managed by Vanguard. As Vanguard is the Plan's record keeper, purchases and sales of these investments by the Plan qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Notes to Financial Statements

6. Nonexempt Prohibited Transactions

In 2023, the Plan sponsor did not remit certain participant contributions and note repayments of \$1,107,301 timely, as required by the Department of Labor (DOL). In 2024, the Plan sponsor did not remit certain participant contributions and note repayments of \$538,665 timely, as required by the DOL. The Company remitted estimated lost earnings to the Plan in 2024 to correct these delinquent remittances.

These late remittances are considered nonexempt prohibited party-in-interest transactions by the DOL, which would jeopardize the Plan's tax-exempt status.

7. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is subject to income tax examinations since Plan inception.

8. Subsequent Events:

Subsequent events have been evaluated through September 18, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
