## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Owen Equipment 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institutions), provided that the investment information is prepared and certified by the qualified institutions in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**NOTE 1 – PLAN DESCRIPTION**

The following brief description of the Owen Equipment 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of Ben-Ko-Matic Co. dba Owen Equipment Co., Legacy Equipment Company, Owen Equipment Sales, Blaze Equipment Rental, LLC, Cal-Line Equipment, Inc., Cal-Line Northwest, LLC, and Reliance Environmental Truck Sales, LLC (collectively, the Company), who meet the eligibility requirements, with the exception of union employees and nonresident aliens. Prior to May 1, 2024, employees were eligible to participate in the Plan on the first entry date after attaining 20½ years of age. Effective May 1, 2024, employees are eligible to participate in the Plan on the first entry date after attaining 18 years of age. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendments** - Effective May 1, 2024, the Plan was amended and a new trustee and recordkeeper was appointed. On that same date the Plan document was amended to add an automatic enrollment provision and changes to vesting as described below. Effective July 1, 2024, the Plan was also amended to add Reliance Environmental Truck Sales, LLC as a participating employer.

**Contributions** - Contributions consist of employee elective deferrals, Roth elective deferrals, and employer discretionary matching contributions. Employee elective deferrals and employer matching are recorded in the year in which the contributions are withheld from compensation. Employees may voluntarily contribute up to 100% of their compensation, limited to \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and over could elect to make additional catch-up contributions of up to \$7,500 annually. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Effective May 1, 2024, the Plan includes an automatic enrollment provision whereby newly eligible employees who do not affirmatively make a deferral election will be automatically enrolled into the Plan with a deferral election of 3% of eligible compensation, with annual increases of 1%, up to a maximum of 6%. The Company made employer matching contributions in an amount equal to the sum of 50% of the participant's deferral on the first 4% of the participants eligible compensation for the years ended December 31, 2024 and 2023. In addition, contributions are subject to certain limitations as prescribed by the IRC.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, and (b) plan earnings, and is charged with an allocation of administrative expenses. Allocation of Plan earnings is based upon participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Prior to January 1, 2024, participants were vested in employer contributions plus actual earnings thereon at a rate of 25% after each year of credited service, beginning in year two of service and was fully vested after five years of credited service. Effective January 1, 2024, participants are vested in employer contributions plus actual earnings thereon at a rate of 20% after each year of credited service and is fully vested after five years of credited service. Participants vest immediately in all contributions plus actual earnings when they reach normal retirement age or in the event of death or total and permanent disability.

**Payment of Benefits** - Upon reaching retirement age, termination of service, or death, a participant may be paid a lump sum amount equal to the participant's vested account value. Upon reaching age 59½, participants may take in-service withdrawals of part or all of their vested account balance. The Plan further provides for qualified reservist and hardship distributions. Hardship distributions are available only for the purpose of meeting immediate and heavy financial need and may be withdrawn prior to normal retirement. Account balances that are under \$7,000 may be automatically paid out at the discretion of the Company.

**Expenses** - Administrative expenses may be paid by the Company. Expenses not paid by the Company are deducted from investment earnings before allocation to participants' accounts. Expenses of Plan administration, including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel are provided by the Company without charge to the Plan. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

**Forfeitures** - Forfeited, non-vested accounts may be used to pay administrative expenses of the Plan or to reduce employer matching contributions. Forfeited accounts amounted to \$16 and \$0 at December 31, 2024 and 2023, respectively. Forfeitures of \$11,288 and \$19,073 were used to reduce employer matching contributions in 2024 and 2023, respectively.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual basis of accounting.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for the benefit-responsive investment contract, which is carried at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Subsequent Events** - The Plan's management has performed an evaluation of subsequent events through September 25, 2025, which is the date these financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

#### **Basis of Fair Value Measurement**

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts (PSAs):* The Plan held a group annuity. The contract allowed the Plan to participate in pooled separate accounts, each of which holds underlying investments. The PSAs invest in a single mutual fund, or in a portfolio of securities. The PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities.) While the underlying asset values of the PSAs are based on quoted prices, the NAV of the pooled separate account is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices and is used as a practical expedient to estimate fair value. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV. The Plan was permitted to redeem investment units at NAV on the measurement date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 4 – GROUP ANNUITY CONTRACTS**

The Plan held a group annuity contract with Sentry Life Insurance Company (the former Issuer) for the Plan year ended December 31, 2023 through May 20, 2024. On May 21, 2024, the Plan entered into a group annuity contract with Lincoln National Life Insurance Company (the current Issuer). The group annuity contracts are both traditional fully benefit-responsive investment contracts and accordingly are reported at contract value in the accompanying financial statements. The current Issuer and former Issuer maintain the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuers are contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 2.4% for the contract held with the former Issuer in 2003 and 1.0% for the contract held with the current Issuer in 2024. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Contract value is the relevant measurement attributable for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by the Issuers, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The Plan's ability to receive amounts due is dependent on the Issuers' ability to meet their financial obligations. The Issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the Issuers. Such events include, but are not limited to layoffs, Plan termination, business closings, reorganizations, liquidations and the failure of the Plan to qualify under Section 401(a) or Section 401(k) of the IRC. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the Issuers to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an unsecured violations of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment of the agreement without the consent of the Issuers.

#### **NOTE 5 – INFORMATION CERTIFIED BY THE TRUSTEES AND CUSTODIAN OF THE PLAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments at fair value and investment at contract value held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified by Fidelity Management Trust Company, the trustee of the Plan and Lincoln National Life Insurance Company, the custodian of the Plan, as of December 31, 2024, and for the period from May 21, 2024 to December 31, 2024, and Sentry Life Insurance Company, LLC, the former trustee of the Plan, as of December 31, 2023, and for the period from January 1, 2024 to May 20, 2024.

#### **NOTE 6 – NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their accounts up to the lesser of 50% of the present value of the borrower's vested interest in amounts held under the Plan at the time of loan origination or \$50,000. Loan must be repaid within five years unless for purchase of a primary residence. Interest is charged based on a reasonable rate of interest as determined by the plan administrator. The rate of interest on outstanding loans ranged from 4.25% to 9.50%, at December 31, 2024. Loans are secured by the vested account balance of the participant.

#### **NOTE 7 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The trustee of the Plan is Fidelity Management Trust Company. Sentry Life Insurance Company is the former trustee of the Plan. Certain Plan investments are shares of mutual funds managed by Fidelity Investments, the trustee of the Plan and shares of pooled separate accounts and a group annuity contract that were managed by Sentry Life Insurance Company, the former trustee, therefore these transactions were party-in-interest transactions. Fees for investment management services charged by Fidelity Investments are netted against Plan earnings and range from 0.02% up to 0.98% of the average daily investment balance during 2024. Fees for investment management services charged by Sentry Life Insurance Company or an affiliate of the trustee were at a rate of 0.50% during 2023 and were netted against Plan earnings.

#### **NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **NOTE 9 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan holds investments that are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participants' account balances. There were three investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023. See the Supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

## **NOTE 10 – TAX STATUS**

The Plan document is an adoption of a non-standardized pre-approved profit sharing plan sponsored by FMR LLC. The Plan document obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
