- 1. Description of the Plan** The following description of the NWT 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of NewWave Telecom & Technologies, Inc., iQuartic, and Onyx Technology LLC (collectively, the "Company") who are at least 18 years old, except for nonresident aliens and employees covered by a collective bargaining agreement. Effective April 1, 2024, the Plan was amended to add New Wave Foundation, Inc. as a participating employer effective August 1, 2024. In March 2025, the Plan was amended to remove ONYX Technologies LLC as a participating employer effective November 8, 2024. Employees are eligible to participate in Company discretionary contributions after completing six months of service with at least 500 hours. There is no such service requirement to be eligible to make participant or receive Company safe harbor contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In January 2024, the Plan was amended and restated with an effective date of February 1, 2024. In connection with this restatement, Empower Trust Company, LLC became the trustee and custodian of the Plan. All assets of the Plan were transferred to Empower Trust Company, LLC in February 2024. No significant Plan provisions were affected by the amendment and restatement.

Notes to Financial Statements

Contributions: Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for automatic enrollment. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a three percent withholding of pretax annual compensation. The Company contributed a safe harbor matching contribution of 100 percent of the first three percent and 50 percent of the next two percent of compensation that a participant contributes to the Plan. Effective April 1, 2024, the Plan was amended to remove the safe harbor matching contribution. The Plan allows for discretionary matching contributions. There were no such contributions for the Plan year ended December 31, 2024. Nonelective profit sharing amounts may be contributed at the discretion of the Company. Participants must be employed on the last day of the Plan year and have completed a year of service or have terminated service due to death, disability or retirement to receive an allocation of any discretionary nonelective profit sharing contribution. There were no such contributions for the Plan year ended December 31, 2024. Operational defects were discovered that required corrective contributions. These amounts are reflected on the Plan's financial statements as Other employer contributions. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, the Company's discretionary matching contributions, if any, as well as allocations of the Company's discretionary nonelective profit sharing contribution, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary nonelective profit sharing contributions, if any, are based on the ratio of the participant's compensation to total compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Payment of benefits: Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. During 2024, the Company elected to permit certain optional withdrawals available through the SECURE Act and SECURE 2.0 Act. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, installment and partial withdrawal payments.

Vesting: Participants are vested immediately in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company discretionary matching and nonelective profit sharing contributions is based on years of continuous service of at least 1,000 hours per year. A participant is 20 percent vested after two years of service is completed, and vests an additional 20 percent per year until full vesting after six years.

Forfeited accounts and unallocated amounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,786 and \$33, respectively. These accounts will be used to reduce future Company contributions, to pay Plan expenses or to restore participant accounts. During 2024, no forfeited nonvested accounts were used to reduce Company contributions or to pay Plan expenses.

At December 31, 2024 and 2023, unallocated balances (other than forfeited nonvested accounts) totaled \$46,342 and \$39,176, respectively. These amounts represent unclaimed benefits previously distributed to participants. These amounts will be restored to participant accounts or used in the same manner as forfeited nonvested accounts. During 2024, no unallocated amounts were used to reduce Company contributions or to pay Plan expenses. No unallocated amounts were used to restore participant accounts and reissue benefit payments.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus one percent. Principal and interest are paid through payroll deductions.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees are charged directly to the participant's account and are included in administrative expenses. Participants are also charged a monthly asset based fee for investment advisory services.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions: Participant contributions, the related Company safe harbor matching contributions and discretionary matching contributions, if any, are recognized in the period the participant contribution is withheld from compensation. Company discretionary nonelective profit sharing contributions, if any, are recognized in the period the related eligible compensation is paid to the participant.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through September 26, 2025, which is the date the financial statements were available to be issued.

3. Certified information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, Empower Annuity Insurance Company of America, and Reliance Trust Company, the custodian, insurance company, and trustee of the Plan, respectively.

4. Fair value measurements

The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the collective trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits.

Investments in the Reliance Trust Company Stable Value collective trust fund can be redeemed immediately at the current net asset value based on the fair value of the underlying assets for participant withdrawals. Company initiated withdrawals may result in a reduction in value if the fair value of the fund's underlying assets is less than the guaranteed value of the fund. Participant initiated withdrawals from the Great Gray collective trust funds can be redeemed immediately at the current net asset value. Company initiated withdrawals which will exceed \$1 million require advanced written notice of five business days. There are no other withdrawal limits, redemption frequency limits or redemption notice periods for the collective trust funds. There were no unfunded commitments for this investment as of December 31, 2024 and 2023.

5. **Guaranteed investment contract**

The Plan participated in a traditional benefit responsive investment contract with Empower Annuity Insurance Company of America ("Empower") via an investment in a Guaranteed Investment Contract ("GIC"). Empower commingled the assets of the GIC with other assets in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. No events limit the ability of the Plan to transact at contract value.

- 6. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 7. Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 8. Tax status** Prior to February 1, 2024, the Plan was a pre-approved plan of ADP LLC, which received an opinion letter on October 6, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Effective February 1, 2024, the Plan is a pre-approved plan of Empower Retirement, LLC, which received an opinion letter on November 14, 2022, in which the IRS stated that the form of the plan document was acceptable under the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 9. Party-in-interest transactions** Certain Plan investments are managed by affiliates of Reliance Trust Company and Empower Trust Company, LLC. Reliance Trust Company, ADP, LLC, and Empower Trust Company, LLC are the trustee, custodian and recordkeepers as defined by the Plan. The Plan paid a total of \$77,290 to ADP, LLC, Empower Trust Company, LLC and the investment advisor for administrative and advisory services for the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions.

The Company has a Plan Expense Agreement ("PEA") with Empower Retirement, LLC that provides for a portion of the revenue earned by Empower Retirement, LLC with respect to the services it provides for the Plan, including the recordkeeping fees paid from participant accounts, to be made available to the Plan to pay expenses. For the year ended December 31, 2024, Empower deposited \$32,933 into the Plan under the PEA and the Plan paid \$32,933 in investment advisor fees under the PEA. The deposit is presented net of expenses and included in the administrative expenses in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. At December 31, 2024, the balance in the PEA account was \$45. These transactions qualify as exempt party-in-interest transactions.
