The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Plan Description

The following description of the Aero Simulation, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Aero Simulation, Inc. (the "Company") who have completed two months of service and are age twenty-one or older. Participants may enter the Plan on first day of each Plan quarter after the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Contributions* – Each year participants may contribute to the Plan up to 100% of compensation, subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans (rollover).

For the year ended December 31, 2024 and 2023, the Company made safe-harbor matching contributions of 100% of the first 5% of compensation that each participant contributed to the Plan.

Additional profit sharing amounts may be contributed at the discretion of the Company. Participants must be employed by the Company on the last day of the year to be eligible. No profit sharing contributions were made to the Plan for the year ended December 31, 2024.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or website.

- c) *Participants Accounts* – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses maybe charged based on account balances or charged equally to each participant. The benefit to which a

participant is entitled is the benefit that can be provided from the participant's vested account.

- d) *Vesting* – Participants are vested immediately in their contributions and the Company's safe-harbor matching contributions, plus actual earnings thereon.

Vesting in the Company's profit sharing contributions is based on years of service: Profit sharing contributions vest 100% after three years of service (100% vested upon three year cliff) or upon the events of death, disability or attaining age 65.

- e) *Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate. Principal and interest is paid ratably through weekly payroll deductions.
- f) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants receive the vested accumulated value of their account in a lump sum distribution.
- g) *Forfeited accounts* – As of December 31, 2024 and 2023, forfeited non-vested accounts of terminated participants totaled \$41,204 and \$4,881, respectively. Forfeitures of nonvested balances may be used to pay Plan expenses or reduce employer matching contributions. In 2024, the Plan used \$18,220 to reduce employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets

and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The three levels of inputs that may be used to measure fair value are:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other-than-quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and,

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Pooled separate accounts – The units of pooled separate accounts are stated at fair value as determined by the issuer of the account based on the fair

value of the underlying investments. Individual participant accounts invested in the pooled separate accounts are maintained on a unit value basis.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through September 24, 2025, which is the date the financial statements were available to be issued.

6. Guaranteed investment contract (GIC)

The Plan' holds a guaranteed investment contract (GIC) with Voya Retirement Insurance and Annuity Company (Voya), under the investment fund, Voya Fixed Account. Voya maintains the contributions in a general account. The contracts underlying this investment option are considered to be fully benefit responsive.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Voya may impose restrictions on the ability to move funds into or out of this investment option. Withdrawals from the Voya Fixed Account for other than the payment of benefits to participants may be subject to a Market Value Adjustment and a surrender charge.

7. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

8. Party-in-Interest Transactions

The Plan invests in certain investments of the Plan's custodian, Voya. Therefore, these transactions qualify as party-in-interest transactions. Additionally, notes receivable from participants are considered to be party-in-interest transactions

because they are transacted with Plan participants. Fees paid for the investment management services are included in net investment income. The Plan paid \$20,667 in fees to the custodian in 2024.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

10. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by My Benefits LLC ("My Benefits"). My Benefits obtained its latest opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
