Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Field Home 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Description of Plan

The following description of the Field Home 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Field Home Holy Comforter (the "Employer") except for employees who are non-resident aliens, students or are participating in another 403(b) or 401(k) plan. For purposes of salary deferral contributions, an employee is generally eligible for participation in the Plan upon their first day of employment unless they are classified as an excludable employee in the Plan. An employee is eligible for Employer contributions upon obtaining 21 years of age, completing one year of service, and is not: covered by a collective bargaining agreement, eligible for participation in another 403(b) or 401(k) plan, or a non-resident alien. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The nursing home and day care program of the Employer were sold to an unrelated buyer in April of 2018. The remaining employees that were not terminated as part of the sale are now employed under Field Hall Foundation, an affiliate of the Employer.

Contributions

Participants may elect to have a percentage or specified pre-tax dollar amount deducted from their compensation as defined by the Plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Employer. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified retirement plans.

For a participant who has completed one year of eligibility service and was hired prior to May 1, 2012, the Employer makes a discretionary contribution equal to 7% of a participant's eligible compensation up to the Social Security Taxable Wage Base ("SSTWB") and 5.5% in excess of the SSTWB.

For a participant who has completed one year of eligibility service and was hired after May 1, 2012, the Employer makes a discretionary contribution equal to 5% of a participant's eligible compensation up to the SSTWB and 5.5% in excess of the SSTWB.

1. Description of Plan (*continued*)

Vesting

Participants are fully vested at all times in their contributions plus actual earnings thereon. Vesting in Employer contributions for participants hired prior to May 1, 2012 is as follows:

Less than 2	0%
2 or more but less than 3	50%
More than 3	100%

Participants that were hired after May 1, 2012 are fully vested in Employer contributions upon completion of 3 years of service.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$34,235 and \$43,846. These accounts may be used to reduce Plan administrative expenses or Employer contributions. During 2024, forfeitures of \$10,427 were used to reduce Employer contributions and no forfeitures were used to reduce Plan administrative expenses.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (1) the Employer's contribution and (2) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant ("borrower") enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of the vested account balance or \$50,000 (whichever is less). The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis which is a basis of accounting other than accounting principles generally accepted in the United States of America (“U.S. GAAP”). Under this basis, investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with U.S. GAAP.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the benefit-responsive guaranteed investment contracts (“GICs”), which are reported at contract value. The benefit-responsive GIC's are valued at contract value, which represents contributions made, plus interest credited, less any withdrawals and expenses. The fair value of the non-benefit-responsive GIC is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations. The separate accounts are reported at the value reported to the Plan by the insurance companies, which represents the approximate fair value of the underlying investments comprising the accounts. The mutual funds and money market fund held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. The mutual funds are required to publish their daily net asset value and to transact at that price. They are deemed to be actively traded.

Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest and dividends are recorded when received. Purchases and sales of securities are recorded on a trade-date basis.

Notes Receivable from Participants

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 25, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (“State Street”), Transamerica Financial Life Insurance Company (“TFLIC”), Hand Benefits & Trust Company (“Hand Benefits”), and MONY Life Insurance Company, qualified institutions.

5. Guaranteed Investment Contracts

TFLIC Fixed Fund, at Contract Value

The TFLIC Fixed Fund ("Fixed Fund") is a fully benefit-responsive investment contract, which provides participants with book value distributions at retirement and other events as described in the group annuity contract. Both principal and interest are guaranteed by TFLIC. The Fixed Fund is supported by TFLIC's general account. The general account of TFLIC invests in investment grade fixed income securities, including U.S. government, agency, and corporate issues; as well as individually underwritten mortgage loans, and private placements. Interest is declared quarterly for new deposits received during that quarter and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets.

No monies may be transferred by participants to fixed income funds (competing funds). Funds transferred to non-fixed income funds may not be transferred to fixed income funds or back to the Fixed Fund for 90 days. Monies transferred back to the Fixed Fund or withdrawn within the 90-day period are subject to a 5% charge. Monies withdrawn or transferred by the Employer and monies withdrawn by participants not due to benefit withdrawals, hardships and loans may be subject to a withdrawal charge.

Because the Fixed Fund is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the account. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5. Guaranteed Investment Contracts (*continued*)

TFLIC Stable Fund, at Contract Value

The TFLIC Stable Fund (“Stable Fund”) is a fully benefit-responsive investment contract, which provides participants with book value distributions at retirement and other events as described in the group annuity contract. Both principal and interest are guaranteed by TFLIC. The Stable Fund is supported by TFLIC's general account. The general account of TFLIC invests in investment grade fixed income securities, including U.S. government, agency, and corporate issues; as well as individually underwritten mortgage loans, and private placements. Interest is declared quarterly for new deposits received during that quarter and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets. The underlying guaranteed rate in effect through segment maturity date.

No monies may be transferred by participants to fixed income funds (competing funds). Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back to the Stable Fund for three months. Monies withdrawn or transferred from the Stable Fund by the Employer at any time and/or by participants during the six-month period preceding contract suspension may be subject to restriction and/or adjustment in accordance with contract provisions.

Because the Stable Fund is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Empower PPSA, at Fair Value

The Plan invests in a non-benefit responsive guaranteed investment contract with Empower Retirement Insurance and Annuity Company called the Empower Principal Preservation Separate Account (“PPSA”). The PPSA is a stable value product that provides protection from Prudential's general account and guarantees principal and accumulated interest. The PPSA invests in a broadly diversified portfolio of fixed income instruments (primarily in intermediate-term bonds, private placements and commercial mortgages). The interest crediting rate is announced in advance and is guaranteed for a six-month period for which a minimum rate will apply. Distributions resulting from a participant's termination of employment, retirement, disability or death, hardship withdrawals and minimum required distributions are always paid in full without any restrictions or fees. Amounts withdrawn may not be transferred to a competing fund for 90 days after withdrawal.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

7. Tax Status

On March 31, 2017, the Internal Revenue Service (“IRS”) issued an opinion letter to the prototype document preparer indicating that the Plan, as then designed, qualifies under Section 403(b) of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Prohibited Transactions

During the 2024 and 2023 Plan years, the Employer failed to transmit to the Plan certain participants’ contributions totaling \$1,000 and \$675 within the period described by Department of Labor regulations. Delays in remitting these amounts to the Plan were due to an administrative oversight. Plan management is in the process of calculating and remitting lost earnings for the delinquent contributions of \$1,675.

9. Party-in-Interest Transactions

Certain investments are managed by TFLIC, one of the Plan’s custodians. Accordingly, these transactions are considered exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
