I am writing regarding the delayed filing of Form 5500-SF for the year 2021 for Genesis Egg Donor & Surrogacy Group, Inc. (The Genesis Group), Plan#23469. Due to challenges that many companies faced in 2021, stemming from the COVID-19 pandemic, The Genesis Group faced significant challenges, including the loss of our in-house accountant and office manager who had to stay home to care for their families. These two individuals were responsible for many of the operational procedures in our office, and their absence led to several missed deadlines. As we gradually began transitioning back to "business as usual," many administrative processes were temporarily put on hold so we could focus on generating income to keep the business afloat. As a result, I was unable to file Form 5500-SF on time.
