We have performed audits of the financial statements of Ingram Micro 401(k) Investment Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Description of the Plan

The following description of the Ingram Micro 401(k) Investment Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that provides retirement benefits for and covers all of the employees of Ingram Micro Inc. (the Company) and designated affiliates who are maintained on the United States payroll, with the exception of those noted in Eligibility below. The Plan is designed to comply with Section 401(a) of the Internal Revenue Code (the IRC) as a defined contribution plan and its incorporated trust is intended to qualify as a tax-exempt trust under Section 501(a) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee, Custodian and Administration of the Plan

The Plan is administered by the Company (the Plan Administrator) and advised by the Benefits Administrative Committee appointed by the Company's Board of Directors. Fidelity Management Trust Company and its affiliates (the Trustee or Fidelity) act as the trustee, custodian and record keeper of the Plan. Mercer Investments LLC (Mercer) is the ERISA 3(38) investment manager of the Plan.

Eligibility

Employees of the Company maintained on the United States payroll, with the exception of those who are leased, employed under a collective bargaining agreement, nonresident aliens with no United States sourced income, or employees who reside and work in a United States territory (including, but not limited to, the Commonwealth of Puerto Rico), are eligible to enter the Plan following the completion of their first hour of credited service with the Company.

Contributions

Contributions are made to the Plan by means of a salary deferral agreement under which the participant can elect pre-tax, Roth 401(k) and after-tax compensation deferrals up to the lesser of 50% of eligible compensation for non-highly compensated participants, and a percentage (not to exceed 50%) determined by the Company of eligible compensation for highly compensated participants, or a fixed amount determined annually by the Internal Revenue Service (the IRS). Participants who become age 50 or older on or before the end of the calendar year are eligible to make additional catch-up contributions of up to the lesser of 25% of eligible compensation or a fixed amount determined annually by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company shall determine, in its absolute discretion, whether matching contributions shall be made for any particular period of time, including a matching contribution on the annual incentive award. The Company is not required to make matching contributions for any period of time. The Company does not match non-Roth 401(k) after-tax contributions. The Company's current matching contribution represents 50% of the participant's pre-tax and/or Roth 401(k) contributions up to the first 5% of eligible compensation.

The Plan provides for an automatic contribution arrangement of 4% and an automatic annual increase of 1% up to a maximum deferral of 10% for eligible employees who have not made an affirmative deferral election.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and (b) Plan net earnings and charged with an allocation of certain administrative expenses. Allocations of matching contributions are based on participant contributions, as defined. Allocations of Plan net earnings and administrative expenses, when applicable, are based on participant account balances, investment elections, and transactions, such as loans or qualified domestic relations orders. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in their account balance.

Notes Receivable from Participants

Notes receivable from participants consist of participant loans that are secured by the balance in the participant's account. Participants may borrow a minimum of \$1,000 and up to a maximum of the amount equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance during the preceding one-year period or 50% of their vested account balance, excluding any balance invested in the self-directed Brokerage Link account.

The loans bear interest at a commercially reasonable interest rate with payment of principal and interest made generally through payroll deductions. Loans with repayment terms in excess of five years are for the purchase of primary residences. A participant may have no more than two loans outstanding at any one time. Participant loans are stated at the unpaid principal value and, as of December 31, 2024, bear interest at rates that range from 4.25% to 9.5% and mature on various dates through 2039. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Vesting

Participants are immediately 100% vested in their contributions and the associated net earnings. The Company's matching contribution is immediately 100% vested.

Payment of Benefits

Upon termination of service, a participant with vested benefits of over \$5,000 may elect to defer distribution or receive a lump sum payment or direct rollover equal to the vested share of the participant's account. A participant with vested benefits of less than \$5,000 but greater than \$1,000 must elect a lump sum payment or direct rollover, or the vested share of the participant's account will automatically be transferred to an individual retirement account. A participant with vested benefits of \$1,000 or less must elect a lump sum payment or direct rollover, or the vested share of the participant's account will automatically be distributed in a lump sum payment.

Benefits may be distributed upon termination of service for any reason, including disability or death. In the event of death, benefits are distributed to the participant's beneficiary. The Plan allows participants to take in-service withdrawals after reaching age 59½. In-service withdrawals may also be taken at any time from pre-tax rollovers, after-tax contributions or for certain financial

hardships. Participants taking in-service withdrawals will be required to pay all applicable taxes on the withdrawals and may be subject to penalty taxes for early withdrawals taken prior to age 59½.

Forfeitures

Employer contributions made for participants who terminated their employment prior to April 1, 2015 were subject to having the employer contributions forfeited based on a five-year vesting schedule. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$7,533 and \$6,908, respectively. These accounts may be used to reduce future employer contributions. In 2024, approximately \$0 of the forfeited funds were used to fund employer contributions, and approximately \$4,215 of the funds were used to pay administrative expenses.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping and certain participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Revenue Credits

The Plan's trust agreement with Fidelity provides for a revenue credit arrangement, whereby the trustee allocates quarterly deposits into the account to pay administrative expenses or credit to participant accounts. Unallocated revenue credits at December 31, 2024 and 2023 are approximately \$59,000 and \$102,000, respectively. During 2024, the Plan allocated approximately \$110,000 of revenue credits to participant account and approximately \$42,000 of revenue credits was used to pay administrative expenses. Administrative expenses are presented net of revenue credits in the statement of changes in net assets available for benefits.

Investment Elections

The Trustee invests contributions in accordance with participant investment instructions. Participants may change their future deferral investment elections concurrent with their pay frequency and also move existing balances effective with the close of market.

Brokerage Link Investment Accounts

No more than 50% of a participant's account balance may be invested in the Brokerage Link investment account, which is a self-directed brokerage account that allows Plan participants to invest in various mutual funds not otherwise offered through the Plan. Participation in the self-directed brokerage account shall be subject to such terms and conditions as may be established from time-to-time by the Plan Administrator, which may include specific enrollment procedures and restrictions on loans and withdrawals.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefits Administrative Committee determines the Plan's valuation policies utilizing information provided by the Investment Manager and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Employer matching contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefits are recorded when paid.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board's Accounting Standard Codification 820, *Fair Value Measurement* are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective Investment Trusts - These assets are valued at their respective net asset value (NAV) as the practical expedient, based on the fair value of the assets underlying the funds. The practical

expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Collective trusts are not classified within the fair value hierarchy. Participant transactions (purchases and sales) may occur daily and there are no restrictions. There were no unfunded commitments.

Brokerage Link Investment Accounts - These assets are valued at the quoted closing market price of the securities held in the accounts.

Mutual Fund - This asset is valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan does not have any Level 2 or 3 assets as of December 31, 2024 and 2023.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Mercer and Fidelity. Fidelity acts as trustee as defined by the Plan and Mercer acts as the investment manager. These transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, certain fees were paid by the Plan to Fidelity and to Mercer. The Plan issues loans to participants, see “Notes Receivable from Participants” in Note 1 for more details. These transactions qualify as party-in-interest transactions under ERISA.

6. Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. Tax Status

The trust that is established under the Plan to hold the Plan’s assets is designed to qualify pursuant to Section 501(a) of the IRC, and, accordingly, the trust’s net investment income is exempt from income taxes. The Plan has a favorable determination letter of its tax-exempt status from the IRS dated June 23, 2014, which provides that the Plan and related trust are designed in accordance with the applicable qualification sections of the IRC. The Plan has been amended and restated since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed in compliance with the applicable qualification requirements of the IRC. In addition, the Plan Administrator is not aware of any operational issues that will prevent the continuation of the Plan's qualified tax status.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued. There were no events or transactions that require recognition of disclosure in the financial statements.
