## INDEPENDENT AUDITOR'S REPORT

## **Basis for Opinion**

**NOTE A - SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Presentation:* The accounting records of the Continental Cars, Inc. 401(k) Plan and Trust (the "Plan") are prepared on the accrual method of accounting in accordance with U.S. generally accepted accounting principles. The Plan includes combined participants of Continental Cars, Inc., Continental Imports, Inc. and Austin Infinity, Inc. (collectively, Plan Sponsor).

*Investment Valuation and Income Recognition:* Investments in mutual funds are reported at fair value of the underlying investment. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisers and the custodian.

The fixed income account is stated at contract value, which represents net contributions plus interest at the contract rate. The contract is fully benefit-responsive.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Participants' Notes Receivable:* Participants' notes receivable are stated at their unpaid principal balance plus any accrued interest. Interest is recognized as accrued. An allowance was not required at either year end. If a participant ceases to make a loan repayment and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment to the participant is recorded.

*Payment of Benefits:* Benefit payments are recorded when paid.

*Concentration of Credit Risks:* Concentration of credit risk with respect to mutual funds is reduced as a result of the diversity of the underlying investments.

*Subsequent Events:* Subsequent events have been evaluated by management through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

*New Accounting Pronouncements:* Management is not aware of any new accounting pronouncements that have been released, and are not yet effective, which will have a significant impact to its financial position or results of operations in future periods.

*Use of Estimates:* The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements, and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**NOTE B - DESCRIPTION OF PLAN**

The following description of the Continental Cars, Inc. 401(k) Plan and Trust provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and covers substantially all employees who are 18 years of age and have two months of service.

*Plan Restatement:* The Plan was amended and restated on July 1, 2022, to include prior amendments made to the Plan and change the eligibility from 12 months to 2 months of services. The restatement includes the adoption of certain provisions of the Coronavirus Aid, Relief and Economic Security (CARES) Act, Setting Every Community Up for Retirement Enhancement (SECURE) Act. These Acts allowed for Coronavirus distributions and changed the age in which required minimum distributions.

The Securing a Strong Retirement Act (SECURE 2.0) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 or later.

*Termination:* Although it has not expressed an intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

*Contributions:* Participants may elect to contribute up to 100% of pretax and after-tax annual compensation subject to IRS limitations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions to various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. The auto enrollment deferral rate increases 1% per year until it reaches 10%. The Plan Sponsor may make a discretionary contribution, that amount of which is determined by the Board of Directors and allocated based on each participant's compensation. Participants also direct the investment of any discretionary contribution received.

*Participant Accounts:* Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are immediately vested in their contributions plus actual earnings thereon, and after a year or service in the Plan Sponsor's matching and discretionary contribution portion of their accounts plus actual earnings thereon. A participant becomes fully vested, regardless of the above vesting schedule, upon attainment of retirement, disability, death or termination of the Plan.

*Participants' Notes Receivable:* Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from 1 - 5 years. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate of interest as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

*Payment of Benefits:* Benefit payments are made at normal retirement (age 65), death, disability and termination of service. Benefits are paid in a lump sum and will be distributed as soon as administratively possible. In service distributions are allowed if the participants account is fully vested. Hardship distributions are allowed as defined by the Plan.

*Forfeited Accounts:* Participant forfeitures of non-vested contributions may be used to pay administrative expenses and reduce employer contribution. Any portion of the forfeiture account not used to pay administrative expenses of the Plan may be allocated to eligible participant accounts. Forfeitures available for future use totaled \$ -0- at December 31, 2024 and \$315 at December 31, 2023.

**NOTE C – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)**

As permitted by Department of Labor CFR 2520.103-8, investments at December 31, 2024 and 2023 and the related investment earnings and interest on participants' notes for the years then ended, were certified and held by VOYA Retirement Insurance and Annuity Company (VOYA), the Custodian, and were not audited by the independent auditor. Participants' notes receivable were note certified by the Custodian and were subject to audit by the independent auditor.

**NOTE D – FIXED INCOME ACCOUNT WITH INSURANCE COMPANY**

The Plan has a fully benefit-responsive group funding agreement, the VOYA Fixed Income Account, with a balance of \$888,362 at December 31, 2024 and \$1,681,775 at December 31, 2023. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group funding agreement provides a fixed account which is contractually obligated to repay the principal and a specified minimum interest rate that is guaranteed to the Plan.

Because the fixed account is fully benefit-responsive, it is stated at contract value, the amount the participant would receive if they were to initiate permitted transactions under the Plan. Contract value, as reported to the plan by VOYA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) full or partial plan termination, (2) insolvency of the Plan Sponsor, or (3) aggregate terminations in any contract year exceed 20% of the full contract value as determined on the first day of the contract year. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**NOTE E – TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed for in the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments.

**NOTE F - INCOME TAX STATUS**

The Plan adopted a pre-approved specimen 401(k) profit sharing plan by Alliance Benefit Group which has received a favorable determination that it qualifies under applicable sections of the Internal Revenue Code. The Plan has not been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

**NOTE G - FAIR VALUE MEASUREMENTS**

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
  - quoted prices for identical or similar assets or liabilities in inactive markets
  - inputs other than quoted prices that are observable for the asset or liability
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means
  - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used or transfers between levels. Following is a description of the valuation methodologies used for various types of assets measured at fair value:

*Pooled Separate Accounts:* Valued at quoted price of the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
