### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Fox Communities Credit Union Capital Accumulation Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Fox Communities Credit Union Capital Accumulation Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### ***Basis for Opinion***

### Note 1: Description of Plan

The following description of the Fox Communities Credit Union Capital Accumulation Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Fox Communities Credit Union (the "Company") who are age 19 or older and have completed 60 days of service. Employees enter the Plan immediately upon meeting the eligibility requirements. The Plan excludes all temporary and seasonal employees from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the provision increasing the age at which participants must begin taking required minimum distributions from age 72 to 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### Contributions

Each year, participants may contribute up to 100% of annual eligible compensation, as defined by the plan document, to the Plan on a pretax or Roth basis subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan or make an alternate deferral election. Automatically-enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company provides a safe harbor matching contribution equal to 100% of the first 2% of eligible compensation and 50% of the next 4% of eligible compensation a participant contributes to the Plan. Rollover and catch-up contributions are not matched by the Company. In addition to safe harbor matching contributions, the Company also makes profit sharing contributions equal to 2% of the eligible compensation of all participants eligible to share in allocations. For the year ended December 31, 2024, Company matching contributions totaled \$974,625, while profit sharing contributions totaled \$579,548.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor and profit sharing contributions, and allocations of plan earnings or losses. Participant accounts are reduced by withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions and rollovers plus actual earnings or losses thereon. Vesting in the Company's contribution portion of a participant's account plus actual earnings thereon is based on years of continuous service. Participants become 100% vested after two years of service for Company safe harbor matching contributions. Participants vest at a rate of 20% per year beginning with the second year of service and become fully vested after six years of service for the Company profit sharing contributions. Participants also become 100% vested in Company contributions upon death or disability. Participants are considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service during a plan year. The SECURE Act requires employers to allow long-term, part-time workers to participate in their 401(k) plan. Employers maintaining a 401(k) plan must have a dual eligibility requirement under which an employee must complete either 1 year of service (with the 1,000-hour rule) or 3 consecutive years of service (where the employee completes at least 500 hours of service). Section 125 of SECURE 2.0 reduces the 3 year rule to 2 years, effective for plan years beginning after December 31, 2024.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have two notes outstanding at any given point in time. Note terms shall not exceed five years, except when the proceeds are used to purchase a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate equal to 1.00% above the prime rate at the time of issuance. Notes receivable from participants merged into the Plan in previous years maintain the terms determined at issuance, including interest rate. The interest rate on existing notes at December 31, 2024, range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, retirement (age 65), or termination of employment, a participant may elect to receive the value of his or her vested account balance in the form of a lump-sum payment, installment payments, or annuity payments. In addition, hardship distributions out of the participant's voluntary contribution account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions.

There were no forfeited nonvested accounts at December 31, 2024 and 2023. Forfeited balances are used to reduce future Company contributions. During the year ended December 31, 2024, Company contributions were reduced by \$94,065 from forfeited nonvested accounts.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts ("FBRICs"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value investments and Note 4 for discussion of FBRICs. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses and Investment Management Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income on the accompanying statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and the processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. All other expenses of maintaining the Plan are allocated to participants proportionately based on their account balances and are included in administrative expenses.

#### Subsequent Events

The Plan has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Fair value of the common/collective trusts is based on quoted NAVs of the underlying investments held by the common/collective trusts. The underlying mutual funds held by the common/collective trusts are open-ended mutual funds registered with the SEC. The funds must publish their daily NAV and transact at the price.

### Note 4: Fully Benefit-Responsive Investment Contracts ("FBRICs")

The Plan invests in a FBRIC with CMFG Life Insurance Company ("CMFG") in the form of a guaranteed investment contract ("GIC") that invests in traditional investment contracts. CMFG maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. CMFG is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on the best interest rate that is consistent with the performance of CMFG's general account assets and is reviewed quarterly.

Certain events limit the Plan's ability to transact at contract value with CMFG, including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit CMFG to terminate the agreement prior to the scheduled maturity date.

### **Note 5: Information Prepared and Certified by Custodians**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value and the fully benefit-responsive investment contract at contract value held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company and CMFG, the custodians of the Plan. In addition, CMFG also certified the notes receivable from participants held at December 31, 2024 and 2023, and interest income on notes receivable from participants for the year ended December 31, 2024.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 7: Tax Status**

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receipt of the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Party-in-Interest Transactions**

Certain plan investments are managed by CMFG. CMFG is a custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan to this custodian for administrative services were \$79,312 for the year ended December 31, 2024. During 2024, the Plan also paid fees totaling \$6,799 to a national board of trustees who monitors fund performance within the Plan. Certain investment-related expenses paid to CMFG are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
