Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lea Elliott, Inc. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) at December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1. Plan Description

The following description of the Lea + Elliott, Inc. (the "Company") Employees' Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established November 1, 1978, as a defined contribution profit-sharing plan for employees of Lea + Elliott, Inc. for the purpose of providing employees of the Company an opportunity to defer a portion of their compensation for federal income tax purposes in accordance with Section 401(k) of the Internal Revenue Code (IRC). The Company serves as a sponsor of the Plan, and as such, has the authority to amend or terminate the Plan, subject to certain restrictions. The management of the Company has the authority and responsibility for the general administration of the Plan. Fidelity Management Trust Company, as trustee, has the authority and responsibility to hold, manage, and protect the assets of the Plan in accordance with the provisions of the Plan and the separate trust agreement. Fidelity Investments Institutional Operational Company, Inc. provides record-keeping services to the Plan and to individual participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation

All employees of the Company are eligible to participate in the Plan. Employees are automatically enrolled in the Plan but are allowed the option to elect voluntarily not to participate in the Plan. Employees may enter the Plan on the first day of each month during the Plan year.

Contributions

Individual participants may elect to contribute up to 60 percent of their annual compensation, subject to the maximum limitations of the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of both Employer and employee contributions among the funds offered by the Plan under rules described in ERISA section 404(c). The Plan currently offers various mutual funds and self-directed brokerage accounts funds as investment options for participants. The Company makes matching contributions of 100 percent of the first one percent of eligible compensation deferred and 50 percent on the next five percent of eligible compensation deferred. Additionally, the Plan allows for Roth elective deferrals. The Roth deferrals are included in an employee's ordinary taxable income and are maintained in a separate account from pre-tax deferrals. Earnings on an employee's Roth account accumulate on a tax-free basis. Plan participants may elect pre-tax, all Roth, or a combination of elective deferrals each pay period. The Company may also make discretionary profit sharing contributions on the basis of the ratio which a participant's compensation bears to the total compensation of all participants. There was \$633,061 of profit sharing contributions made for the year ending December 31, 2024.

Notes to Financial Statements

Participant Accounts

Each participant's account is credited with the participant's contribution, related matching contributions and allocations of (a) the Company's discretionary contribution (if any) and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Employer nondiscretionary matching contributions become fully vested after two years of service. Employer discretionary contributions become twenty percent vested after two years of service, with an additional twenty percent vesting for each year of service over the next four years. In the event of a death, disability or attainment of normal retirement with 5 years of service, the participant becomes fully vested in all employer contributions.

Notes Receivable from Participants

Participants may borrow, in case of a hardship, from their fund accounts up to 100 percent of the participant's salary deferral contributions provided that all notes receivable from the participant do not exceed the lesser of 50 percent of the participant's vested balance or \$50,000. The notes receivable is secured by the balances in the participant's account, and bear interest at a rate which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual payments based on their account balance in either a lump sum or in equal installments over a period of time, or the purchase of a life annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll the account balance over into an IRA or new employer's qualified plan. A Participant whose vested balance never exceeded \$7,000 will be rolled into an IRA account. Balances that have never exceeded \$1,000 will be paid out in a lump sum when termination occurs. Participants should refer to the Plan documents for a full description of the distribution methods offered by the Plan.

Notes to Financial Statements

Participants may make hardship withdrawals if they have an immediate and heavy financial need and other resources are not available to meet the need. Using the "deemed hardship" rules of Reg. 1.401(k)-1(d)(3)(iii)(B), such needs include medical expenses, costs related to the purchase of a principal residence (excluding mortgage payments), payments needed to prevent eviction from the principal residence or mortgage foreclosure, payment of college tuition, payment for burial or funeral expenses, and expenses for the repair of the participant's residence. Only the employee's elective deferrals may be withdrawn, not Plan earnings. Corrective distributions are made to participants whose contributions for the year exceed the maximum allowed under the Plan.

Rollovers

The Plan enables employees to contribute assets that were held by a previous employer plan, provided the contribution meets the requirements of IRC Section 401(a).

Forfeited Accounts

Forfeitures occur on the last day of the Plan year in which a former participant incurs five consecutive one year breaks in service or upon the distribution of the entire vested portion of the participant's account. Forfeitures, if any, are used to reduce employer contribution to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,336 and \$1,060 respectively. During the plan year activity within the forfeiture account included additions of dividends of \$252, forfeitures of \$21,500 and adjustments of \$25.

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments are recorded when paid.

Notes to Financial Statements

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Note 3. Certification

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest, dividends, and interest income on notes from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Notes to Financial Statements

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are held with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds that are valued on the basis of readily determinable market prices.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Plan management evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of different levels.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and/or to terminate the Plan, subject to the provisions of ERISA. In the event of a complete or partial Plan termination, participants would become 100% vested in their entire account balances. In the event of such Plan termination, the trustees shall determine whether the assets of the Plan shall be liquidated and distributed or whether the assets shall continue to be held in trust and distributed in accordance with the terms of the Plan.

Notes to Financial Statements

Note 6. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fidelity Management Trust Company provides certain administrative services to the Plan, pursuant to an agreement, and receive revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the party-in-interest for administrative services to the Plan.

If the revenue received by this party-in-interest from such mutual fund service providers exceeds the amount owed under the agreement, excess amounts are remitted to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to participant accounts. During 2024, \$99,500 of excess amounts were allocated to participants based on their respective account balance. This amount was used to offset administrative expenses in the amount of \$1,287. The Plan or Plan Sponsor may make direct payments to a party-in-interest for administrative expenses not covered by revenue sharing.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
