To the Board of Directors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Harley Ellis Devereaux Employees' Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Harley Ellis Devereaux Employees' Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Harley Ellis Devereaux (the "Company") who have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Additionally, those participants attaining the age of 50 may make additional catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employees are automatically enrolled in the Plan at a 5 percent deferral rate after 90 days of employment. The Plan includes an automatic escalation feature where participants' deferral percentages are automatically increased 1 percent each year, up to a maximum of 10 percent. The automatic enrollment and automatic escalation features do not apply to employees with a date of hire or reemployment prior to January 5, 2010.

The Company may contribute a discretionary matching contribution equal to a percentage of the eligible contributions made by participants during the year, up to a specified percentage of compensation. Participants are required to be employed as of the last day of the plan year, unless the participant is terminated during the plan year due to death, disability, or retirement, to receive the employer discretionary matching contribution. The Company made discretionary matching contributions equal to 25 percent of the first 8 percent of employee deferrals, up to a maximum of 2 percent of eligible compensation, totaling \$818,396 and \$792,268 for the years ended December 31, 2024 and 2023, respectively.

In addition, the Company may contribute a discretionary nonelective amount that is based on a percentage of compensation determined annually by the board of directors. Participants are required to be employed as of the last day of the plan year, unless the participant is terminated during the plan year due to death, disability, or retirement, to receive the employer discretionary nonelective contribution. The Company made a discretionary nonelective contribution of 0.5 percent of eligible compensation, totaling \$244,087 and \$227,874 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Contributions are allocated to each participant's account based on the participant's elected investment allocation. Plan earnings are allocated to each participant's account in the same ratio as each account bears to the aggregate of all accounts. Plan expenses are allocated to each participant's account, as defined in the Plan. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary, employer discretionary nonelective, and rollover contributions and any income or loss thereon. Participants hired prior to January 1, 2017 are immediately 100 percent vested in employer discretionary matching contributions. For all participants hired after January 1, 2017, a four-year vesting schedule is used for employer discretionary matching contributions. Vesting in the Company's discretionary matching contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in discretionary matching contributions made by the Company 25 percent after one year of service and another 25 percent per year thereafter until they become fully vested after four years of service.

Benefit Payments

Distributions may be payable upon death, disability, termination of service, or retirement. A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installments.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Participant Notes Receivable

Participants may borrow from their accounts up to the lesser of one-half of their vested balances or \$50,000, less the participant's highest outstanding note receivable balance from the preceding 12 months. Notes receivable must be repaid via payroll withholdings for a term generally not to exceed five years. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

Note 2 - Summary of Significant Accounting Policies (Continued)

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. The Plan holds the Fidelity Managed Income Portfolio I Fund and the Fidelity Managed Income Portfolio II Fund, both of which are stable value funds. The funds have certain limitations on withdrawals and exchanges. Participant-directed withdrawals made in order to accommodate distributions to participants or transfers to noncompeting investments may be made on any business day. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur. Non-participant-directed withdrawals directed by a plan sponsor must be preceded by a 12-month written notice to Fidelity Management Trust Company (the "Trustee"). The Trustee, however, may, at its discretion, complete any such plan-level withdrawal before the expiration of such 12-month period. No such notice has been given to the Trustee.

Additionally, the Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded mutual funds, equity securities, debt securities, and a money market fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 22, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company, as the Trustee, holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
