## INDEPENDENT AUDITOR'S REPORT

Hawaii Community Foundation 401(k) Profit Sharing Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hawaii Community Foundation 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B to the financial statements.
- The information in the accompanying financial statements related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Emphasis of Matter – Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B of the financial statements, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO THE FINANCIAL STATEMENTS – MODIFIED CASH BASIS

#### NOTE A – DESCRIPTION OF PLAN

Hawaii Community Foundation (Foundation) established the Hawaii Community Foundation 401(k) Profit Sharing Plan (Plan) on January 1, 2019 through a restatement of the Foundation's money purchase plan that was originally established on January 1, 1989. The Plan was amended effective January 1, 2022. The following is a description of the Plan, which provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

##### General

The Plan is a profit sharing and salary deferral plan (also known as a 401(k) plan) covering substantially all employees of the Foundation who are not members of a collective bargaining unit, a non-resident alien, a leased employee, or an independent contractor. Employees are eligible to make salary deferrals to the Plan from their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

##### Contributions

Participants may make employee salary deferral contributions to the Plan up to the lesser of 100% of their eligible compensation or \$23,000 and \$22,500 in 2024 and 2023, respectively, adjusted annually for the cost of living, plus an additional \$7,500 in 2024 and 2023, for employees age 50 and over. Participants may make rollover contributions to the Plan from another qualified plan.

Each year, the Foundation makes a safe harbor nonelective employer contribution on behalf of each eligible participant, as defined in the plan agreement, in an amount equal to 3% of the participant's compensation earned during the plan year while an active participant. The Foundation will also make a profit sharing contribution equal to 7% of compensation to all participants eligible to share in the allocation. The Foundation may also elect, on a year-to-year basis, to match in whole or in part each employee's salary deferral contribution up to 4% of the participant's compensation. There were no discretionary matching contributions during the years ended December 31, 2024 and 2023. To be eligible for the discretionary matching and profit sharing contributions, participants must be at least 21 years of age and have completed one year of service with at least 1,000 hours of service. Participants must be employed on the last day of the plan year to be eligible for the profit sharing contribution.

Total employee and employer contributions to each participant's account may not exceed the lesser of \$69,000 (\$76,500 with the catch up contribution) in 2024 and \$66,000 (\$73,500 with the catch up contribution) in 2023, or 100% of annual compensation, as defined. Excess contributions are refunded in accordance with provisions of the Internal Revenue Code.

##### Participant Accounts

Each participant's account is credited with the participant's contributions, the safe harbor contribution, and discretionary matching contribution; plus, an allocation based on participant earnings or account balances of the Foundation's profit sharing contribution and the Plan's net earnings; less an allocation for Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### Vesting

Participants are 20% vested in employer discretionary matching and profit sharing contributions, and earnings thereon, after two years of continuous service, 40% after three years of continuous service; 75% after four years of continuous service, and 100% vested after five years of continuous service. The participant's voluntary contributions and the Foundation's safe harbor contributions, and earnings thereon, are always 100% vested.

##### Payment of Benefits

The vested amount in each participant's account is payable upon normal retirement (age 65), disability, death, or termination of employment. Participants are 100% vested upon normal retirement, disability, or death. Participants may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or equal installment payments. For participant account balances less than or equal to \$5,000 (excluding rollover balances), the amount will be distributed in a lump-sum payment.

##### Notes Receivable from Participants and Plan Loans

Participants may borrow a minimum of \$1,000 from their accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have two loans outstanding at any time. The notes receivable and related interest must be paid within five years unless they are used to acquire a principal residence, in which case the repayment period may be extended to 15 years. The notes receivable are collateralized by the balance in the participants' accounts, except for those invested in the VALIC Fixed Account, and bear an interest rate of 1% plus the prime rate at the time the loan was established. The interest rates for loans outstanding as of December 31, 2024 and 2023 were 4.25% to 9.50% and 4.25% to 6.25%, respectively. The notes receivable from participants as of December 31, 2024 and 2023 were for general purposes and not for the purchase of a principal residence. Principal and interest are paid ratably through monthly payroll deductions. The notes receivable from participants mature at various dates through December 2029.

Prior to January 1, 2019, participants could obtain loans through The Variable Annuity Life Insurance Company (VALIC), and had to pledge collateral equal to the outstanding principal from all investments held. The interest rates were based on the prevailing interest rates when the loans were established. The collateral for the loans are maintained in the VALIC Fixed Account. Participants could borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. As the plan loans were issued directly by VALIC, the loans are not shown in the Plan's statements of net assets available for benefits. The loans were not made from plan assets and are, therefore, not considered assets of the Plan. Payments on the loans are made in equal amounts over the loan term by the participant directly to VALIC or through payroll deductions. As of December 31, 2024 and 2023, the balance on such loans amounted to \$46,631 and \$44,987, respectively, of which \$44,396 and \$42,214, respectively, were in default.

##### Withdrawals

Active participants may withdraw all or a portion of their vested account balances as in-service distributions after attaining age 59-1/2, or as hardship withdrawals, by submitting a written application that is approved by the plan administrator. Hardship withdrawals are allowed for participants and their beneficiaries incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service.

##### Forfeitures

Forfeitures may be applied to reduce administrative expenses of the Plan, or to supplement or reduce employer matching contributions. For the years ended December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$0. For the years ended December 31, 2024 and 2023, no forfeited accounts were used to reduce administrative expenses or employer contributions.

#### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

Except for investments, which are accounted for on a fair value basis, the Plan has prepared its financial statements on the basis of cash receipts and disbursements; consequently, certain additions to net assets available for benefits are recognized when received rather than when earned, and certain deductions from net assets available for benefits are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to be presented in accordance with accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates, it is reasonably possible that such estimates may change within the near term, and such differences could be material to the financial statements.

##### Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance. Interest income is recorded when it is received. Related expenses are recorded as administrative expenses and are expensed when paid. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### Payment of Benefits

Benefit payments are recorded when paid.

##### Expenses

Expenses are recognized when the related liability is paid. Fees incurred by the Plan for investment management services are included in the net appreciation in the fair value of investments.

##### Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of registered investment companies includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### NOTE C – CERTIFICATIONS FROM QUALIFIED INSTITUTIONS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments in registered investment companies, pooled separate accounts, insurance contracts, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest for the years ended December 31, 2024 and 2023, were derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company LLC (John Hancock) and VALIC, the qualified institutions of the Plan, as of and for the years ended December 31, 2024 and 2023.

#### NOTE D – FAIR VALUE MEASUREMENTS

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation methodologies used to measure fair value. There are three levels of the fair value hierarchy. Level 1 inputs to the valuation methodologies consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Level 3 inputs are unobservable and significant to the fair value measurement. The fair value measurement level of an asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation methodologies used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments in registered investment companies are valued at quoted market prices, which is a Level 1 measurement. Investments in pooled separate accounts are valued at net asset value of unit shares held by the Plan at year end. The net asset values, as provided by VALIC, are used as a practical expedient that is based on the underlying assets of the pooled separate accounts, and are not categorized in the fair value hierarchy. At December 31, 2024 and 2023, there were no investments valued using Level 2 or Level 3 measurements. The valuation methodologies described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – GUARANTEED INSURANCE CONTRACT

The Fixed Account Plus (FAP) is a fixed dollar annuity, an investment product offered by VALIC. Contributions to the FAP purchase a contractual or guaranteed amount of future benefits for the participant. Investments in the FAP are secured by the general assets of VALIC and backed by VALIC’s claims-paying ability.

Liquidity restrictions apply to the FAP under the annuity contract used to fund the primary retirement plans such that, transfers are only permitted up to 20% of the participants' FAP balance per year; however, a participant may withdraw the full balance upon separation of service. At December 31, 2024 and 2023, the FAP contract amounted to \$3,396 and \$2,780, respectively. For the years ended December 31, 2024 and 2023, the weighted average rate of interest credited to the benefit responsive contract was 2.00%.

The Plan's ability to receive amounts due in accordance with a fully-benefit responsive contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include amendments to the plan documents including complete or partial plan termination or merger with another plan, bankruptcy of the plan sponsor or other plan sponsor events such as divestiture of a subsidiary that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, and a material amendment to the agreement without the consent of the issuer.

##### NOTE F – TAX STATUS

The Foundation has adopted a prototype non-standardized profit sharing plan of John Hancock Retirement Plan Services LLC. The prototype plan has received an opinion letter dated May 18, 2015 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and, accordingly, further believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The plan administrator evaluated the Plan's tax positions as of December 31, 2024 and 2023 and for the years then ended and determined that the Plan had no uncertain tax positions required to be reported. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for any tax periods.

#### NOTE G – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan's assets are administered by and in the custody of John Hancock and VALIC, as trustee and insurance company, respectively, of the Plan. Millennium Investment & Retirement Advisors, LLC and Raymond James & Associates, Inc. provide advisory services to the Plan. Recordkeeping services are provided by Pension Services Corporation. The determination of the amount and timing of matching and/or discretionary employer contributions made to the trust fund is made by a committee of the Foundation, which also determines the amount and method of benefits paid to participants from the trust fund. Fees incurred by the Plan for investment management are included in net appreciation in fair value of the investments.

#### NOTE H – PLAN TERMINATION

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

#### NOTE I – ADMINISTRATION OF PLAN ASSETS

Certain administrative functions are performed by officers or employees of the Foundation who receive no compensation from the Plan. Certain administrative expenses are paid by the Foundation. Expenses that are paid by the Foundation are excluded from these financial statements.

#### NOTE J – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan and Foundation operate in the State of Hawaii. Local, national, and international events can have severe, adverse effects on economic conditions in Hawaii. These financial statements do not include the adjustments that would result if the Plan were to account for future losses or asset impairments, as the effects on the financial statements of the Plan from such changes in economic conditions are not presently determinable.

**NOTE K – DELINQUENT CONTRIBUTIONS**

During the year ended December 31, 2024, the Foundation made late payments of participant contributions totaling \$26,214, which is disclosed in Schedule H, Line 4a of the Form 5500. The Foundation corrected this issue during the year ended December 31, 2024. During the year ended December 31, 2023, the Foundation made late payments of participant contributions totaling \$1,246, which the Foundation corrected during the year ended December 31, 2023.

**NOTE L – SUBSEQUENT EVENTS**

The plan administrator has evaluated subsequent events through September 24, 2025 which is the date the financial statements were available to be issued, and determined that the Plan did not have any subsequent events requiring adjustment to the financial statements or disclosure in the notes to the financial statements.
