### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Savings and Investment Plan for Employees of Disabled American Veterans, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Savings and Investment Plan for Employees of Disabled American Veterans' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the "Auditor's Responsibilities for the Audit of the Financial Statements" section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2 and for determining that the modified cash basis of accounting is an acceptable presentation for the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **Note 1. Description of the Plan**

***General***

The following description of Savings and Investment Plan for Employees of Disabled American Veterans (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined-contribution plan sponsored by Disabled American Veterans (DAV) who have met certain service requirements, as defined. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Disabled American Veterans Benefit Plan Administration Committee is the administrator of the Plan. Empower Trust Company, LLC and Empower Annuity Insurance Company of America serve as the custodians of the Plan.

***Contributions***

Each year, participants may make elective deferral contributions to the Plan on a 401(k) pre-tax and Roth 401(k) after-tax basis subject to certain Internal Revenue Code (IRC) limitations. Employee rollover contributions are also permitted. An employee can participate simultaneously in the Roth 401(k) after-tax and 401(k) pre-tax; however, the two annual contributions combined cannot exceed their annual maximum for the 401(k) set each year by the IRS. DAV makes a 100% matching contribution up to 6% of compensation to the Plan for all participants, as defined. For employees hired or rehired after 1998, DAV makes an automatic employer contribution of 3% of each eligible employee's compensation.

DAV's National Adjutant, at its discretion, may approve additional contributions to certain participants' accounts each year (leadership award) and this leadership award is funded by DAV subsequent to the Plan year-end. For the 2023 and 2022 Plan years, the Board of Directors (Board) approved a \$229,900 and \$133,816 leadership award, respectively. The Plan received contributions for those awards during 2024 and 2023, respectively. There was no leadership award for the 2024 Plan year.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, DAV's contributions and Plan earnings and is charged with withdrawals, loan execution costs and an allocation of plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in DAV's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after two years of continuous service. Forfeited balances of terminated participants are used to restore forfeitures and reduce future DAV contributions.

***Notes Receivable From Participants***

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is based on local prevailing rates as determined by the Plan Administrator. All loans are repayable over a period not to exceed five years (except for loans for the purchase of a primary residence). Principal and interest is paid ratably through monthly payroll deductions.

***Payment of Benefits***

Participants with a 401(a) balance may elect to receive cash withdrawals in the case of hardship, attainment of age 59½, unintended automatic salary deferral, or a qualified reservist distribution. Three withdrawals are permitted in any 12-month period.

Participants investing in the 401(k) pretax option and the Roth 401(k) after-tax option upon reaching age 59½, retirement, termination, disability or death may elect to receive either a lump-sum amount equal to the participant's vested interest in his or her account or elect a direct rollover. In addition, participants in the Roth 401(k) after-tax option upon holding the funds for five years can withdraw all Roth 401(k) after-tax funds tax-free, and beneficiaries receive benefits tax-free.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$58,998 and \$78,680, respectively. These accounts will be used to restore forfeitures or to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$53,637 from forfeited nonvested accounts (none in 2023).

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

Investments held by a defined-contribution plan are required to be reported at fair value; unrealized appreciation and depreciation in the fair value of investments is recognized in the period of change. Certain additions and the related assets are recognized when received rather than when earned. Certain deductions are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements (modified cash basis) are not intended to present net assets available for benefits and the changes in net assets available for benefits in conformity with accounting principles generally accepted in the United States of America (GAAP), but on an other basis of accounting prescribed or permitted by the United States Department of Labor.

***Use of Estimates***

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend investment income are recorded on the cash basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by DAV or the Plan, at DAV's discretion.

**Note 3. Certification of Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company LLC and Empower Annuity Insurance Company of America, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan has an investment in a fixed annuity contract offered by Empower Annuity Insurance Company of America, one of the custodians as defined by the Plan agreement. Therefore, this transaction qualifies as a party-in-interest transaction.

Fees paid by the Plan for investment services are included as a reduction of the return earned on each fund. In addition, administrative and portfolio management fees of \$163,042 are paid to certain affiliates of the custodian. DAV provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan held no Level 3 securities at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices in an active market.

*Fixed annuity contract:* The guaranteed annuity contract is an investment contract with Empower Annuity Insurance Company of America, one of the custodians. This investment is valued at contract value which approximates fair value. Contributions become part of the Empower Annuity Insurance Company of America's general account and there are no particular segregated or identifiable assets ascribed to the Plan's investment.

Crediting rates for the investment are set by Empower Annuity Insurance Company of America using a process similar to that used by banks or other insurance companies for similar products.

Certain events may limit the ability of the plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, DAV has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions and the trustee may commence payment of benefits, pursuant to the terms of the Plan Document.

**Note 7. Tax Status**

The IRS has determined and informed DAV by a letter dated October 2, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan is also exempt from Puerto Rico (PR) income taxes under the provisions of the PR IRC. The Plan Document has been amended since the Plan received the determination letter.

However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in accordance with the applicable requirements of the IRC and the Plan and related trust to continue to be tax-exempt.
