Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audit of the accompanying financial statements of Spooner Risk Control Services, Inc. Multiple Employer 401(k) Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance accounting principles generally accepted in America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.



NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Spooner Risk Control Services, Inc. Multiple Employer 401(k) Profit Sharing Plan (the "Plan") established March 1, 2014, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan allows related companies (related through common ownership of its shareholders or members) to adopt its provisions. The related companies who have adopted the provisions of the Plan are Spooner Risk Control Services, Inc., Spooner Incorporated, Spooner Medical Administrators, Spooner HR Solutions, Inc., and Spooner Return to Work, Inc.

General

The Plan is a multiple employer participant-directed defined contribution plan covering substantially all employees of Spooner Risk Control Services Inc., (the "Plan Sponsor") and the other related companies listed above who have adopted the provisions of the Plan. Employees, who have worked one year, have attained the age of 18 within the plan year, and meet certain eligibility requirements are able to participate in the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

An employee may elect to defer pre-tax and Roth post-tax contributions in 1% increments or a defined flat dollar amount per pay period with a maximum established by Internal Revenue Code ("IRC") December 31, 2024 and 2023. In addition, the Plan permits catch-up contributions by participants who have attained age 50 by December 31 of each year.

The Plan Sponsor may make discretionary matching and "safe harbor" matching contributions. The Company made a discretionary "safe harbor" matching contribution equal to 100% of participants' pre-tax contribution up to 3% of pay and an additional discretionary matching contribution equal to 50% of participants' pre-tax contribution on the next 2% (up to 5% of pay). In addition, each year the Plan Sponsor determines, at its discretion, an amount, if any, to be contributed out of current and accumulated profits. Contributions are subject to maximum annual limits as defined by various laws and regulations.

Participant Accounts

The allocation of a participant's contributions to the investment funds is selected by the participant and may be changed daily. Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also vested immediately in the Plan Sponsor contribution portion of their accounts plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, and up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Loan terms may not be greater than five years, unless the loan qualifies as a "home loan". Principal and interest is paid ratably through monthly payroll deductions. All expenses associated with establishing and administering loans are paid by or charged to the participant's account.

Principal and interest payments are made through payroll withholding according to each note's term per the promissory note.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Accounts of terminated participants with balances under \$5,000 will be distributed in a single lump-sum payment to the participant.

In the event of financial hardship, participants may apply to receive a distribution from their fund accounts, subject to IRS mandated rules for hardship withdrawals. The participant will not be allowed to make salary deferral contributions for a period of six months after receiving a hardship distribution.

Forfeitures

At December 31, 2024 and 2023 forfeited unallocated accounts totaled \$0. Forfeitures of \$0 and \$4,308 were deposited in the uninvested cash balances of the Plan during the years ended December 31, 2024 and 2023, respectively, which may be used to restore participant forfeitures, pay Plan expenses, or reduce future employer contributions. The Plan elected to apply a portion of forfeitures to pay Plan expenses.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants represent participant loans and are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Repayments of principal and interest are recognized in the period in which payroll deductions are processed. Participants can have no more than two outstanding loans at one time.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value at December 31, 2024 and 2023.

Investment income consists of interest income. The net appreciation (depreciation) in the fair value of investments consists of realized gains or losses and any unrealized appreciation (depreciation) on those investments. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported based on historical cost.

Fair Value of Financial Instruments

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect these estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is as least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

The Plan pays expenses incurred in the administration of the Plan, unless otherwise paid by the Plan Sponsor. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net (depreciation) appreciation of fair value of investments.

Income Taxes

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan files the United States Federal Form 5500 annually.

Subsequent Events

The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

NOTE 4 - INVESTMENTS

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Mutual funds: Valued at the net asset value of shares held by the Plan at year end.
- Money market funds: Valued based on the underlying investments traded on the active market.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Plan Sponsor adopted a Non-Standardized Pre-Approved Profit Sharing Plan ("the Pre-Approved Plan") on March 1, 2014. The Pre-Approved Plan obtained its latest opinion letter on December 31, 2018, in which the IRS stated that the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Pre-Approved Plan has been amended, however, the Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Custodian and, therefore, these transactions are party-in-interest transactions. Fees paid by the Plan for the investment management and administrative services amounted to \$64,053 and \$61,142 for the years ended December 31, 2024 and 2023, respectively. There are also indirect fees deducted directly from investment earnings of the Plan.
