Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MBF Inspection Services, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Notes to Financial Statements
December 31, 2024 and 2023

1) Description of Plan

The following description of MBF Inspection Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan and was adopted by MBF Inspection Services, Inc. (the “Employer”). The Employer serves as the Plan administrator. The Plan covers substantially all employees, excluding collectively bargained employees, non-resident aliens, and leased employees, upon their date of hire and who are age 21 and over. Employees are eligible to receive Employer contributions after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Upon enrollment in the Plan, participants direct the investment of all contributions in a variety of investment options offered by the Plan. Employee pre-tax or after-tax Roth contributions may be made up to the maximum limits of Section 402(g) of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The amounts contributed may not exceed the maximum amount deductible under the limitations prescribed by law.

For 2024 and 2023, the Employer made safe harbor matching contributions which are fully vested. The Employer matched 100% of the first 3% and 50% of the next 2% of active eligible participants’ compensation contributed to the Plan.

The Plan also allows for a discretionary profit sharing contribution and a discretionary matching contribution. The Employer made no discretionary profit sharing or matching contribution for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer contributions, and allocations of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon and the Employer’s safe harbor matching contributions plus actual earnings thereon. Vesting in the Employer’s discretionary profit sharing contribution and discretionary matching contribution is based on years of continuous service.

Notes Receivable from Participants

The Plan does not permit notes receivable from participants.

Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. A participant may withdraw all or a portion of their pre-tax deferral account in the event of financial hardship, as defined in the Plan.

Mandatory Cash-Out Provision

Upon termination of employment for any reason, if the amount of the participant’s vested account balance is less than or equal to \$5,000, the Employer will automatically roll over the balance to an individual retirement account without the consent of the participant unless the participant elects a single lump sum cash distribution.

Forfeitures

Forfeitures of terminated participants’ nonvested account balances may be used to pay Plan administrative expenses or to offset Employer contributions.

As of December 31, 2024 and 2023, unallocated and nonvested forfeited amounts totaled \$0. During 2024 and 2023, no forfeitures were used to pay administrative expenses or offset Employer safe harbor matching contributions.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. For the years ended December 31, 2024 and 2023, the Employer paid a portion of the costs of Plan administration. Such expenses are not included in these financial statements. Fees paid for investment management services are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through September 19, 2025, the date which the financial statements were available to be issued.

3) Investments and Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures* provide the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Shares of registered investment companies (mutual funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds: Primarily invests in direct obligations of the U.S. treasury, U.S. government agencies, repurchase agreements and money markets with maturities of 13 months or less which have observable pricing inputs, including quoted prices for similar assets in active or non-active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4) Information Prepared and Certified by the Custodian (Unaudited)

- Investments reflected on the supplemental schedule of assets held at end of year as of December 31, 2024.

5) Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA provisions. In the event of the Plan termination, participants would become 100% vested in all their Employer contributions.

6) Tax Status

The Plan is operating as a tax exempt plan under a prototype document with a non-standardized adoption agreement. The Internal Revenue Service (IRS) has determined and informed the prototype plan sponsor by letter dated June 30, 2020, that the prototype plan, as then designed, is in compliance with applicable sections of the IRC. The Plan is relying on the opinion letter of the prototype sponsor. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes the Plan is no longer subject to income tax examinations for years prior to 2021.

7) Party-in-Interest and Related-Party Transactions

Certain investments are managed by Mid Atlantic Trust Company, the custodian of the Plan. These transactions qualify as exempt party-in-interest transactions.

The Employer provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged. For the years ended December 31, 2024 and 2023, fees paid by the Plan for administrative expenses, such as third-party recordkeeping fees were \$42,837 and \$30,578, respectively.
