INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
Service Employees International Union
Supplemental Retirement Savings 401(k) Plan

Opinion

We have audited the accompanying financial statements of the Service Employees International Union Supplemental Retirement Savings 401(k) Plan (the Plan), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Service Employees International Union Supplemental Retirement Savings 401(k) Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.





In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.


Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Service Employees International Union Supplemental Retirement Savings 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The effective date of the Plan was January 1, 1997. The Plan is a defined contribution/profit-sharing plan, commonly referred to as a 401(k) plan, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers employees of participating employers other than an employee who is covered by a collective bargaining agreement that does not provide for coverage under the Plan, or an employee employed outside the United States and its territories. Participating employers are the Service Employees International Union (SEIU), who is also the Plan sponsor, and the SEIU National Industry Pension Fund.

Contributions and Vesting - Eligible participants may become active in the Plan by electing to make a pretax contribution to the Plan of up to 25% (increased from 15% effective June 1, 2002) of annual salary. Effective June 1, 2022, the Plan was amended to accept Roth contributions. Deferral rules for Roth contributions are the same as used for pre-tax deferrals under the plan.

Annual salary is defined as the amount of base weekly pay, without taking into account bonuses, lump-sum payments, or overtime pay. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). All participants are 100 percent vested in their accounts.

Participant-Directed Investment Accounts - The contributions made by an individual participant are added to the separate account established in each participant's name for each investment option they have selected. These participant-directed investment accounts also receive a proportionate share of the net income, gains and losses generated by each respective investment option. Participants may transfer amounts in their account between funds at any time.

Contributions to the Plan are invested as directed by the participant in various pooled separate accounts, mutual funds and an insurance company contract fund. Participants must evaluate their own investment goals and objectives and choose the investment that is best suited to achieve those goals and objectives.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants - The Plan permits participants to borrow a minimum of \$1,000 up to a maximum of 50% of their total vested balance. A participant may never borrow more than \$50,000 minus the highest outstanding balance on any individual loan during the last 12 months. Each loan is treated as a directed investment of the participant, and all loan repayments are credited to the participant's selected investment options. All loans carry a reasonable rate of interest based on prevailing interest rates for similar loans and generally require repayment within 5 years.

Distributions - Distributions are made upon termination of employment, financial hardship, permanent disability, retirement or death, as provided for under the Plan Document.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Loans to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits - Benefits are recorded when paid.

Corrective Distributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding deduction of corrective distributions. The Plan distributed the excess contributions to the applicable participants prior to March 31 of each subsequent year.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3. PLAN TERMINATION

The Plan may be terminated at any time by the Plan sponsor. In the event of termination, participants or their beneficiaries will receive the balances in their participant-directed investment accounts after all Plan expenses have been paid.

NOTE 4. TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated July 7, 2010, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal jurisdiction and the various states and local jurisdictions in which the Plan files returns. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's investment in the pooled separate accounts category is comprised of several investments. Underlying assets in these funds primarily include publicly traded equity securities and fixed income securities and are valued at their NAVs calculated by the fund sponsor and have daily or monthly liquidity.

NOTE 6. EMPOWER GUARANTEED INCOME FUND

The Plan invests in the Guaranteed Income Fund (GIF), a general account group annuity contract issued by Empower Annuity Insurance Company of America. The contract is considered a fully benefit-responsive investment contract and is therefore reported at contract value in the statements of net assets available for benefits.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of this plan. Under this contract, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Contract value is also often referred to as book value.



NOTE 6. EMPOWER GUARANTEED INCOME FUND (CONTINUED)

The contract is affected directly between the Plan sponsor and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or contract value paid overtime. There are not any events that allow the issuer to terminate the contract and which require the Plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.

The contract value of the investment contracts at December 31, 2024 and 2023 was \$3,197,788 and \$2,964,063, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 7. ADMINISTRATIVE EXPENSES, RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Expenses of maintaining the Plan are paid by the SEIU and the Plan. The Plan pays certain administrative, investment and professional fees to various service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Administrative expenses paid by the SEIU are not included in these financial statements.

Certain plan investments, including notes receivable from participants, are managed by Empower (formerly Prudential). Empower is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

Investment fees paid by the Plan to Empower for the years ended December 31, 2024 and 2023 were \$39,574 and \$26,467, respectively.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.



NOTE 9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

A reconciliation from the financial statements to the Form 5500 is necessary to explain differences in the financial data reported under U.S. generally accepted accounting principles and the Form 5500's requirements.
