## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the  
Northern California Golf Association/  
Poppy Holding, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Northern California Golf Association/Poppy Holding, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Basis for Opinion

### 1. Description of Plan

The following description of the Northern California Golf Association/Poppy Holding, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was adopted by the Northern California Golf Association (the "Association") on January 1, 1995, and was most recently amended on January 5, 2025 (see Note 10). The Plan includes participants from Northern California Golf Association and its wholly-owned subsidiary, Poppy Holding, Inc. (Poppy Ridge and Poppy Hills). The Plan is a defined contribution plan with a salary deferred arrangement qualified under appropriate provisions of the Internal Revenue Code ("IRC") and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and certain provisions of the IRC.

#### **Eligible Participants**

Employees who are at least 21 years of age are eligible to participate in the Plan after completing one year of service in which they have worked at least 1,000 hours. Certain classes of employees are excluded from the Plan (see the Plan document for the specific Plan exclusions). Employees may become eligible participants on the first day of each month following completion of eligibility requirements.

#### **Plan Administration**

The Association is the administrator of the Plan. As administrator, the Association has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan, including the authority and responsibility to invest, manage, and control the assets of the Plan specifically allocated to the trustee. Fidelity Management Trust Company ("Fidelity") is the appointed trustee for the Plan and acts at the direction of the Plan's administrator. The Association paid the majority of all necessary and proper expenses incurred in the administration of the Plan. Such expenses were primarily comprised of legal fees and expenses relating to the maintenance of the Plan's records.

#### **Contributions**

Employees are automatically enrolled into the Plan at 4% of eligible compensation with 1% annual increase up to 10% of eligible compensation unless they opt out, and will be enrolled into the Plan 30 days following the date of eligibility. Participants may contribute up to 88% of their eligible compensation up to the limits imposed by Section 402(g) of the IRC. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Association may make an annual matching contribution, not to exceed 50% of the participant's deferral contribution up to 10% of the employee's compensation. The Association may also make a discretionary profit sharing contributions. All participants of the Plan are eligible, but each employee is their own group. The Association made a matching contribution of approximately \$351,400, net of forfeitures and a discretionary profit sharing contribution \$1,019,500 for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, Plan earnings or losses, and rollovers from other qualified plans. Plan earnings or losses are allocated based upon each participant's account balance. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

***Vesting***

Participant contributions, rollovers and net earnings on these contributions are fully vested when made or earned.

Discretionary employer matching and profit sharing contributions, if any, as well as all earnings on these contributions vest according to the following schedule:

***Participant Notes Receivable***

Participants may borrow from their fund accounts a minimum of \$1,000 up to 50% of the value of their vested account balance, or \$50,000, whichever is less. Loan terms range from one to five years, except for loans used to purchase a primary residence, which have a maximum term of thirty years. There is a historic loan on the books prior to the change in loan terms, which was previously due in 30 years and matures in 2036. Participants are allowed two outstanding loans at a time. Loans are secured by no more than 50% of the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the loan originates. Interest rates on participant notes receivable as of December 31, 2024 were 4.25% to 9.50% per annum. Principal and interest are paid in equal installments through semi-monthly payroll deductions.

***Payment of Benefits***

When participants leave the Association upon retirement or for any other reason, those participants (or their beneficiaries) may receive the full value of their salary deferrals, rollovers, vested employer contribution, and the net earnings thereon in a single lump-sum payment. Financial hardship distributions are available for certain immediate and heavy financial needs. Participants should refer to the Plan document for the specific needs that qualify for a financial hardship distribution.

***Payment of Benefits***, continued

In order to receive distributions, participants (or their beneficiaries) are required to file the appropriate forms with the Plan administrator. Account values will be determined as of the day the distribution is made.

Distributions under the Plan shall generally be made as soon as possible after the date of retirement, date of death, or termination of employment. In the event of a mandatory distribution greater than \$1,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an Individual Retirement Account designated by the Plan administrator.

***Investment Options***

Upon enrollment in the Plan, a participant may direct his or her contributions in percentage increments into a series of mutual funds and a common/collective trust offered by the Plan. Participants may change their investment options at any time.

***Forfeitures***

Forfeitures that occur during a Plan year will be used to reduce the Association's matching and/or profit sharing contributions or to pay Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$3,700 and \$2,900, respectively. Approximately \$51,000 of forfeitures were used to reduce the Association's matching contributions for the year ended December 31, 2024.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") and ERISA.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities, and changes in net assets available for benefits. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

***Payment of Benefit***

Benefit payments are recorded when paid.

**3. Certified Information**

**4. Fair Value Measurements**

Accounting standards for fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these accounting standards are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Cash equivalents:* Valued based on redemption values on the last business day of the Plan year.

*Preferred stocks, common stocks, corporate bonds and U.S. government securities:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments in mutual market funds are managed by Fidelity. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As of December 31, 2024, the balance of the RCP account was approximately \$15,500. Effective September 1, 2024, the adoption agreement was amended to remove the Fiduciary Addendum to remove ERISA spending account provision relating to participant allocations.

**6. Tax Status**

The Plan has adopted a prototype Plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020. The Plan document has been amended since receiving that opinion letter. However, the Plan administrator and sponsor believe that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC and ERISA, and that the trust, which forms a part of the Plan, is exempt from income tax. Accordingly, no provision has been made for federal and state income taxes.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**8. Risks and Uncertainties**

The Plan holds various types of investments. Investment securities are exposed to various risks, such as interest rates, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the various risk factors will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

As of December 31, 2024, there were three funds that held 16%, 11% and 10% of the Plan's net assets.

As of December 31, 2023, there were three funds that held 14%, 14% and 11% of the Plan's net assets.

**10. Subsequent Events**

- Effective January 5, 2025 the plan was amended to include partial withdrawals as a form of distributions.

Effective July 1, 2025, Youth on Course ("YOC") spun off from NCGA. On July 15, 2025 amounts of \$3,151,063 were transferred out of the Plan into the YOC plan. The YOC spin-off included 27 employees, which included 17 participants with account balances.

In accordance with accounting standards affecting disclosures of subsequent events, the Plan evaluated subsequent events for recognition and disclosure through August 6, 2025, the date which these financial statements were available to be issued. Management concluded that, other than above, no material subsequent events have occurred since December 31, 2024 that require recognition or disclosure in these financial statements.
