**NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of The Herring IMPACT Group Employees 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan, established January 1, 1992, is a defined contribution plan covering eligible employees of The Herring IMPACT Group LLC (the Plan Administrator or Plan Sponsor) and eligible employees of TdD Attorneys At Law, LLC (collectively, the Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Charles Schwab Trust Bank is the Plan's custodian and EPIC Retirement Plan Services (EPIC) is the Plan's recordkeeper.

**Eligibility**

The Plan covers substantially all employees of the Employers who have attained the age of 21. Employees can begin participating on the first day of each calendar month after satisfying the eligibility requirements. Participation is voluntary.

**Contributions**

Each year, participants may contribute up to the maximum allowed under the Internal Revenue Service (IRS). Contributions may consist of both pre-tax and Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employers may make discretionary matching contributions. For the years ended December 31, 2024 and 2023, The Herring IMPACT Group LLC matched 100% of the first 3% of compensation that a participant contributed to the Plan. For the years ended December 31, 2024 and 2023, TdD Attorneys At Law, LLC made discretionary matching contributions of \$20,030 and \$13,267, respectively.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employers' contributions, and allocations of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Forfeitures**

Participants who terminate their employment and are less than 100% vested in their account will forfeit their nonvested portion. Forfeitures may be used to reduce future Employers' contributions or to pay Plan expenses. Forfeitures available for use amounted to \$2,472 at December 31, 2024. No forfeitures were available for use at December 31, 2023. Forfeitures used to pay Plan expenses amounted to \$4,565 and \$3,867 for the years ended December 31, 2024 and 2023, respectively.

**Participant Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in Employers matching contributions is based on a six-year graded vesting schedule. Participants are 20% vested after two years of service, increasing 20% each year thereafter, becoming fully vested after six years of service. Effective October 2024, participants are 25% vested after one year of service, increasing 25% each year thereafter, becoming fully vested after four years of service. Participants also become fully vested upon reaching early retirement date, death or total and permanent disability.

**Payment Of Benefits**

Participants are eligible for normal retirement upon reaching age 65. Participants are eligible for early retirement upon attaining age 55 and one year of service. Participants who have reached a benefit event (e.g. death, disability, retirement or termination) may elect to receive an amount equal to the vested value of their account in a lump-sum distribution. Distributions are subject to the applicable provisions of the Plan Document.

**In-Service Distributions**

Active participants who reach age 59-1/2 or experience a qualifying financial hardship may withdraw all or part of their vested accounts. Hardship withdrawals will be approved only if they conform to Plan provisions and established IRS safe harbors.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by law are recorded as a liability with a corresponding reduction in contributions. There were no excess contributions recorded for the plan year ended December 31, 2024 and 2023.

**Administrative Expenses**

The Plan pays substantially all administrative expenses, including custodial fees, investment advisory fees, transaction fees and recordkeeping fees.

**Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation And Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date. The change in fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized gains and losses and unrealized appreciation and depreciation.

**Payment Of Benefits**

Benefits are recorded when paid.

**3. Certified Investment Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by the Custodian, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Custodian that the information provided to the Plan Administrator related to the following information is complete and accurate. This information has not been audited by the Plan's independent auditors.

The Plan follows an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Investment Trusts**

Valued at the NAV of units of a collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**7. Income Tax Status**

The Plan was amended and restated effective April 1, 2021, through the adoption of a pre-approved defined contribution plan document sponsored by EPIC. EPIC obtained an opinion letter dated June 30, 2020, in which the IRS stated that the pre-approved plan document is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter. The Plan has been amended since the date of the pre-approved plan document. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Party In Interest Transactions**

The Plan pays fees to various service providers related to operations of the Plan. These transactions qualify as exempt party in interest transactions under ERISA.
