## **INDEPENDENT AUDITORS' REPORT**

To the Trustees

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Projection, Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Projection, Inc. 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion on the Financial Statements**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. **1. DESCRIPTION OF PLAN**

The following description of the Projection, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan, which was established in 1983, is a defined contribution plan covering all eligible employees of Projection, Inc. (the Corporation), its affiliated corporations, and Projection Video, Inc. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Corporation has the responsibility for remittance of participant and employer contributions, appointing an administrator to administer the Plan, and determining funds available for investment under the Plan. Projection, Inc. pays for a portion of the administrative expenses. An annual Plan administrative expense of approximately 0.4 percent is applied to each participant's account balance on a monthly basis. Principal Financial Group provides administrative services for the Plan. Plan administrative expenses include items such as recordkeeping, participant website access, participant statements, Plan compliance services and financial professional services.

**Eligibility Requirements**

All full-time employees become eligible to participate in the Plan on the first day of the month following the completion of 1 month of eligible service and attainment of age 18.

Part-time, seasonal, and temporary employees who are regularly scheduled to work less than 1,000 hours in a 12-month eligibility period are generally excluded from the Plan. Part-time, seasonal, and temporary employees who are regularly scheduled to work less than 1,000 hours in an eligibility period are excluded from the Plan. Beginning in 2024, long-term, part-time employees who complete at least 500 hours of service in three consecutive 12-month periods and have attained age 18 are eligible to participate in the Plan. If a part-time, seasonal, or temporary employee either meets the 1,000-hour threshold in a 12-month eligibility period or changes to full-time status, the employee will become eligible to participate in the Plan on the first day of the month following the completion of 1 month of eligible service and attainment of age 18.

**Contributions**

Each year, participants may elect to contribute a percentage of annual compensation as defined in the Plan, as pre-tax 401(k) or Roth contributions to the Plan. The Plan automatically enrolls eligible participants for a 6 percent pre-tax salary deferral under its automatic enrollment feature, unless the participant elects to increase/decrease the amount or signs an enrollment form declining to participate. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts, a common/collective trust, and mutual funds as investment options for participants. The Corporation may make discretionary contributions and/or matching contributions determined annually by the Corporation's Board of Directors. The Corporation did not make a contribution for 2024 or 2023. Contributions are subject to certain limitations.

The Plan automatically increases each participant's deferral percentage by 1 percent per year on January 1 of each year until his or her contribution percentage equals 9 percent. Participants are given the opportunity to decline participation or increase/decrease the percentage.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Corporation's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or individual account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Corporation's matching and discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest 20 percent per year of service after two years of service, and are 100 percent vested after six years of service.

An employee is 100 percent vested if termination is due to retirement (65th birthday), early retirement as defined in the Plan, disability or death.

**Notes Receivable from Participants**

Participants may borrow up to the lesser of \$50,000 minus the difference between the highest outstanding balance of loans during the one-year period ending on the day before the new loan is made, or 50 percent of the participant's vested account balance.

Loan terms range anywhere from 0 to 5 years, or up to 30 years for the purchase of a primary residence, and bear interest from 5.25 to 10.50 percent. The loans are secured by the vested balance in the participant's account. Principal and interest are paid ratably through biweekly payroll deductions. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive the value of the participant's vested interest in his or her account either as a lump sum amount, a systematic withdrawal plan, or by the purchase of an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeited Accounts**

There was a zero balance in the forfeiture account for 2024 and 2023. Forfeitures were not used to reduce the amount of administrative expenses paid by Projection, Inc. for the years ended December 31, 2024 and 2023.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The accounting and reporting policies used in the financial statements conform to U.S. generally accepted accounting principles. The significant policies are summarized below.

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Financial Statement Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

As permitted by accounting principles generally accepted in the United States of America, the Plan uses net asset value (NAV) as a practical expedient to determine the fair value of certain investments that do not have a readily determinable fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Taxes**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Corporation. Expenses that are paid by the Corporation are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.

**3. CERTIFIED FINANCIAL INFORMATION**

Certain information related to investments disclosed in the accompanying financial statements as of December 31, 2024 and 2023, the ERISA-required supplemental schedule of Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and the Delaware Charter Guarantee and Trust Company conducting business under the trade name Principal Trust Company, a member of the Principal Financial Group (collectively "Principal"), the custodian of the Plan. Notes receivable from participants and interest earned on notes receivable were certified by Principal for the year ended December 31, 2024, but were not certified for the year ended December 31, 2023.

**4. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value focuses on the price that would be received to sell the asset or paid to transfer the liability regardless of whether an observable liquid market price existed (an exit price). The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – inputs to the valuation methodology are based upon unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability, and market-corroborated inputs. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 assets and liabilities measured at fair value are based on one or more of three valuation techniques (market, cost, or income approach). The market approach evaluates prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities. The cost approach evaluates the amount that would be required to replace the service capacity of an asset (i.e., replacement cost). The income approach uses techniques that convert future amounts to a single present amount based on market expectations (including present value techniques, option-pricing models, and lattice models).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV, based on quoted market prices in active markets, of shares of the underlying assets held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value.

*Stable value common/collective trust fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the common/collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. RELATED PARTY TRANSACTIONS**

Principal Financial Group is the Plan's custodian. Plan assets include investments in pooled separate accounts and a common/collective trust, which are managed by Principal Financial Group. As Principal Financial Group is the Plan's custodian, transactions with the custodian qualify as party-in-interest transactions under ERISA. Fees incurred by the Plan for the investment management services are made directly to the custodian. These expenses are presented as administrative expenses on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**7. TAX STATUS**

Effective March 11, 2022, the Plan adopted a Non-standardized pre-approved profit sharing plan with CODA with an opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the Plan and related Trust qualify under the applicable provisions of the Internal Revenue Code (IRC), and are exempt from Federal income taxes.

The Plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in a combination of investment securities that are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
