Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### ***Opinion***

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

### Note 1 – Description of Plan

The following description of the Boiling Point Group, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of plan provisions.

**General** – The Plan was established on July 1, 2014, for the benefit of the employees of Boiling Point Group, Inc. and its three subsidiaries: Boiling Point Restaurant (N.CA), Inc.; Boiling Point Restaurant (S.CA), Inc.; and Boiling Point Restaurant (WA), Inc. (collectively the “Company”). The Plan is a defined contribution plan covering substantially all employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company is the Plan’s sponsor and serves as plan administrator.

**Eligibility** – Employees of the Company are eligible to participate in the Plan upon reaching age 21 and after completing one year of service in which 1,000 hours are worked. The Plan considers service with the following affiliates of the Company credited service towards the Plan when considering eligibility: Boiling Point Services, Inc.; Boiling Point Partners II, Inc.; and Boiling Point Corporation, Inc., a Washington Corporation. Employees may begin participating under the Plan once they have satisfied the eligibility requirements and reached the entry date of January 1 or July 1.

### Contributions

*Participant contributions* – Each year, participants may contribute between 1% and 100% of pre-tax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

*Employer safe harbor matching and discretionary non-elective contributions* – The Company makes safe harbor matching contributions equal to 100% of employee contributions up to the first 3% of eligible compensation, plus 50% of employee contributions up to the next 2% of eligible compensation deferred to the Plan. The Company may elect to make discretionary non-elective contributions to the Plan. Discretionary non-elective contributions are allocated to participants in the same proportion as a participant’s compensation bears to the total of all participants’ compensation. There were no discretionary non-elective contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant’s account is credited with the participant’s contributions and Company safe harbor matching contributions as well as allocations of the Company’s discretionary non-elective contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** – Participants are fully vested in their contributions plus actual earnings thereon and the Company’s safe harbor matching contribution portion of their accounts. Participants vest in the Company’s discretionary non-elective contributions based on the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
At least 2, but less than 3	20%
At least 3, but less than 4	40%
At least 4, but less than 5	60%
At least 5, but less than 6	80%
6 or more	100%

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time. Under the terms of the Plan Agreement, plan loans will bear a reasonable rate of interest determined to be 2% above the prime rate. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rate of interest on the outstanding loan was from 6.75% to 10.50%, maturing through December 2029.

**Payment of benefits** – On termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Terminated employees with balances less than \$5,000 are subject to automatic distribution as soon as administratively feasible upon termination.

**Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and may be used to pay plan administrative expenses or to reduce future Company contributions. There were no forfeitures as of December 31, 2024 and 2023. No forfeitures were used during the year ended December 31, 2024.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value. The Plan’s trustee, John Hancock Life Insurance Company (U.S.A.) (John Hancock), certifies the fair market value of investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to participant-elected transactions are deducted from the gross amount paid. Investment-related expenses are included in net appreciation in fair value of investments.

**Subsequent events** – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 4, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Pooled separate accounts* – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. As of December 31, 2024, there were no unfunded commitments or redemption restrictions on the PSAs.

John Hancock PSAs held under the Plan as of December 31, 2024 and 2023, invest solely in the respective publicly traded mutual funds. Investment strategies for PSAs held by the Plan are as follows:

Reliance MetLife Stable Value PSA invests solely in Reliance MetLife Stable Value Fund. The investment seeks to preserve principal and accumulated interest.

Wells Fargo Special Mid Cap Value Fund PSA invests solely in the Wells Fargo Special Mid Cap Value Fund. The investment seeks long-term capital appreciation.

PIMCO Income Fund PSA invests solely in the PIMCO Income Fund. The investment seeks to maximize current income and long-term capital appreciation as a secondary objective.

PGIM Total Return Bond Fund PSA invests solely in PGIM Total Return Bond Fund (Class Z). The investment seeks total return.

PGIM Global Total Return Fund PSA invests solely in PGIM Global Total Return Fund (Class Z). The investment seeks total return, made up of current income and capital appreciation.

DFA Inflation-Protected Securities Fund PSA invests solely in the DFA Inflation-Protected Securities Portfolio. The investment seeks to provide inflation protection and earn current income consistent with inflation-protected securities.

JP Morgan Equity Income Fund PSA invests solely in the JP Morgan Equity Income Fund (Class R5). The investment seeks to provide capital appreciation and current income.

TIAA-CREF Equity Index Fund PSA invests solely in the TIAA-CREF Equity Index Fund. The investment seeks to provide long-term total return, mainly through capital appreciation, by investing primarily in a portfolio of equity securities selected to track the overall U.S. equity markets based on a market index.

TIAA-CREF Small-Cap Blend Index Fund PSA invests solely in the TIAA-CREF Small-Cap Blend Index Fund (Institutional Class). The investment seeks to provide long-term total return, mainly through capital appreciation.

Invesco Global Fund PSA invests solely in Invesco Global Fund (Class Y). The investment seeks capital appreciation.

Science and Technology Fund PSA invests solely in the JHVIT – Science and Technology Trust (Class 1). The investment seeks long-term growth of capital and current income is incidental to the portfolio's objective.

New World Fund PSA invests solely in the New World Fund (Class R6). The investment seeks long-term capital appreciation.

Fidelity Mid Cap Index Fund PSA invests solely in the Fidelity Mid Cap Index Fund (Institutional Class). The investment seeks to provide investment results that correspond to the total return of stocks of mid-capitalization United States companies.

Fidelity International Index Fund PSA invests solely in the Fidelity International Index Fund (Institutional Class). The investment seeks to provide investment results that correspond to the total return of foreign stock markets.

American Funds EuroPacific Growth Fund PSA invests solely in the American Funds EuroPacific Growth Fund (Class R5). The investment seeks long-term growth of capital.

Cohen and Steers Real Estate Securities Fund PSA invests solely in the Cohen and Steers Real Estate Securities Fund (Class A). The investment seeks total return through investment in real estate securities.

Blue Chip Growth Fund PSA invests solely in the John Hancock Funds II – Blue Chip Growth Fund (Class 1). The investment seeks to provide long-term growth of capital and current income as a secondary objective.

American Century Small Cap Value Fund PSA invests solely in the American Century Small Cap Value Fund. The investment seeks long-term capital growth.

Federated High Yield Bond invests solely in a diversified portfolio of high yield corporate bonds. The investment seeks high current income.

The Plan invests in the Vanguard Target Retirement Fund PSAs. These target date PSAs invest solely in the respective Vanguard Target Retirement mutual funds. The investments seek capital appreciation and current income consistent with its current asset allocation and provide broad diversification while incrementally decreasing exposures to equities and increasing exposure to bonds as each fund's target retirement date approaches.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments as of December 31, 2024 and 2023, are valued at NAV practical expedient. Therefore, no fair value table is presented.

#### **Note 4 – Tax Status**

The Plan Document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

#### **Note 6 – Information Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

#### **Note 7 – Party-in-Interest Transactions**

Plan investments include PSAs managed by John Hancock. John Hancock is the trustee of the Plan and therefore, transactions with the entity qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services to John Hancock amounted to \$51,518 for the year ended December 31, 2024.

#### **Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.



