#### NOTE A - DESCRIPTION OF THE PLAN

The following description of the United States Lime & Minerals, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan whereby eligible employees of United States Lime & Minerals, Inc. and certain related entities (the “Company” or the “Employer”) are permitted to make pretax contributions that are tax-deferred under Section 401(k) of the Internal Revenue Code (“IRC”) or after tax contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Employees are eligible for Plan participation upon completing six consecutive months of service. The Plan Sponsor’s Chief Executive Officer selects an Administrative Committee which is responsible for monitoring investment offerings and overall compliance of the Plan.

##### Contributions

Participants may elect to defer up to 75% of eligible compensation, as defined in the Plan agreement. Participant deferrals are subject to certain maximum limitations imposed by the IRC (\$23 elective deferrals and \$8 catch-up contributions for 2024 if the age of 50 is attained before end of Plan year). Participant deferrals are subject to annual non-discrimination tests. Pursuant to these tests, it was determined that some participants exceeded certain IRS limits by an aggregate amount of \$43 for 2024, and \$56 for 2023. Both amounts are reflected in the Statements of Net Assets Available for Benefits as excess contributions payable and were disbursed to participants subsequent to their respective year ends.

Upon enrollment in the Plan, a participant may direct contributions among the investment options provided by the Plan. The Company’s common stock is not an investment option for participants. The balance of the Company’s common stock was contributed to the Plan in a prior year as a result of a merger of this Plan with another plan. Participants may change their investment options at any time throughout the year. Rollover contributions, representing distributions from other qualified plans, are allowed and may be made prior to meeting the eligibility requirements for participation in the Plan. The Company matches 50% of participants’ contributions, up to 6% of the participants’ eligible compensation. The Company may also make additional discretionary contributions; however, no discretionary contributions were made during 2024.

##### Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) earnings and losses based on the participant’s investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

##### Notes Receivable from Participants

Participants may borrow a minimum of \$1 up to a maximum equal to the lesser of \$50 or 50% of their nonforfeitable account balance. A participant may only have one loan outstanding from the Plan at any point in time. The loans are secured by the balance in the participant's account and are recorded at fair value. The Plan Administrator will fix the term for repayment of the note for a period not to exceed 5 years unless the note qualifies as a home loan used to acquire a principal residence. The repayment term for a home loan may not exceed 30 years. The loan interest rate is 1% over prime and fixed for the duration of the loan. Principal and interest is paid at least quarterly under a level amortization schedule. Loans are considered in default if any scheduled payment remains unpaid beyond the following quarter in which payment was due.

##### Vesting

Participants are immediately vested in 100% of their salary deferrals, rollovers, Company matching and discretionary contributions, and related earnings thereon.

##### Payment of Benefits

Upon retirement, death, full and permanent disability, or termination of employment, a participant (or the participant's beneficiary, if applicable) will be provided by the Plan the opportunity, at his or her election, to receive a lump sum distribution or a direct rollover from his or her vested account. Other than for termination of employment, a participant can elect to have installment payments over a fixed period for the distribution of a participant's Employer stock balance. The Plan allows participants to make in-service and hardship withdrawals, subject to certain limitations, as defined in the Plan.

Under the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE), participants who reach age 70 ½ after December 31, 2019 must begin taking minimum distributions from the Plan by April 1 of the calendar year following the year in which they reach age 73. Under the SECURE Act, participants who turned 70 ½ before January 1, 2020 would still begin taking distributions by later of April 1 of the calendar year following the year in which they reach 70 ½, or actual retirement if later.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are reclassified as deemed distributions based upon the terms of the Plan document.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding decrease to employee contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15 of the subsequent year.

Payment of Benefits

Benefits payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Plan utilizes a framework for measuring fair value that provides a fair value hierarchy prioritizing the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value "NAV" and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trusts:* Valued at NAV of the units of the collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Company stock:* Valued at the closing price reported in the active market in which the individual security is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Part of the investment balance is attributable to the Plan Sponsor's registered stock. However, these shares are frozen and purchasing additional shares is not an investment option for participants. In addition, certain fees paid to the Plan Custodian for investment management services are incorporated into the expense ratios of the individual mutual funds.

The Plan has notes receivable from participants, which qualify as parties-in-interest to the Plan and are exempt from prohibited transaction rules.

#### NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be distributed to the participants of the Plan in accordance with the provisions of ERISA.

**NOTE G - TAX STATUS**

The Plan is based on a prototype plan which has received an opinion letter dated July 16, 2014, which stated the prototype plan is a qualified plan in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.
