**Note 1 – Description of Plan**

The following description of the McKinley Management, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of McKinley Management, Inc. and its subsidiaries (collectively, the Company) who are age 18 or older. Entry dates are on the first day of each calendar month of the Plan year coinciding with the next following satisfaction date of the eligibility requirements. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan engages Reliance Trust Company (the Custodian) to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated effective January 1, 2022 to include amendments required for the SECURE Act and CARES Act.

Effective February 1, 2024, the Plan Sponsor's name was changed to McKinley Management, LLC and the following participating employers were listed in the plan document: Alaska Growth Capital BIDCO, Inc., FAS Alaska, Inc., McKinley Alaska Private Investment, LLC, and McKinley Research Group, LLC. In addition, the Plan Sponsor has a voluntary self-correction process underway to retroactively correct the effective dates of these newly listed participating employers to be December 31, 2023, consistent with organizational changes.

Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (Secure 2.0 Act)

On December 29, 2022, the SECURE 2.0 Act was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Key provisions that may affect plan participants currently and/or in the future include increasing the age for required minimum distributions and provisions relating to catch-up contributions. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required. The deadline for adopting plan amendments has been extended, most recently, to no later than December 31, 2026.

Contributions

Participant contributions are based on the percentage of compensation up to 75% elected by the employee in his or her elective deferral agreement and subject to annual maximum limitations. Company contributions may be made without regard to current or accumulated net income, earnings, or profits of the Company. The Company may make a discretionary matching contribution based on a participant's contribution (5% for 2024). The Company may also make profit sharing contributions at its discretion.

**Note 1 – Description of Plan (Continued)**

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and (b) the Plan earnings and charged with an allocation of administrative expenses. Allocations are made in a manner which recognizes each participant's account balance, investment selection, and timing of contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferral contributions. For employer contributions, participants are fully vested at the completion of three years of service.

Forfeited Accounts

Forfeitures of nonvested matching contributions can be applied to pay Plan expenses or reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,158 and \$73, respectively. In 2024, employer contributions were reduced by funds from the forfeited accounts in the amount of \$968.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump sum amount equal to the value of his or her vested account balance (a lump sum distribution is required if the value of the participant's Plan benefit does not exceed \$5,000), equal installments over a period based on the life expectancy of the participant, or partial withdrawals.

Participants may also elect to take in-service or hardship withdrawals subject to the terms of the Plan document and Internal Revenue Service (IRS) regulations.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Note 2 – Summary of Significant Accounting Policies (Continued)**

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants totaling \$3,056 as of December 31, 2023, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to April 15, 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan permits the payment of Plan expenses to be made from the Plan's assets. Expenses that are paid by the Company are excluded from these financial statements. Fees are charged to participants on a pro rata basis, equally to participant accounts, or specifically to a participant account for transactions specifically related to that participant. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events for disclosure in the financial statements through September 23, 2025, which is the date the financial statements were available to be issued.

Subsequent to December 31, 2024, the Plan switched recordkeeper and custodian of their Plan assets and restated the Plan effective January 1, 2025.

Effective March 14, 2025, the following participating employers were listed in the plan document: McKinley Management, LLC, McKinley Alaska Private Investment, LLC, Alaska Growth Capital BIDCO, Inc., and McKinley Management Inc.

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include –

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds.* Valued at quoted market prices of shares held by the Plan at year end.
- *Collective trust fund.* Valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

**Note 5 – Related Party Transactions and Party-in-Interest Transactions**

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Participants direct the investment of their contributions into various investment options offered by the Plan. Some of the funds in which the Plan invested its assets were managed by McKinley Capital Management, LLC (MCM), a wholly owned subsidiary of McKinley Management, Inc. MCM received certain fees from the funds for investment management, fund accounting or other services during the year ended December 31, 2024. These party-in-interest transactions are permitted under provisions of the Plan and are exempt from the prohibited transaction rules under ERISA.

**Note 6 – Tax Status**

The IRS has determined and informed the Plan's volume submitter sponsor by an opinion letter dated October 6, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan sponsored by ADP, LLC which has been adopted by the Plan, is acceptable pursuant to Section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, each respective participant's account, net of any termination fees, will become fully vested and will be distributed to each participant in accordance with the Plan agreement.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Such investments are exposed to risks and uncertainties, such as interest rate risk, credit risk, market risk, economic changes, political unrest, regulatory changes, and foreign currency risk. The Plan’s exposure to a concentration of risk is dependent upon funds selected by participants. The following table shows details on investments that represent a concentration of greater than 10% of the Plan’s investments in either years:

**Note 9 – Prohibited Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonable segregated from the Employer’s general assets. During the year ended December 31, 2024, the Employer failed to remit \$43,387 of contributions. Lost earnings are paid by the Employer, not from Plan assets. Lost earnings on the 2024 delayed remittances are scheduled to be remitted by the Employer in 2025. These transactions constitute prohibited transactions as defined by ERISA.
