1. DESCRIPTION OF THE PLAN

The following description of the Riggs Community Health Center Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a pre-approved 401(k) plan adopted by Riggs Community Health Center, Inc. (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All employees who meet certain eligibility service requirements are participants in the Plan. The plan administrator is responsible for oversight of the Plan. The Board of Directors is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions and Funding Policy

Participants are eligible to participate in the Plan on the first day after three months of service. The Plan Sponsor's contribution is a safe-harbor match contribution of 100 percent of each participant's contribution limited to 3% of participant's compensation and 50 percent of each participant's contribution limited to 3% to 5% of participant's compensation. Each year, the Plan Sponsor may also make a discretionary profit-sharing contribution to the Plan. Participants are eligible for the discretionary profit-sharing contribution after twelve consecutive months of employment with 1,000 hours of service in that period. During 2024 and 2023, there were no profit-sharing contributions made into the Plan.

Upon entry into the Plan, participants may also defer a dollar amount or a percentage of their compensation, up to a maximum limit of 90% of their compensation. In addition, participants who have or will have attained age 50 by the end of the calendar year are allowed to defer an additional amount as "catch-up contributions" to a maximum as determined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The participants are able to direct their balance to be invested into various investment options offered by the Plan.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, allocations of Plan Sponsor's contribution and plan earnings (net of certain fund management expenses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement Benefits and Vesting

The Plan provides that employee salary deferrals, rollover contributions, and employer safe harbor contributions are always 100% vested in the Plan. Amounts relating to discretionary profit-sharing contributions are vested at 20% per year becoming fully vested at the conclusion of five years or earlier upon attainment of normal retirement age, upon retirement due to disability, upon death or upon termination of the Plan. Upon termination of employment, the nonvested portion of the participant's account is called a forfeiture and remains in the Plan to reduce Plan Sponsor contributions for the year. There were forfeitures of approximately \$400 and \$1,100 available to offset contributions as of December 31, 2024 and 2023, respectively. During 2024, contributions of the Plan Sponsor were reduced by approximately \$32,000 from forfeited non-vested accounts.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her vested interest in the account or have payments paid as a "direct rollover" to the participant's individual retirement account or to another employer's tax qualified plan. Participants can may also elect to receive distributions prior to termination granted they have attained age 65. If account balance is greater than \$1,000 and the participant has attained age 59½, the participant can choose to receive monthly installments or defer receiving payments until age 65. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan. Hardship distributions are permitted within the Plan with a minimum amount of \$500. Distributions can only be made from accounts which are 100% vested.

Plan Termination

Although the Plan Sponsor has not expressed intent to discontinue the Plan, it may do so at any time, upon resolution by Plan Sponsor's Board of Directors. The Plan provides that in the event of termination of the Plan, all amounts credited to the participant accounts will be fully vested and will be paid as directed in the Plan's text and regulations.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in unrealized appreciation of investments are reflected in the statements of changes in net assets available for benefits in the year in which such changes occur.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Each individual investment offered to the participants has varied investment objectives. Participants should refer to the custodian for a more complete description of the investment objectives.

Payment of Benefits

The Plan records benefit payments to participants when paid.

Administrative Expenses

The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Plan Sponsor and generally include audit and legal fees. The expenses paid by the Plan Sponsor are excluded from these financial statements. Administrative expenses incurred by the Plan generally include certain administrative fees charged directly to the participants' accounts.

Subsequent Events

The Plan evaluates events or transactions occurring subsequent to the statement of net asset available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued which is September 25, 2025.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (John Hancock), the trustee as of December 31, 2023, has certified to the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for benefits as of December 31, 2023.

During April 2024, the Plan Sponsor changed the trustee to ADP Retirement Trust Services, LLC. Accordingly, ADP Retirement Trust Services, LLC, the trustee of the Plan effective April 5, 2024, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024, the schedule of assets at December 31, 2024, and the related investment related activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). However, in accordance with Subtopic 820-10, the pooled separate account investments that measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Pooled separate accounts*: The separate accounts are stated at fair value as reported to the Plan by John Hancock, based on the quoted market prices of the underlying mutual funds. The unit value of the separate accounts is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. The investment strategies for the pooled separate accounts vary based on the degree of risk chosen by the participants.

5. INCOME TAX STATUS

The Plan has adopted a pre-approved plan document sponsored by ADP, LLC, which has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Transactions with parties-in-interest included administrative, investment advisory, and management fees for the Plan's custodian and trustee, ADP Retirement Trust Services, LLC and John Hancock, and auditing fees paid to the Plan's independent auditor, Blue & Co., LLC. Banker Investment Group received fees for investment advisory services, and ADP, Inc. received fees recordkeeping services.

The Plan Sponsor pays the majority of expenses of the Plan, including administrative and accounting fees. These expenses qualify as party-in-interest transactions. The Plan Sponsor provides certain administrative services at no cost to the Plan including accounting fees.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
