Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Community Rehab Associates Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Community Rehab Associates Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

1. Plan Description

The following description of the Community Rehab Associates Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Community Rehab Associates, Inc. (the "Company") who have completed three months of service and are age eighteen or older, as determined in accordance with the Plan's service rules. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The effective date of the Plan is September 1, 2007.
- b) *Employee Contributions* – Each year participants may contribute up to 100% of annual compensation, as defined by the Plan, subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans. The Plan does not include an automatic deferral feature.
- c) *Employer Contributions* – For the year ended December 31, 2024 and 2023, the Company made a matching contribution of up to 1% based upon the first 4% of compensation that each participant contributed to the Plan. The matching contributions are discretionary and determined per payroll.
- d) *Investment Options* - Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or internet. Participants who do not select specific investments are invested in accordance with the default investment alternatives established under the Plan.
- e) *Participants Accounts* – Each participant's account is credited and/or reduced with the participant's contributions and withdrawals, employer matching contributions, and allocations of the Plan earnings and losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses maybe charged based

on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- f) *Vesting* – Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company's matching contribution.
- g) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution or installment payment sufficient to satisfy required minimum distributions (RMD).
- h) *Forfeited Account* – Forfeitures of non-vested balances may be used to reduce employer contributions or pay plan expenses. At December 31, 2024 and 2023 there was no balance in the forfeiture account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through September 23, 2025, which is the date the financial statements were available to be issued.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Investment assets measured using either the net asset value (NAV) per share practical expedient or contract value are not categorized in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The underlying mutual funds include: (i) equity securities invested in small, large and mid-sized companies that seek high total return or long-term capital growth; (ii) common stocks, preferred stocks, fixed-income securities, convertible securities and depositary receipts of foreign companies that seek long-term capital growth; (iii) common stocks and fixed-income securities that seek favorable overall return; (iv) stocks, bonds and money market instruments that seek to achieve a competitive total return; (v) asset allocation funds which invest in a combination of assets such as stocks, bonds and money market instruments and seek to provide capital appreciation and income consistent with asset allocation; and (vi) Lifecycle funds which model portfolios designed to provide a balance of growth, income and capital conservation through a mix of equity and fixed-income exposures based on a participant's age and projected retirement date, adjusting asset allocations and associated risk levels with the objective of becoming more conservative as the target date approach.

Common Collective Trust – This investment includes the Invesco Stable Asset - ADPZ fund ("ADP CCT"). The objective of the ADP CCT is preservation of principal and to provide interest income reasonably obtained under prevailing market conditions. The ADP CCT invests in a highly diversified portfolio of investment grade, fixed and floating-rate securities. Investments are valued at the net asset value of units of the collective trust. The net asset value, as provided in the fund's audited financial statements, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

8. Related Party Transactions

Investment assets of the Plan are held by Reliance Trust Company, a subsidiary of ADP, Inc. ADP is the recordkeeper for the Plan. In 2024, the Plan paid fees of \$20,313 for recordkeeping services.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

10. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by Reliance Trust Company ("Reliance Trust"). Reliance Trust obtained its latest opinion letter dated October 6, 2020, in which the IRS stated that the Pre-approved Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and accordingly is exempt from taxation. Therefore, no provision for income taxes has been included in the Plan's financial statements.
