## REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator of the  
Wiseda Corporation 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Wiseda Corporation 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

#### **A. Description of the Plan**

##### **General**

The following brief description of the Wiseda Corporation 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan is sponsored by Wiseda Corporation (the “Plan Sponsor”). Fort Worth and Western Railroad Company, Davoil, Inc., Quorum International, Inc., DavRail Inc., and DavMarketing Solutions, Inc. are affiliated entities that are participating employers. Collectively, they are referred to as the Companies. The Companies’ corporate offices are located in Fort Worth, Texas.

The Plan was effective January 1, 2001, restated most recently effective February 26, 2022, and is a defined contribution plan available to substantially all employees of the Companies, except leased employees, nonresident aliens, residents of Puerto Rico, and those covered by a collective bargaining agreement, who have attained age 21 and completed three months of service. Eligible employees may enter the Plan on the first day of every month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The purpose of the Plan is to encourage the Companies’ employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

##### **Contributions**

Participants are allowed to contribute up to 90% of their compensation. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the Plan documents. In addition, some or all of a participant’s contributions may be designated as a Roth deferral contribution. Roth deferral contributions are made on an after-tax basis; however, such contributions will not be taxed at the time of distribution. Eligible participants may also make rollover contributions to the Plan from another qualified plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the Plan year may make catch-up contributions in accordance with, and subject to, the limitations imposed by the Code. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participants.

**A. Description of the Plan – continued**

**Contributions – continued**

The Companies may make discretionary matching or non-elective contributions to the Plan as determined annually by their Board of Directors. Participants must be: (1) employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year; or (2) have died, retired, or suffered disability during such Plan year to be eligible to receive discretionary contributions. Participants must be eligible participants on the last day of the Plan year to receive the discretionary match or non-elective contributions. There were no discretionary or non-elective contributions during 2024 or 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of: (1) the Companies' contributions (if any); and (2) Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. Participants become 100% vested after three years of service in both the Companies' discretionary and non-elective matching contribution portion of accounts, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants are allowed to borrow from their accounts a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balances. Note terms range generally from one to five years, or longer for the purchase of a primary residence. The notes are secured by the balances in the participants' accounts and bear interest. As of December 31, 2024 and 2023, all notes had interest rates ranging between 5.00% and 10.50%. Principal and interest are paid ratably through payroll deductions and additional participant payments. Participant loans are classified as notes receivable from participants in the Plan's financial statements.

**Payment of Benefits**

Participants withdrawing during the year for reasons of disability, retirement, death, or termination are entitled to their vested account balances. Benefits are distributed in the form of rollovers or lump-sum payments. If withdrawing participants are not entitled to their entire account balances, the amounts not received are forfeited.

**A. Description of the Plan – continued**

**Payment of Benefits – continued**

Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of his/her vested account balance while employed after reaching age 59 ½. A participant may receive a hardship distribution from salary reduction contributions if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, his/her spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses for the participant, the participant's spouse, or dependents; (4) needed to prevent eviction of the participant from his/her principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) for the repair of damage to participant's principal residence that would qualify for casualty deduction under the Code; (6) for burial or funeral expenses for the participant's deceased parent, spouse, children, or dependents; or, (7) for expenses and losses attributable to a federal declared disaster.

In a prior year, in connection with the Bipartisan Budget Act, the Plan's hardship withdrawal provisions were updated as follows: (1) participant deferral contributions will no longer be suspended after receipt of a hardship withdrawal; (2) participants are no longer required to take out a loan prior to requesting a hardship; (3) the reasons for heavy financial need were expanded to include certain disaster events and casualty losses not associated with disasters; and (4) earnings on elective deferral contributions in a participant's account will be included as part of a hardship withdrawal.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to reduce Plan expenses with any remaining forfeitures used to reduce the Companies' contributions. There were no forfeitures used during the years ended December 31, 2024 and 2023, and no unallocated forfeitures as of December 31, 2024 and 2023.

**Excess Contributions Payable**

The Code attempts to ensure that the tax advantages of the Plan are shared proportionally by employees at all levels of income. The amounts accrued as excess contributions payable at year-end represent contributions exceeding the allowed limits for certain participants which are refunded to them subsequent to the end of the Plan year. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

**Investment Options**

Upon enrollment in the Plan, a participant may direct his/her salary deferrals in 1% increments into a number of the Plan's investment options.

**Plan Expenses**

Employees of the Companies perform certain administrative functions with no compensation from the Plan. In accordance with Plan provisions, the Companies pay substantially all costs relating to asset charges and recordkeeping. Administrative expenses paid by the Companies are not reflected in the accompanying financial statements.

**B. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

**Contributions**

Contributions from the Companies and participants are accrued as they become obligations of the Companies, as determined by the Plan’s administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

**Investment Valuation and Income**

The investments of the Plan are stated at fair value as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan’s valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year-end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are recorded at the unpaid principal balance plus accrued but unpaid interest.

**Payment of Benefits**

Benefits are recorded when paid.

**C. Fair Value Measurements**

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan's investments are as follows:

- Mutual funds are valued at the published per share net asset value ("NAV") of shares held by the Plan and are classified within Level 1 of the valuation hierarchy. There are no significant restrictions on redeeming these investments at NAV.
- The stable value collective trust fund is composed primarily of a fully benefit-responsive investment contract that is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

**D. Certified Investments**

**E. Tax Status**

Effective February 26, 2022, the Plan was amended and restated by the adoption of the ADP, LLC Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which has a favorable opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020. This opinion letter states that the form of the prototype plan is acceptable under Section 401 of the Code. The Companies may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations.

**E. Tax Status – continued**

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Companies believe that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participants' accounts will become 100% vested.

**G. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**H. Party-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Notes receivable from participants to the Plan qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA which are exempt from the prohibited transaction rules.
