Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of St. Nicks Alliance Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

NOTE 1 – DESCRIPTION OF PLAN

The following description of the St. Nicks Alliance Pension Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

A. **General** — The Plan is a defined contribution retirement plan established in 2003, covering all full-time employees of St. Nicks Alliance and its affiliates who have completed at least one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and subsequent amendments. The Plan qualifies under Section 401(a) of the Internal Revenue Code (the “Code”). Employers in the Plan are as follows:

- St. Nicks Alliance (the “Plan Sponsor”)
- St. Nicks Alliance Home Care Corp.
- Evergreen Your North Brooklyn Business Exchange
- School Settlement Association, Inc.

Collectively, these employers are referred to as the “Company”.

B. **Eligibility and Service Rules for Participation** — All employees over the age of 21 and upon completing six consecutive months of service during which the employee(s) must complete 900 hours of service or upon completing one year of service are eligible to participate in the Plan. Effective January 1, 2025, employees become eligible to participate in the plan upon completing at least 500 hours of service during the six consecutive months following their hire date, or, if this condition is not met, upon completion of one year of service. Participants are eligible for employer contributions upon completing one year of service during which the employee(s) must complete 1,000 hours. Employees are automatically enrolled in the Plan upon meeting the requirements at a deferral rate of 1% of participant compensation, unless they elect an alternate percentage or opt out of the Plan. There is no auto escalation.

C. **Employer Contributions** — Each year, the Company contributes to the Plan a non-elective safe harbor contribution of four percent of each participant's annual compensation. The Company may also elect to contribute further discretionary contributions to the Plan.

D. **Participant Contributions** — Participants may contribute pre-tax compensation, as defined in the Plan, subject to the Internal Revenue Service (“IRS”) limitations, by means of payroll deductions. The Plan allows additional “catch-up” contributions for employees at age 50. Participants can also make Roth deferrals in accordance with the Plan’s provisions.

E. **Participant Accounts** — Upon enrollment in the Plan, participants may direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution, allocation of the Company's contribution, and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

F. **Vesting** — Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's non-elective employer contributions is based on years of service as follows:

- G. **Forfeitures** — Participants who terminate employment before they vest will forfeit their interest in their discretionary contributions. These forfeitures will be held in the Plan for use by the Company to meet any obligations with respect to employer contributions. There was \$0 and \$1,254 of applied forfeitures in 2024 and 2023, respectively. There was no unapplied forfeiture balance as of December 31, 2024 and 2023.
- H. **Distributions** — If a participant terminates employment with the Company due to disability or retirement, the participant (or a designated beneficiary) may elect to receive either a lump-sum distribution equal to the value of his or her account, or installments over a fixed period of time.
- I. **Participant Loans** — Participant loans are not permitted by the Plan.
- J. **Regulatory Compliance Affecting Retirement Plans** — The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 1.0 Act) became law on December 20, 2019. The SECURE Act made major changes to the Required Minimum Distribution (“RMD”) rules, increasing the age from 70 ½ to 72 to participants over 72 after January 1, 2020. Plans were required to be formally amended for certain other changes if adopted on or before the last day of the 2023 plan year.

The SECURE Act 2.0 (SECURE 2.0) was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act of 2019, which altered the rules around how employees can save and withdraw money from their retirement accounts. SECURE 2.0 further increased the age of RMDs, increased the catch-up contributions for older workers and required automatic enrollment for new plans. The SECURE 2.0 Act increased the age at which individuals must begin taking RMDs to 73 from 72, beginning January 1, 2023 as well as other increases starting in 2030. The SECURE 2.0 Act increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable year beginning after December 31, 2024.

In addition, the SECURE 1.0 Act and further by the SECURE 2.0 Act lowered the eligibility requirements to enable part-time workers to participate in 401(k) plans. These rules for long-term, part-time workers are expanded to apply to ERISA 403(b) plans, as well. The SECURE 2.0 Act changes the eligibility requirements under 401(k) so that it is easier for part-time employees to participate in them. The enacted law, the SECURE 1.0 Act, allows plans to limit eligibility for participation of part-time employees who reach the later of: (1) age 21 or completion of one 12-month period in which the employee worked at least 1,000 hours (pre-SECURE 1.0 Act rule); or (2) three consecutive years of service with 500 or more hours in each year. Under the SECURE 2.0 Act, a plan must allow a part-time employee to participate if the employee has either satisfied the above rule #1, or if the employee has completed two consecutive 12-month periods in which the employee worked at least 500 hours in each one of the two periods and reached age 21 by the end of the second 12-month period.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. **Basis of Accounting** – The Plan’s financial statements are prepared on the accrual basis of accounting. The Plan adheres to accounting principles generally accepted in the United States of America (“U.S. GAAP”).
- B. **Use of Estimates** – The preparation of financial statements in conformity with U.S. GAAP requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. **Investment Valuation and Income Recognition** – Investments, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, a fair value hierarchy prioritizes observable and unobservable inputs used to measure fair value into three levels, as described in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. **Administrative Expenses** – Certain expenses of maintaining the Plan are paid by the Company and excluded from the financial statements. Investment fees are netted with investment income. Investment advisory and recordkeeper fees amounted to \$95,818 and \$81,162 for the years ended December 31, 2024 and 2023, respectively.

E. **Benefit Payments** – Benefits are recorded when paid.

NOTE 3 – INVESTMENTS – UNAUDITED INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE AS COMPLETE AND ACCURATE

As noted in the independent auditors' report, the Plan Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information included in the ERISA-required supplemental schedule was certified as complete and accurate by the Plan's trustee, Reliance Trust Company (the "Trustee"), and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information to the information included in the Plan's financial statements. ADP is the Trustee's agent and is the Plan recordkeeper.

The Plan's Trustee has certified to the completeness and accuracy of the investments included in the financial statements as of December 31, 2024 and 2023, and investment activity included in the financial statements for the years then ended, as summarized below:

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 Input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value common collective trust fund: The Plan holds an investment in a common/collective trust with Ameriprise Trust Company (“Ameriprise”) Columbia Trust Stable High Quality Income Fund, (the “Stable Fund”). The account is credited with an interest rate determined by Ameriprise. Ameriprise reserves the right to change the interest rates applicable to amounts held in the interest accumulation account at their discretion. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Investments in the Stable Fund are valued at the net asset value (“NAV”) determined on the valuation date, and redemptions from the Stable Fund may be made each business day. All underlying funds are reported at the fair value net asset value per unit. The fair value of the Stable Fund is provided by the issuer and Plan management does not make any adjustment to the amount. The common/collective trust does not permit the Trustee to terminate the agreement prior to the scheduled maturity date. The Fund’s investment objective is to preserve principal while maximizing current income. The Fund may invest in fixed income instruments, stable value investment contracts issued by various banks, life insurance companies and other financial institutions and in units of collective investment funds with investment objectives similar to those of the Fund. The stable value common collective trust fund is a direct filing entity.

NOTE 5 – RELATED-PARTY TRANSACTIONS

Plan investments as of December 31, 2024 and 2023 are held by the Trustee. ADP is an agent of the Trustee and is the Plan's recordkeeper. Fees paid by the Plan to ADP for recordkeeping services amounted to \$57,243 and \$49,625 during the years ended December 31, 2024 and 2023, respectively. The Plan paid investor advisory fees to Merrill Lynch of \$38,575 and \$31,537 during the years ended December 31, 2024 and 2023, respectively. These fees are reflected in administrative expenses in the statements of changes in net assets available for benefits.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, all accounts shall then be disposed of for the benefit of each participant or beneficiary as if the termination date was his or her settlement date.

NOTE 7 – TAX STATUS

The Plan has adopted a non-standardized pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Code Section 401(a) for a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan. Although the Plan has been amended since adopting the non-standardized pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
